## AMENDMENT NO. 2 to the INMATE TELEPHONE SERVICES AGREEMENT

This Amendment No. 2 to the Inmate Telephone Services Agreement dated 6/1/2014, as previously amended, (the "Agreement") is made by and between **Inmate Calling Solutions, LLC, d/b/a ICSolutions** and **Laramie County Sheriff's Department, WY** effective as of July 31, 2016 ("Amendment Date"). Whereas, the parties agree as follows:

1. The first sentence of Section 1 of the Agreement is hereby amended to read as follows:

*"This Agreement became effective as of July 1, 2014 and shall remain in full force and effect until July 31, 2019."*

2. Services under the Agreement shall include deployment of The Visitor™ video visitation system including the following:

- 30 x Wall Mounted Inmate Kiosks
- 1 x Inmate Kiosk on Mobile Cart
- 12 x Wall Mounted visitor Kiosks
- 6 x POE Switches
- 42 x Cable\Connector Packages
- 1 x Visitor Registration Terminal
- 1 x Linux Commissioning Server
- 2 x Video Call Processors
- 2 x Video Storage Servers
- 1 x Enterprise Firewall
- 1 x Equipment Rack\Shelves
- 1 x APC UPS + Power Management Module
- Turnkey installation including all necessary conduit & cabling
- All-Inclusive warranty, support repair/replace maintenance package

3. Remote visitation shall be priced to the consumer at \$.50 per minute billed in 30-minute increments.

4. Exhibit D to the agreement is hereby amended to add the following:

*"ICS shall also pay to County a Commission of 50% of any service fees collected with respect to video visitation. Commencing with the month of August, 2016, ICS shall be entitled to retain the first \$1.00 of every inmate phone call to recover its investment in The Visitor™ system with the balance of the calling revenue continuing to be subject to a Commission rate payable to County of 60%."*

5. Except as amended herein, the Agreement shall remain in full force and effect.


