

**AMENDMENT ONE TO THE PROFESSIONAL
SERVICES CONTRACTOR AGREEMENT BETWEEN
LARAMIE COUNTY PUBLIC WORKS/PLANNING DEPARTMENT
LARAMIE COUNTY, WYOMING & CIVILWORX LLC.**

1. PARTIES: This Amendment is made AND entered into by and between Laramie County, Wyoming, P.O. Box 608, Cheyenne, Wyoming 82003-0608, (COUNTY) and CivilWorx, LLC, 1807 Capitol Avenue, Suite 206, Cheyenne, Wyoming 82001 (CONTRACTOR).
2. PURPOSE OF AMENDMENT: This Amendment shall constitute the first amendment to the Agreement between CONTRACTOR and the COUNTY. The purpose of this Amendment is to extend the term of the original agreement (Agreement #220719-23) to November 30, 2025 to allow for the completion of the Allison Draw Dredging project currently underway with the COUNTY.
3. TERM OF AMENDMENT: This Amendment shall commence on upon the date the last required signature is affixed hereto and shall remain in full force and effect through the term of the Agreement, as amended, unless terminated at an earlier date pursuant to the provisions of the Agreement, or pursuant to federal or state statute, rule, or regulation.
4. AMENDMENTS
 - A. Section II of the original Agreement is hereby amended to read as follows:

"This agreement shall commence on the date last executed by the duly authorized representatives of the parties to this Agreement and shall remain in full force and effect until November 30, 2025."
5. AMENDED RESPONSIBILITIES OF THE COUNTY

Responsibilities of the COUNTY have not changed.
6. AMENDED RESPONSIBILITIES OF THE CONTRACTOR

Responsibilities of the CONTRACTOR have not changed.
7. SPECIAL PROVISIONS
 - A. SAME TERMS AND CONDITIONS. With the exception of items explicitly delineated in this Amendment, all terms and conditions of the original Agreement, and any previous amendments, between the CONTRACTOR and the COUNTY, including but not limited to sovereign immunity, shall remain unchanged and in full force and effect.
8. GENERAL PROVISIONS.
 - A. ENTIRE AGREEMENT. The Original Agreement (5 pages), Attachment A (12 pages), Attachment B (205 pages), Attachment C Insurance Requirements (3 pages) and this Amendment One (3 pages) represent the entire and integrated agreement and

understanding between the parties and supersedes all prior negotiations, statements, representations and agreements, whether written or oral.

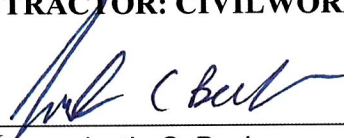

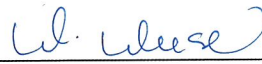
