

FIRST AMENDMENT TO MICROMANIA CONTRACT

Laramie County / Billy Traughber

THIS ADDENDUM is made and entered into by and between Laramie County, Wyoming, 3801 Archer Parkway, Cheyenne, Wyoming 82009, (“COUNTY”) and Billy Traughber, 621 Hope Terrace Ct., Santa Maria, CA 93455(hereinafter, “CONTRACTOR”).

I. PURPOSE

This Amendment shall constitute the first amendment to the Agreement to provide MicroMania Midget Wrestling at the Laramie County Fair between Laramie County and Billy Traughber, which was duly executed on May 16, 2023. The original Agreement provided an event date of August 7, 2023.

The purpose of this Amendment is to modify the event date to August 18, 2023, through mutual agreement of the parties, see revised Agreement of Entertainment, attached hereto as Attachment ‘B’.

II. TERM

This Amendment shall commence on the date last executed by the duly authorized representatives of the parties to the Agreement and shall remain in full force pursuant to the terms of the Agreement, signed May 16, 2023.

III. RESPONSIBILITIES OF CONTRACTOR

A. CONTRACTOR shall provide and complete the services described in Attachment ‘B’, attached hereto and fully incorporated herein.

IV. SPECIAL PROVISIONS

A. Same Terms and Conditions. With the exception of items explicitly delineated in this Amendment, all terms and conditions of the Agreement between COUNTY and CONTRACTOR, signed on May 16, 2023, including but not limited to sovereign/governmental immunity, shall remain unchanged and in full force and effect.


V. GENERAL PROVISIONS


