Background/History

Laramie County, Wyoming is serving as the applicant on behalf of our local Sheriff's Office. Laramie County encompasses 2,688 square miles of rural county and is the most populous of the 23 counties in Wyoming. Laramie County is in the Southeast corner of the State, with Cheyenne, our state capital, within its borders. The total population of Laramie County per the 2022 census estimate is 100,723 with much of that population residing within the City of Cheyenne. Recorded in the U.S. Census Bureau as of July 1, 2023, the population was 65,168. In less than two years the population has grown by 35,555 people. We expect this growth to continue with the addition of large businesses such as, "Thunder Plains Park". This will be Wyoming's first full sized thoroughbred horse racing track/Equestrian Center and are on target to open their doors in August of 2025. Another large development is Meta's newest 715,000-square-foot campus data center supporting almost 100 operational jobs and over 1,000 skilled trade jobs during construction. Meta is currently under construction on the south end of our county.

Another factor aiding in our growth are the two major transportation hubs of I-80 that run East and West, and I-25 that runs North and South. The I-25/I-80 interchange, and adjacent highway facilities are the largest and most heavily used in the state of Wyoming. This segment of the Federal Interstate System serves local, regional, state, and national travel needs and is the primary interchange in Wyoming for interstate commerce from border to border and coast to coast.

The Laramie County Sheriff's Office is one of the largest agencies of its type in Wyoming. Currently comprised of 161 sworn deputies divided into two divisions: Operations and Detention. This Grant will focus on the Operations Division. Please note this grant will focus on the Operations side of the division, with the request for AEDs being specific to placement in county patrol cars. These AED's will aid deputies in protecting the well-being, safety and security of all people in the county. Due to the vastness of Laramie County, more often than not, our officers are the first to arrive on scene. Having AEDs available in their cars is the first step to decreasing the call-to-shock time, which has been proven to greatly increase a victim's chance of survival. Currently we do not have enough AED's for every car that goes out on patrol.

Was there a particular instance where a life would have been positively impacted if you would have had the equipment available?

Each year sudden cardiac arrest (SCA) kills 335,000 people of all ages and fitness levels without warning. Ninety five percent of those who suffer from SCA die because CPR and defibrillation usually occur too late, if at all. If a law enforcement officer on the scene knew CPR and applied an Automated External Defibrillator within 5 minutes, the American Heart Association (AHA)) estimates that at least 40,000 more lives per year could be saved. Since 1999, when the Public Act 1733 Good Samaritan Law was passed, the most statistically supported beneficial effect has been the placement of AEDs in police vehicles. Studies consistently show that law enforcement officers can respond to an emergency call in less time than a medical first responder such as an ambulance or other advanced life support service.

To illustrate the unique challenges of our rural county, the small community of Meriden will be used. In 2022, Meriden had a population of 83 with no medical offices located within their town. The average age for Meriden is 54.4. Meriden is not located by the Interstate for fast travel, but is accessible by a two-lane road 45 miles North of Cheyenne. A law enforcement vehicle traveling an average 100 mph to Meriden would take 27 minutes. If an ambulance traveled the same distance from Cheyenne at their top speed of 75 mph, it would take them 38.6 minutes. That is a difference of 11.6 minutes. With each passing minute being crucial to the victim, this example shows the positive impact of having AEDs in law enforcement vehicles because they usually reach the victim much quicker.

On November 12, 2024, the Laramie County Sheriff's Office was dispatched to an urgent welfare check in unincorporated Laramie County. Once on scene, they were able to locate a subject who did not appear to be breathing. The subject was warm to the touch, but did not have a pulse indicating he recently stopped breathing. The deputies on scene immediately started chest compressions and accessed their medical bag and AED from the patrol vehicle. The AED was used to assist in life saving measures until medical personnel arrived. Not all Laramie County Sheriff's Office Patrol vehicles have AED's to be able to offer life saving measures. Our request is to add an additional twenty AED's to the Office to ensure each patrol vehicle has one available for lifesaving measures on scene.
