6. Briefly describe the project and how it supports the Investment Justification

Laramie County, Wyoming is requesting funding for security enhancement equipment for its courthouses. The Homeland Security Threat Assessment identifies governments as being the target of anti-governmental or anti-authority extremism activities. The Laramie County Courthouses, are public facilities that house, the First Judicial Circuit Court, First Judicial District Court, the Public Defender's Office and the Drug and Alcohol Treatment Courts along with several county operational offices to include assessors, clerk, treasurer, county commissioners, information technology, and human resources. Historically, these offices have experienced some form of civic unrest or threatening behaviors that are increasingly concerning combined with current political unrest. The equipment and monitoring software allows for immediate audible and visual shot detection and location with the capabilities of providing SMS or email notifications to selected users for emergency response.

7. Explain this project's dual applicability to all-hazard events (man-made and natural hazards)

This project is an important component to not only man-made hazards such as a shooting, but is also vital to natural hazards/events such as fires, flooding etc. The system would be integrated into the Laramie County Emergency Notification System (Ever-bridge) to be able to locate the threat and properly respond.

8. Identify portions of the THIRA or SPR that the project will address

Our project will address items identified within the Laramie County THIRA, to include physical security measures. These actions will allow us to implement and maintain risk-informed counter tactics to aid in the protection of life along with the protection of governmental facilities that host key operational activities vital to civic stability. Physical security measures identified within the THIRA have increased in potential due, to current civil unrest and the requested equipment will be critical to courthouse and building security.

9. How will this project increase capability or reduce vulnerabilities in protecting, preventing, responding, or recovering from an act of terrorism?

This equipment and software will facilitate proper protection, prevention, response and recovery efforts of Laramie County facilities and the protection of life. The requested items will aid in deterring and reducing vulnerabilities of our governmental facilities through the prevention of terrorist activities. Security and law enforcement will be able to immediately respond should an event occur. The element of prompt response time and specific location notification is paramount. During a violent threat with lethal weapons, immediate response by law enforcement is crucial to the protection of life. Along with law enforcement response, it is important to have the capabilities to notify employees and the public of the location of on-going threats for the preservation of life. With this project, both individuals working and conducting business in the facility will have added protection during the course of the business day against outside threats.

Laramie County will assume all responsibility for the maintenance of the equipment and software to keep it operational. The requested items will be sustained by the county for future operations and will be physically installed within the facilities and incorporated into the existing security and notification system.

14. Describe existing capability levels

We currently do not have any equipment or software that detects shots fired or active threats within the Laramie County Courthouses. We have conducted several exercises and trainings associated with active shooters and have discovered that unless you are in the specified area of attack, you will not be aware of

the threat. This has been a concern and vulnerability that the has become increasingly important due to the current civic unrest.

15. Please provide an overview of the trainings, exercises, real events, or other needs assessments that have identified this as a gap (include the cause of the gap).

Laramie County participates in all area trainings and exercises as appropriate through our departments and elected officials. We are .4 miles from the State Capitol, .2 miles from the Cheyenne Police Department and less than 500 feet from the Laramie County Detention Center. In 2020 and 2021, we have been a primary location of multiple gatherings to protest against public health COVID orders, presidential election results and political representative decisions. In general, the stress level of the public and employees has increased due to COVID, political unrest and economic uncertainty all of which can contribute to increased vulnerabilities and security threats. For example in June of 2020, we had an individual come into the courthouse who shaped his fingers as a gun and aimed at numerous civilians standing in line and made threats of "bang, bang, your dead."

16. How will this project reduce capability gaps?

Our project will provide immediate response efforts to acts of terrorism that includes lethal means within the courthouses of Laramie County. The equipment is considered a physical protective measure that will be installed into the facilities to allow for immediate dedication and location of threats. Also within the THIRA we found that our governmental faculties and infrastructure system is a gap across the board in terms of planning, organization, equipment, training and exercises. Our THIRA also identified the continued need to provide operational communications between responders and the affected population, along with locating and responding to terrorists.

Budget Narrative

We can break our project into two separate phases, new courthouse and historic courthouse. The new courthouse is located at 309 W. 20th Street and as mentioned before holds the offices of the courts and several election officials and governmental operations. For this location, we would need to purchase emergency panic buttons, gunshot detection sensor, and software. For equipment, cabling, hardware, installation and project management we are estimating a total of \$60,000.00 Phase two could be the historic courthouse located at 310 W. 19th Street. The historic courthouse is physically attached to the new courthouse through an atrium and houses the offices of the commissioners, IT, district attorney's and human recourses to name a few. This location would need the same type of equipment and installation. For equipment, cable, hardware, installation, design etc. we would need \$40,000.00

Total requested budget of \$100,000 for both the new and historical courthouse.
