Project: Water System Improvements and RV Park

Rocky Mountain Sand & Gravel, LLC is hereby directed to proceed with the following changes:

• Yard hydrants shall be Woodford S4H, or approved equal, at all locations, rather than modified frost-free hydrants.

- Replace the electrical work with the designs shown on the revised sheets dated 4-3-17. This work includes a new location for a Pad Mount Transformer by High West Energy. High West Energy will provide CTs and locate the meter at the transformer. A new Panel B and mounting bracket shall be placed northwest of the proposed dumpster area to feed the 20 RV sites west of the access road. In the main switchboard delete nine (9) 100/2 breakers and two (2) 701/2 breakers which will now be located in Panel B. Add an additional 400/3 breaker and feeder for Panel B. Provide a revised cost estimate for the associated work.
- The prices included in the original bid for item 52 (base bid) and Add Alternate A will be removed.
- The location for the Pad Mount Transformer by High West Energy has been staked, the contractor shall coordinate with High West Energy and the engineer to verify the locations of electrical components will not conflict with other proposed improvements.
