ROAD PETITION _____

WHEREAS, the Board of County Commissioner of Laramie County has received Road Petition No. _____, (Petition from Burnett Family dated January 14, 2019) requesting the vacation of the public right-of-way known as a portion of County Road 202 described as the NE corner of Section 7, Township 12 North, Range 61 West to a point approximately 2,400 feet west along the Northern boundary of Section 7, Laramie County, Wyoming as represented in the attached map; and

WHEREAS, The Board of Laramie County Commissioners, having appointed the Laramie County Public Works Director as a viewer to examine into the expediency of the proposed vacation; and

WHEREAS, the Laramie County Public Works Director has viewed and evaluated the pertinent facts regarding the proposed vacation and recommends approval of the vacation; and

WHEREAS, the Board of County Commissioners conclude vacation of the public right-of-way as requested by Road Petition _____ would be in the public interest.

NOW THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF LARAMIE COUNTY, WYOMING:

1. A portion of the public right-of-way shall be vacated as illustrated in the attached map, said portion to be vacated being described as a portion of County Road 202 as described as from the NE corner of Section 7, Township 12 North, Range 61 West to a point approximately 2,400 feet west along the Northern boundary of Section 7.

2. This section of right-of-way has never had a roadway constructed on it.

3. A copy of this Resolution and map shall be recorded in the Real Estate Division of the Office of the Laramie County Clerk, Ex-Officio Registrar of Deeds.

Commissioners,

This petition requests vacating a portion of County Road 202 (CR202) described as follows: From the NE corner of Section 7, Township 12 North, Range 61 West to a point approximately 2,400 feet west along the Northern boundary of Section 7. This section of Right-of-Way has never had a roadway constructed on it. The currently developed and County maintained section of CR202 effectively ends as this point presently.

I see no adverse effects with this request and would recommend vacating the said described Right-of-Way as this is well out of the zoned area of the County and is primarily farm and ranch land with no plans of any major subdivision development to be accessed by this section of undeveloped Right-of-Way in the foreseeable future.
