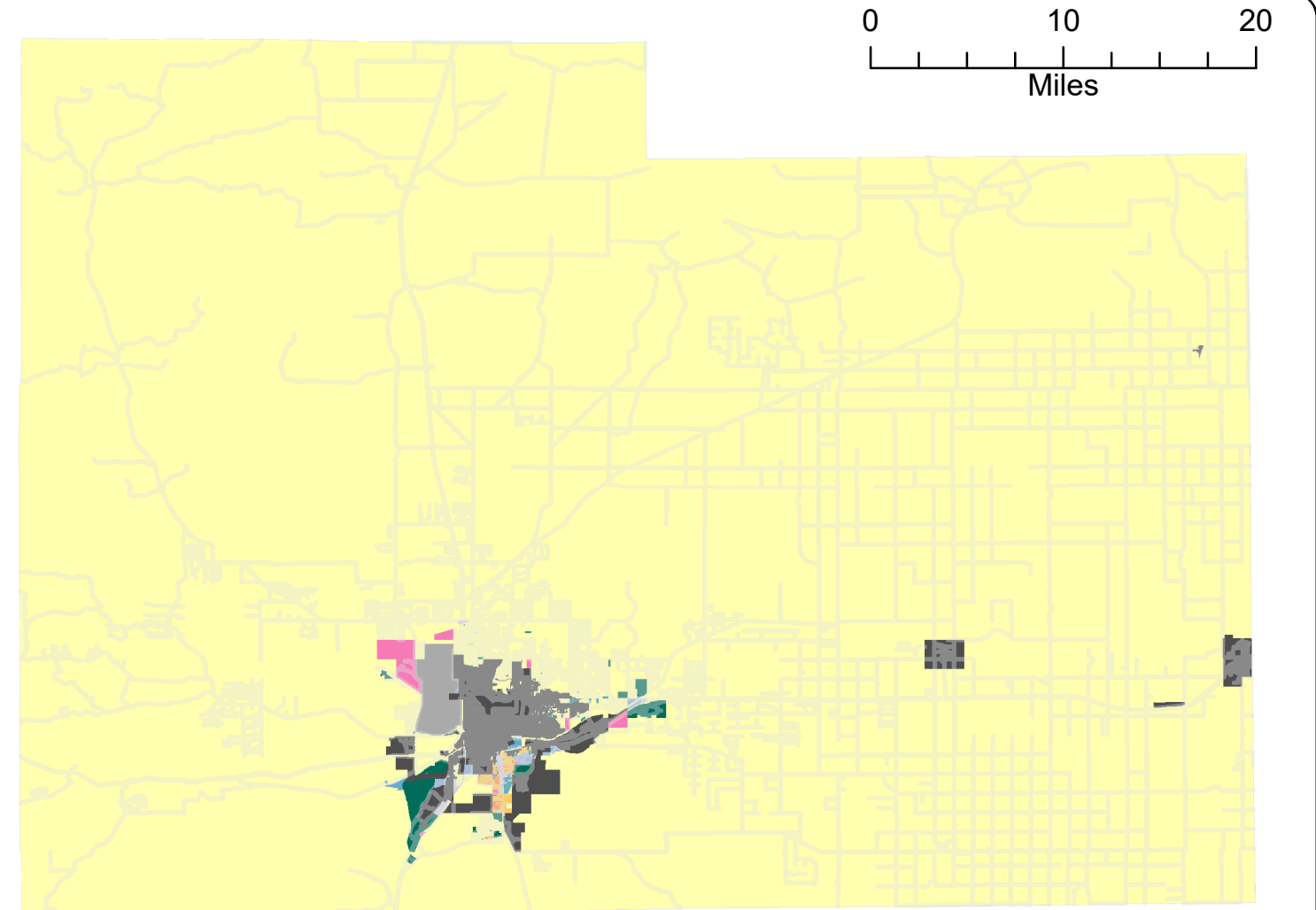
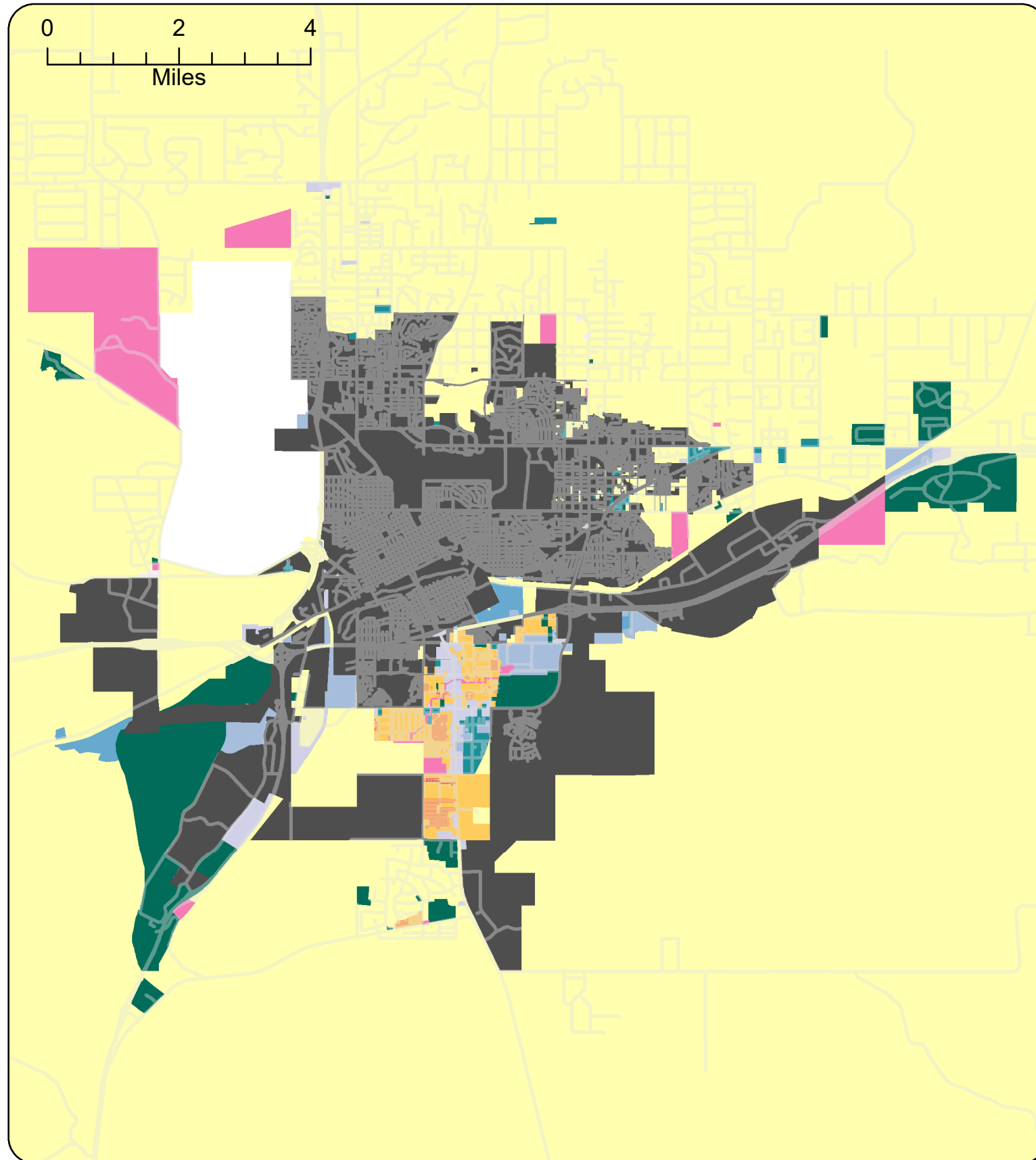

**A RESOLUTION TO APPROVE THE LARAMIE COUNTY ZONING MAP TO  
ACCOMPANY THE 2025 LARAMIE COUNTY LAND USE REGULATIONS**

**WHEREAS**, Wyoming State Statutes §18-5-201 to 18-5-208; §18-5-301 to 18-5-315 authorize Laramie County, in promoting the public health, safety, morals and general welfare of the county, to regulate the use of land through zoning in unincorporated Laramie County; and

**WHEREAS**, the Laramie County Board of Commissioners adopted the 2025 Laramie County Land Use Regulations; and

**WHEREAS**, the Laramie County Zoning Map shall bear the signature of the Chairman of the Board of County Commissioners pursuant to Section 2-1-100; and

**WHEREAS**, the Laramie County Board of Commissioners wish to adopt the Laramie County Planning and Development 2025 Zone Map Amendment effective August 6, 2025.
