## INTRODUCTION

Pursuant to Wyoming State Statute 24-3-101, a petition (see Exhibit A) was submitted to vacate a portion of the existing 80' right-of-way (ROW) of Road 103 (aka BCH CR 10 and McLees Road) in the northwestern area of Laramie County. The roadway has had three different names associated with the road: BCH CR 10, McLees Road, and Road 103. Therefore, this report and Exhibits may use any of these names, but they all refer to the same roadway. The approximately 1.4 miles of the ROW to be vacated is located within Section 3, T18N, R70W and Sections 33 and 34, T19N, R70W (see Exhibit B & C). Exhibits B & C shows property owners impacted and within the area. The total approximate area of the vacation is 13.58 acres.

There are fences, gates, and cattleguards that are located on various stretches of this roadway. It appears these items have been in place since approximately 1994 and possibly earlier.

## HISTORY AND BACKGROUND INFORMATION

The 80' ROW for Road 103 was petitioned to be established on August 6, 1885. However, it was not established until December 31, 1923. The original Road that was established had a description as follows: "Beginning at a point on CR#10 in the SW ¼ of Section 11 T18N R70W, thence northwesterly and in accordance with the field notes of the survey through Sections 11, 10, 3, 4, T18N, R70W, and Sections 33, 28, 21, 16, 17, 8, 5, & 6, T19N, R70W. The line described is the centre line of an 80-foot R of W." See Exhibit B.

Road 103 begins at Horse Creek Road (Hwy 211), heads slightly in a westerly direction, then turns to the north at the location where Road 237 (aka Farthing Road) ties into Road 103. The road continues in a northwesterly direction. This requested vacation request is for the section of Road 103 that starts where Road 239 ties into Road 103 and ends at the northern section line of Section 28 (see Exhibit C).

There has been extremely limited development in this area of the County and most existing roadways are for access to ranches and ranch property that have been in existence for many, many years.

Since 1980, there have been several petitions, issues and discussions related to various segments of Road 103. The following are excerpts from BOCC meeting minutes related to this roadway (See also Exhibit D):

July 8, 1980 – "A road petition was presented to the Board for action. Vice-Chairman Hickey requested it be tabled until the County Engineer returns from his vacation. It was noted the action to be taken on this petition regarding McLees Road was not clear."



July 22, 1980 – "Robert Whitney presented a road petition for McLees Road, an established County road, to be improved. Ben Henan stated the residents want two gullies of about 200 feet each re-built. Commissioner Francis asked if the residents would be willing to supply the materials needed. Ben stated the residents have loose gravel available in their area, but the use of a dozer and man hours would also be needed. The Board has no objections to the work being done."

January 1981 – "Floyd Hale met with the Board to discuss a road petition submitted last summer (ref. Book P, Page 279). A second examination of the petition showed the requested action to be unlcear and the Board asked for the submittal of a new petition to achieve the vacation (abandonment) of McLees Road, as desired."

February 10, 1981 – "A motion was made by Vice-Chairman Francis, seconded by Commissioner Humphrey, to appoint Robert Whitney as viewer for the vacation/abandonment of McLees Road. A report will be given for action in two weeks. Motion Carried." (RP-239)

February 24, 1981 – "Robert Whitney presented a viewer's report for the proposed vacation of McLees Road (RP-239). Several interested parties including representatives of Southeast Wyoming Wildlife Federation expressed their opinions that the road should remain open. A motion was made by Commissioner Francis, seconded by Commissioner Humphrey, to deny the viewers report, thereby denying the petition to vacate the road. Motion Carried."

April 21, 1981 – "Floyd Hale of the Bell Ranch met with the Board to discuss the McLees Road Petition which had previously been denied by the Board. After lengthy discussion, the Board directed that a passable road would be built across Section 21 later this year."

September 2, 1986 – "John Morris requested the Board reconsider abandonment of a portion of Branch County Road 10 (103): Beginning at a point on the south boundary of Section 21, T19N, R70W, and ending at the NW corner of said Section 21, T19N, R70W. There was discussion referring to access of Section 16. Chairman Humphrey informed the Board that he was contacted by the Wyoming Game and Fish who are apparently opposed to the abandonment. Mr. Morris voiced his primary reason for wanting the road abandoned is to control hunters on his property. Commissioner Ketcham moved to vacate County Road 103 due to the information provided in the viewers report and the potential liability of the County. Commissioner Francis seconded, Motion Carried."

September 23, 1986 – "Chairman Humphrey asked to move agenda item four to the first item of business. Matt Reed, Wyoming Wildlife Federation, had requested reconsideration of Commissioner decision for abandonment of County Road 103 and a large audience made comments pro and con the closure. After lengthy comments and suggestions from several sporting groups, environmentalists and individuals, Commissioner Francis moved to reconsider the closing of Road 103 and rescind this motion at a later date. Commissioner Humphrey seconded the motion. Commissioner's Francis and Humphrey voted for and Commissioner Ketcham voted against the motion which carried."



October 7, 1986 – "Commissioner Ketcham asked that item 11 on page 9 of the September 2, minutes be corrected to delete 'Vacate' from the motion and add 'Closed'. He then moved for approval of the August minutes and the minutes of proceedings for September 2, 1986. Commissioner Francis seconded the motion which carried with a unanimous Yes vote." Note: no further information or follow-up could be found in the BOCC meeting minutes through March 1987.

October 20, 1987 – "Pete Hutchison told the Board that hunting season has started again and County Road 10(103) is a problem again. There is allegation that one of the property owners is asking \$500 from the hunters to pass through a portion of the Road and unknown persons had placed large boulders on portions of the road inhibiting access. Discussion followed and Roberta Coates, County Attorney's Office, told the Board that to stop people and charge a fee on a County Road is a low enforcement function. The County Engineer was asked to go ahead and survey this portion of Road 103 to determine exactly where the Road is to allow the County to maintain it and remove the rocks."

May 17, 1988 — "John Morris requested further discussion in regard to the possible abandonment or maintenance of County Road 103 from the McLees Ranch north onto public lands. Pete Hutchison, County Engineer, stated that no surveying has yet been done to determine whether or not the Road actually 'goes someplace' and therefore should be maintained. Commissioner Ketcham requested the surveying be done and Hutchison make a progress report next month." Note: no further information or follow-up could be found in the BOCC meeting minutes.

April 8, 2009 – "Don Beard, Laramie County Public Works, presented the viewer's report regarding a petition to vacate a portion of a platted County Road (County Road 103) on Iron Mountain Ranch and recommended approval. Mr. Beard said this petition is by landowner consent and does not effect any other landowners, so the Commissioners can act today. Chairman Ketcham opened the meeting for public comment. Hearing no public comment, Chairman Ketcham closed the public hearing. Commissioner Woodhouse moved to accept Road Petition 433 to vacate a portion of a platted County Road on Iron Mountain Ranch. Commissioner Humphrey seconded the motion, which passed unanimously." Note: this vacation is only for Road 103 within Section 21 which is the same section of roadway that the petition referenced in the BOCC meeting minutes of September 2 and 23, 1986.

## INVESTIGATION AND EVALUATION

During the evaluation of this petition, discussions were held with Ms. Bonnie Reider, who is the owner of most of the property where this vacation would impact. Ms. Reider made contact during a site visit during the investigation. Discussions were also held with Mr. Mark Voss, County Attorney, which encompassed legal issues, ambiguity with recorded legal documents, clarification on County and State Laws, etc., and other unusual/unique circumstances that arose during the investigation.

Ms. Reider indicated that she was not in favor of this petition even though she submitted it because she wanted to keep it as a public road and be maintained once a year in the fall.



Apparently, for at least the last 15 years, the County has bladed the roadway once a year towards the end of summer into early fall. However, Ms. Reider indicated that she has constructed a hunting camp/headquarters near at the original homestead site and has had numerous vandalism incidents since there is no one living there year-round. She indicated she has put locks on gates to minimize the vandalism. This year, the County Public Works Department informed her that having gates and locking them across a public roadway such as Road 103 is not legal and she would have to remove them, or she could file a petition to vacate the public roadway so it would become private which would allow her to be able to lock the gates and secure the access into her property.

Generally, one of the main concerns with a roadway vacation would be for existing and future access to properties. There are large properties to the north of this petition request. In addition, there are large areas of BLM lands within this general area and how to access these lands can be a concern. Historically, the main issue with vacating any section of Road 103 in the past had to do with access to State and BLM lands, especially for hunters. However, Section 16, T19N, R70W, which was a State Section and had direct access via Road 203, is no longer a State Section. Section 16 was traded in 2007/2008 for land at the X-Bar Ranch south of Laramie. Therefore, currently there is no direct access to any State or BLM lands from the existing Road 103.

On September 2, 1986, the Board of County Commissioners (BOCC) voted to approve the vacation of Road 103 from the southern Section line of Section 21, T19N, R70W north to the northern Section line of Section 21. However, there is some ambiguity and uncertainty as to whether or not the vacation was in full effect because of the reconsideration motion that passed the BOCC on September 23, 1986. Regardless, there was another petition submitted in 2009 to vacate the same section of roadway and the BOCC approved that vacation on April 8, 2009. Therefore, Road 103 is currently vacated within Section 21.

## CONCLUSIONS AND RECOMMENDATIONS

## It is recommended that the petition be granted given the following conclusions:

- Although the County has been willing to accept the conditions of having gates and locks across this roadway in the past, the concern for setting a precedence that could be used by other property owners in the County is valid. Continuing what has been done in the past, which is what Ms. Reider would like to do, would not be in the best interest of the County as a whole, Ms. Reider, and the public, given the potential legal issues and setting a precedence that could be abused by others throughout the County.
- Vacating this portion of Road 103 would resolve any concerns or issues with gates and locking of the gates on a roadway.
- Road 103 has already been vacated to the north within Section 21.



- This section of Road 103 does not provide any direct access to State or Federal Lands.
- There appears to be other, currently private, access roads that have been used to access property to the north of this vacation.
- ➤ If it is found in the future that this section of Road 103 needs to be or should be reinstated as a public roadway, it can always be platted and reestablished. This vacation would not prohibit that.

## ADDITIONAL ACTION ITEMS RECOMMENDED

- The current GIS mapping shows Road 103 exists as a public road everywhere except for through Section 28, T19N, R70W. If this petition request is approved/granted, the GIS should be modified to indicate that Road 103 is private from Road 239 north to Wildman Road.
- The GIS mapping does not currently show Road 103 extending north of Section 21.
   Research could not find any documentation indicating it has been vacated north of Section 21 and the original establishment in 1923 indicates it continues northwesterly from Section 21 and ends in Section 6. Does or should this section of Road 103 be shown as public?
- The current official County Road Map dated January 2024 is not consistent with the current GIS map for Road 103. It is recommended that the official County Road Map be modified to be consistent with the GIS map depending on the approval or denial of this petition.
- No research/investigation was conducted on Wildman Road located off the vacated portion of Road 103 in Section 21. The GIS map shows it as a public roadway however, the official County Road Map shows it as a private roadway. It would be best if both maps were consistent to avoid confusion by the public.






Exhibit B – Area Land Ownership Map








Exhibit C – Adjacent Ownership Map





#### Branch C. R: #12;

Beginning at a point on County Road #12, where the same is intersected by the south line of Section 16-18-67; thence northwesterly and in accordance with the field notes of the survey through sections 16, 17, 8, 9, & 5 T. 18, N. R. 67 W., 32 & 31, T. 19, N. R. 67, 36, 25, 26, 27, 22, 23, 14, 15, 10 & 3 T. 19., N. R. 68, W. to a point on the north line of section 3, T. 19, N. R. 68. The Board of Laramie County Commissioner met in a special session on Tuesday, July 8, 1980 at 2:00 p.m. Those present were Dean Fogg, Chairman; Win Hickey, Commissioner; Shirley Francis, Commissioner; Janet C. Whitehead, County Clerk; and Betsy Phelan, Recording Secretary.

Also present were Robert Whitney, County Engineer; Ben Henan, Superintendent of Road and Bridge; Bill Bagley, Deputy County Attorney; David Guille, Director of Civil Defense; A. Kermit Sims, County Assessor; Tom Bonds, Director of Planning Office; Sharon Parrill; Lynwood E. Smith; Dean W. Borthwick; Merrilyn J. Borthwick; William C. Allen; Robert A. Boese; Maryann Smith; Cathy Ellis; Art Ellis; Bob DeFratis; Rob Dick; and Betty Sue Allen.

Sharon Parrill met with the Board to request approval of a retail liquor license to be issued to the Clowm's Den. Commissioner Hickey recommended tabling of the license discussion until all paper work on the installation of a septic system is received from the Environmental Health office. Discussion will resume in two weeks.

Rob Dick, representative of E. F. Hutton investments, met with the Board to request usage of the Laramie County Bonding Auhtority to obtain tax exempt bonds for the construction of an eighty unit low-income housing apartment complex, to be located at 4900 King Arther Way in Buffalo Ridge. Lengthy discussion was held on a denial action taken by the City Council when approached for City approval. The Board was hesitant to take any action on the request in view of the fact the property is located in the City and should be acted upon by that body. Mr. Dick was asked to return to the Council for further discussion of the project.

Chris Olsen met with the Board to request a vacation of a small portion of Van Buren for construction purposes. The County Engineer reported the owner of the two tracts of land along that portion of the road must file a Certificate of Vacation with the County Clerk. The Board will then take action on the Certificate to vacate the road. Mr. Olsen further requested minimal maintenance on the Granite Springs Retreat Roads. Ben Henan, Superintendent of the Road and Bridge Department, reported maintenance of all Retreat Roads in the dry season would overwhelm his crews in the area. Chairman Fogg, Ben Henan, and Chris Olsen made plans to meet in the area to look at the roads Monday morning at 10:00 a.m.

This being the date set for a public hearing on a petition for the formation of the North Cheyenne Skyline View Improvement District, Dean Borthwick, Bill Allen, and Ed Witzenburger met with the Board for discussion of the petition. The County Engineer reported this petition had been preceded with a petition, advertised June 20, 1980, and signed by 60% of the residents of North Cheyenne, to request annexation into the City. A lengthy discussion was held on the annexation plan. Tom Bonds commented the annexation should preceed the construction of roads in the area to ensure proper compliance with City Road Standards during construction and to allow the installation of City water and sewer lines prior to the road construction. Mr. Bonds recommended the Board table any action on the Improvement District until the annexation question is discussed before the City Council scheduled for July 28, 1980. He commented further the annexation would be better achieved if the whole area is done at once and not on a piecemeal basis. Mr. Borthwick and others in favor of the Improvement District, voiced objection to delaying action on the petition until annexation is decided by the council. A motion was made by Commissioner Hickey, seconded by Commissioner Francis, to approve the Improvement District subject to Council action on July 28, 1980. A letter of explanation is to be sent to the Council regarding the Board's motion and it is to be noted the Commissioners prefer annexation of this area. Motion Carried.



A Zone Change (ZC-207) for World Wide Construction Services for the corner of the intersection of I-25 and I-80 was presented to the Board. The Planning Commission has approved with conditions. A motion was made by Commissioner Francis, seconded by Commissioner Hickey, to approve the Zone Change(ZC-207). Motion Carried.

Tom Bonds advised the Board, the Planning Commission had denied the Preliminary Plat of both Kevin Acres and Sunnyside Meadows due to public access requirements, road requirements, road usage, objections of landowners in the area of the use of prime agricultural land for subdividing, and problems of subdivisions located inside of farming communities. Both subdivisions are located south west of Hillsdale.

The Final Plat of Pinkney Subdivision was presented to the Board by Tom Bonds and Michael Pell. This subdivision is located off of Avenue "C" and Gordon Road. Tom Bonds informed the Board all the requirements as set by the Planning Commission have been met. The Board Tabled action until July 29, 1980.

A motion was made by Commissioner Hickey, seconded by Commissioner Francis, to adopt the following resolution. Motion Carried.

#### RESOLUTION

NOW THEREFORE, BE IT RESOLVED, That the Final Plat and the Engineers Certificate, a copy of which is thereto attached, is approved.

Residents from Orchard Valley came before the Board to see about getting their streets paved. Bob Whitney explained to the residents there are no federal funds available at this time for the paving of streets. Bob also pointed out the roads in Orchard Valley are not built to county specifications, but stated the residents could possibly get the paving done if an improvement district is formed.

A concerned citizen of the County came before the Board to ask about the firing of three sheriff's deputies, including one from Pine Bluffs. Commissioner Hickey stated the payroll records had been checked and no requests for termination had been turned in by the sheriff. In fact, the Sheriff had put one part-time deputy on full time and hired another. Commissioner Francis stated the Board is still working on the budget for the new year. No cuts have been made from the previous year's budget and the Board is not requesting any department to terminate any employee.

A motion was made by Commissioner Francis, seconded by Commissioner Hickey, to appoint Robert Whitney as road viewer for the Iron Mountain Road and to accept the road petition (RC-237) as presented. The Road requested is about a half a mile long to be established and eventually paved. Motion carried.

Robert Whitney presented a road petition for McLees Road, and established County road, to be improved. Ben Henan stated the residents want two gullies of about 200 feet each rebuilt. Commissioner Francis asked if the residents would be willing to supply the needed materials. Ben stated the residents have loose gravel available in their area, but the use of a dozer and man hours would also be needed. The Board has no objections to the work being done.

A motion was made by Commissioner Hickey, seconded by Commissioner Francis, to amend the minutes of June 3, 1980, to include the following: The Board confirmed the reappointment to the counting center board for the Primary and General Elections, the following persons: Francis Parker, Jan Marshall, Robert Yogi Allen, Jack Miller, Janet Whitehead, Bert Faltnor, Diana Deaguero, with Gerrie Bishop designated to replace Dean Radford. 




