We would like to receive funding for both the exterior and interior keypad door project, but if unable to receive our full funding request, we are still interested in receiving a partial amount and would then make the exterior doors, our priority. The goal is to secure all of the exterior/perimeter doors as well as designated interior doors deemed vulnerable from a security standpoint. Confidential health information, as well as Emergency Medical Countermeasures/controlled substances, would be secure with a keypad system, as opposed to the key system that is currently used. The keys and locks currently used are experiencing general wear and tear. In addition to this, the C-LCHD on certain occasions has not been able to recover keys that were issued to staff that have left our employment. For these two reasons, there is security vulnerability with both the exterior and interior doors.

#### **Project Description**

Project Justification: Community Resilience

Briefly describe the project and how it supports the investment justification.

We are requesting funding for our local Health Department building security keypads on six exterior doors as well as eighteen (designated high priority) interior doors, to secure Controlled Substances\Emergency Medical Countermeasures caches within the building that are earmarked for a BT Bio-Terrorism event or Pandemic. Also to ensure that we are able to secure private health information according to HIPPA federal regulations. This request supports community resilience through prevention and protection.

Describer threats and hazards that create the need.

The current key system has developed vulnerabilities in terms of natural wear & tear over the years, as well as the inability to re-secure keys issued to former staff members who are no longer employed by the C-LCHD. This makes our facility unsecure to both staff and citizens during a threat or hazard within Laramie County.

Explain this project's dual applicability to all-hazard events (manmade and natural hazards):

This project will ensure that private health information is secured according to HIPPA federal regulations, from threats such as, unauthorized access by former staff or citizens. Door keypads will also ensure that key staff maintains access via master codes, to all areas of the building during a Public Health Emergency, caused by either a Natural disaster or manmade event. The increased security can be applied to both manmade and natural hazards and is not event specific.

Identify portions of the THIRA and SPR that the project will address.

Our project will address the Laramie County THIRA and SPR through Infrastructure Systems and Supply Chain Integrity and Security of records under HIPPA federal regulations, and Security of Medical Countermeasures/ controlled substances under Terrorism/Natural Disasters section of the Laramie County EMA THIRA.

How will this project increase capability or reduce vulnerabilities in protecting, preventing, responding, or recovering from an act of terrorism?

Our request will assist staff in providing immediate quality care to the population while reducing access vulnerabilities. Capability 1 Community Preparedness – safeguard medication cache used for public. Capability 3. Emergency Operations Coordination i.e. keypad protocols and access placed into County Health Department EOP to assist IC during a PH emergency event. Capability 9 Medical Material Management & Distribution i.e. safeguarding medical countermeasures/controlled substances.

All future maintenance and support will be sustained through the C-LCHD general budget. Security measures implemented will be the responsibility of our agency for maintenance and sustainment into the future.

The Cheyenne – Laramie County Health Department hosts trainings and exercises within our building for all Local partners and State agencies. We have been directly involved in planning and training efforts in coordination with Laramie County EMA. We have either conducted or participated in all local TTX, FSE, or FE exercises, and have also participated in emergency planning efforts with the WDH, CPD, CF&R, RERT 7, Civil Support Team and CFD. We have participated in the THIRA with both EMA and WOHS. Real world threats related to this request are: confidential medical information breaches i.e. (HIPPA), as well as unauthorized medication access that continue to plague healthcare facilities here and around the nation. The current gap (vulnerability) arises out of an aging security system, and inability to secure all keys issued in the past.

How will this project reduce capability gaps?

If funded, this keypad installation project will help address security gaps for Capability 1, Community Preparedness/Mass Care Services

Capability 3 Emergency Operations Coordination/Infrastructure Systems Capability 9 Medical Material Management & Distribution/Supply Chain Integrity & Security.

  Office of Homeland Security. We anticipate this concluding around February 31,2020

## A RESOLUTION ADOPTING THE NATIONAL INCIDENT MANAGEMENT SYSTEM (NIMS), ON BEHALF OF THE GOVERNING BODY OF LARAMIE COUNTY, WYOMING

#### WITNESSETH

WHEREAS, the President in Homeland Security Directive (HSPD)-5, directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System (NIMS), which would provide a consistent nationwide approach for Federal, State, and local governments to work together more effectively and efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity;

WHEREAS, the collective input and guidance from all Federal, State, and local homeland security partners has been, and will continue to be, vital to the development, effective implementation and utilization of a comprehensive NIMS;

WHEREAS, it is necessary and desirable that all Federal, State, and local emergency agencies and personnel coordinate their efforts to effectively and efficiently provide the highest levels of incident management;

WHEREAS, to facilitate the most efficient and effective incident management it is critical that Federal, State, and local organizations utilize standardized terminology, standardized organizational structures, interoperable communications, consolidated action plans, unified command structures, uniform personnel qualification standards, uniform standards for planning, training, and exercising, comprehensive resource management, and designated incident facilities during emergencies or disasters;

WHEREAS, the NIMS standardized procedures for managing personnel, communications, facilities and resources will improve the county's ability to utilize federal funding to enhance local agency readiness, maintain first responder safety, and streamline incident management processes,

WHEREAS, the Incident Command System components of NIMS are already an integral part of various city/county incident management activities, including current emergency management training programs; and

WHEREAS, the National Commission on Terrorist Attacks (9-11 Commission) recommended adoption of a standardized Incident Command System.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF LARAMIE COUNTY that the National Incident Management System (NIMS) is established as the County standard for incident management; and

BE IT FURTHER RESOLVED, that Jeanine West, or her successor in the position of Director of EMA, is appointed as agent of the Laramie County Board of Commissioners to execute and submit items and certifications for NIMS compliance.
