Nancy Trimble, Planning, stated ONEOK Elk Creek Pipeline, LLC, submitted an application for Board Approval for the following location: approximately 22 miles from the eastern border of Laramie County, parallel to ONEOK Bakken Pipeline. Jake Rosernberg, ERM, said the project is an approximately 900 mile, 20-inch diameter natural gas liquids pipeline. The project will originate in Richland County, Montana, and terminate at the existing ONEOK facility near Bushton, Kansas. Phil Saunder, Elk Creek, said they are negotiating with landowners for additional easements and have commitments from 50 percent of landowners. Ms. Trimble said based on evidence provided, staff recommends approval with no conditions. Chairman Holmes opened the hearing for PUBLIC COMMENT. Kevin Miller, International Union of Engineering Operators, said the union is in support of safe pipelines. Hearing no further PUBLIC COMMENT, Chairman Holmes closed the hearing. A motion was made by Commissioner Kailey, seconded by Commissioner Heath, to approve the resolution with no conditions and to adopt the findings of fact a and b of the staff report. Commissioner Thompson said he was not comfortable with approving the motion until additional landowners have agreed to easements.
