### Cheyenne Community Public Recreation District Narrative (Bicycle Playground)

 In 2014 the County Commissioners allocated funds to the Laramie County Recreation Planning and Advisory Board for the purpose of re-imagining a dilapidated Laramie County Park, named Clear Creek Park. A complete remodel of the park has since been undertaken and completed to include a new picnic shelter, new restrooms and a new playground. However, the county still has significant space to incorporate additional activities into the park.

The County Commissioners and the Recreation Board have partnered to rework this park and make it a destination place for families and groups within the community. We would like to bring a new element of active play to the youth in Laramie County. There are no bicycle parks in the area. A bicycle park would allow kids to be physically active while learning to adapt to obstacles and challenges. This type of recreational activity encourages movement, social interaction, and cognitive development and most importantly is fun!

Laramie County in partnership with the Laramie County Recreation Planning and Advisory Board
is seeking funding to assist in creating a bicycle park located within Clear Creek Park. We are
flexible for the placement and installation of equipment and are open to any phases needed for
completion. We have a couple areas within the existing park that could easily be developed for
the creation of the bicycle park.

Our expected outcomes are very simple; we anticipate greater usage of the park by providing a bicycle playground. We predict that the playground will be heavily used by the youth frequenting the park, both with their families and on their own. Having this play opportunity in the community will provide these children and all children of Laramie County with a safe recreational activity and space. A bicycle park will allow children of all ages to learn and practice bicycle safety in a controlled environment away from dangers like traffic. This will be the first park of its kind in the county and will draw visitors who otherwise might not visit the park.

There is excitement amongst our partners to bring a bicycle playground to the community and we are thrilled to have the opportunity to place this at Clear Creek Park. A bicycle playground is a unique feature that is nonexistent in our community. If selected for funding, we could start with the bid process immediately to hire a qualified vendor/contractor. We would love to have this project completed within one year from funding being awarded and will work diligently to make this goal happen. We have conducted basic research into the existing vendors who might be interested in our project. We have primarily looked at Progressive Bike Ramps, as they seem to be the only supplier of this equipment. Attached please find quotes and pictures of bicycle playground options. Both Laramie County and the Recreation Board are open to bicycle playground equipment ideas; we are not set on a certain brand or style and want to provide a well-balanced play area for all ages.

3. This is a public park that is open from 7am until dusk, seven days a week. On average we estimate that fifteen kids play in the park per day and that one hundred twenty five kid's access the park on a weekly basis. Per year we review our rental usage of the shelter and park and the weekly usage associated with outside activities. The park usage is higher in the warmer months than there is during the Wyoming winter. Being a public park, the park is open to everyone. We anticipate that by bringing a new play feature, such as a bicycle park, the park will attract new visitors.

### Budget Details

We are requesting \$50,000 towards our bike playground project; we are open and flexible to the type and style of bicycle equipment.

We have not selected a design of the bicycle park, so equipment selections can be modified to our space and needs. The items above serve as an example of what we could expect to receive for \$50,000. Regardless of the options selected, we feel that we can bring a quality bicycle playground to Laramie County.

At this time Laramie County has funded \$600,000 towards the shelter, restroom and infrastructure. Additional funds in excess of \$80,000 have come from foundation grants, CCRD and the Laramie County Recreation Planning and Advisory Board to complete the playground area. We do not have any additional cash match for this project, but are committed to using county resources to help with dirt work and the installation. This will be a standalone feature of Clear Creek Park for years to come!










Existing plat of Clear Creek Park-Owned by Laramie County, Wyoming.
