Permit and Plat

Cate Cundall, Planning, said Jones Land Surveying, Inc, on behalf of Gary Schroeder, submitted a subdivision permit and plat application for Hillsdale South Ranchettes, 2nd Filing, located at 876 West Rd. The application was submitted to subdivide approximately 29.39 acres of vacant land into five residential tracts, 5.80 acres or larger. Ms. Cundall noted that Planning Commission public hearings on the application were postponed on April 28 and May 12, 2022, to resolve the vacation of a portion of West Rd included in the subdivision permit and plat. She said the owner asked that the project proceed, since the road vacation has been completed.

Ms. Cundall said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact a and b.

Chairman Thompson opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Thompson closed the hearing.

Bryce Hamilton, Planning, said Steil Surveying Services, LLC, on behalf of Mickey Edmond, submitted a subdivision permit and plat application for property located on the west side of County Rd 164, about four miles south of the town of Pine Bluffs. The application was submitted to subdivide the 311.62-acre property into 24 residential lots of roughly 22 acres each on the north side and 5.25 acres each on the south side.

Mr. Hamilton said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact a, b, c and d with two conditions: 1) A non-adverse Chapter 23 recommendation is received from DEQ by the Planning Dept prior to plat recordation and 2) The plat is revised to dedicate at least 40 feet of public right-of-way along the section line for future expansion of Road 208 prior to recordation.

Chairman Thompson opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Thompson closed the hearing.
