

**AMENDMENT FOUR TO THE AGREEMENT BETWEEN
WYOMING DEPARTMENT OF TRANSPORTATION
AND
LARAMIE COUNTY**

1. **Parties.** This Amendment is made and entered into by and between the Wyoming Department of Transportation (WYDOT), whose address is: 5300 Bishop Blvd. Cheyenne, WY 82009, and Laramie County, Wyoming (County), whose address is: P.O. Box 608, Cheyenne, WY 82003.
2. **Purpose of Amendment.** This Amendment shall constitute the fourth amendment to the Agreement between WYDOT and the County. The purpose of this Amendment is to: a) extend the term of the Agreement; and b) amend the responsibilities of the County by replacing Attachment C with Attachment D.

The original Agreement, dated February 23, 2004, required the County to provide snow removal on portions of South Greeley Highway and Fox Farm Road in Laramie County, Wyoming.

Amendment One, dated May 23, 2022, amended the original Agreement to: a) increase the County fees for snow removal; b) extend the term of the Agreement through February 4, 2023; and c) amend the responsibilities of the County.

Amendment Two, dated June 26, 2023, amended the original Agreement to extend the term of the Agreement to February 4, 2024.

Amendment Three, dated March 15, 2024, amended the original Agreement to: a) extend the term of the Agreement through February 4, 2025; and b) amend the responsibilities of the County.

3. **Term of the Amendment.** This Amendment shall commence on February 4, 2025, or upon the date the last required signature is affixed hereto, whichever is later (Effective Date), and shall remain in full force and effect through the term of the Agreement, as amended, unless terminated at an earlier date pursuant to the provisions of the Agreement, or pursuant to federal or state statute, rule, or regulation.
4. **Amendments.**
 - A. The second sentence of Section II of the original Agreement is hereby amended to read as follows:

“The term of the Agreement is from February 23, 2004, through February 5, 2026.”

5. **Amended Responsibilities of the County.**

- A. As of the Effective Date of this Amendment, Attachment C, which was attached to the original Agreement, is superseded and replaced by Attachment D, which is attached to this Amendment and incorporated into the original Agreement by this reference. All references to "Attachment C" in the original Agreement, and in any amendments thereto, are amended to read: "Attachment D".

6. **Amended Responsibilities of WYDOT.** Responsibilities of WYDOT have not changed.

7. **Special Provisions.**

- A. **Same Terms and Conditions.** With the exception of items explicitly delineated in this Amendment, all terms and conditions of the original Agreement, and any previous amendments, between WYDOT and the County, including but not limited to sovereign immunity, shall remain unchanged and in full force and effect.

- B. **Counterparts.** This Amendment may be executed in counterparts. Each counterpart, when executed and delivered, shall be deemed an original and all counterparts together shall constitute one and the same Amendment. Delivery by the County of an originally signed counterpart of this Amendment by facsimile or PDF shall be followed up immediately by delivery of the originally signed counterpart to WYDOT.

8. **General Provisions.**

- A. **Entirety of Agreement.** The original Agreement, consisting of four (4) pages; Attachment A, consisting of one (1) page; Amendment One, consisting of three (3) pages; Attachment B, consisting of one (1) page; Amendment Two, consisting of three (3) pages; Amendment Three, consisting of three (3) pages; Attachment C, consisting of one (1) page, this this Amendment Four, consisting of three (3) pages; and Attachment D, consisting of one (1) page, represent the entire and integrated Agreement between the parties and shall supersede all prior negotiations, representations, and agreements, whether written or oral.

9. **Signatures.** The parties to this Amendment, through their duly authorized representatives, have executed this Amendment on the dates set out below, and certify that they have read, understood, and agreed to the terms and conditions of this Amendment.

This Amendment is not binding on either party until approved by A&I Procurement and the Governor of the State of Wyoming or his designee, if required by Wyo. Stat. § 9-2-3204(b)(iv).
