Comments

Laramie County sits on a plateau in the southeast corner of Wyoming, covering an area of 2,685 square miles. Elevation varies from 7,000 feet at the western boundary to 5,000 feet at the eastern boundary (Cheyenne-6,082 ft.; Pine Bluffs-5,042 ft.). The area is mostly High Plains grassland with a total of 8.3 square miles of surface water. Cheyenne began as a large rail stop for the Union Pacific Railroad to replenish steam engines prior to the large mountain climb between Cheyenne and Laramie, Wyoming to the west. Cheyenne was chosen to be the Capital of the Wyoming Territory because of its population and proximity to the railroad and military facilities. Cheyenne remained the Capital when statehood was obtained in 1890. Laramie Countys demographics are quickly changing as Cheyenne and the surrounding county grows. Light industrial areas are growing, bringing in larger businesses. These businesses bring employment, making residential subdivisions and business parks grow, causing both the city and county population to expand. Land use and development have been on a steady increase over the last decade. More residential subdivisions have been dedicated in the past two years than the first ninety years that records were kept in the county. Cheyenne remains a regional transportation hub with the UPRR still using the same east-west route laid out in the 1860s. Cheyenne sits at the intersection of two major interstates, I-25 and I-80, seeing a large amount of truck traffic throughout the County. The Federal Government plays a major roll for Cheyenne and Laramie County. Located adjacent to Cheyenne is F.E. Warren Air Force Base, a nuclear missile facility that maintains and operates the Peacekeeper missile sites located throughout the region. The Federal Courts, U.S. Marshalls Office, Bureau of Land Management and Internal Revenue Service all have offices located in Cheyenne. Population centers for Laramie County include: (per 2010 Census) Cheyenne 59,252 Pine Bluffs 1,129 Unincorporated 30,875, Burns 302, and Albin 181. Cheyennes infrastructure is multi-faceted. Cheyennes electricity is supplied mostly from the south out of Colorado supported by a redundant grid system. Water is supplied by pipeline from the mountains west of Laramie to a new water treatment plant and supplemented by numerous wells. Natural gas is supplied from several pipelines to a local distribution system. Sewer treatment facilities located east of town are secured and controlled, as is the water treatment plant. Emergency services in the City of Cheyenne and Laramie County are provided by numerous fire protection districts and municipal fire service, government law enforcement and both contracted and volunteer EMS providers. F.E. Warren AFB and the Wyoming Air National Guard also provide full time fire and airport protection services. Several industrial units, such as Frontier Oil Refinery and Dyno Noble give specific assistance to the emergency responders through mutual aid agreements. Both state and federal law enforcement agencies can, and do, assist locals when needed.

Requested funds are to create a plan for the Child's Draw Basin; this area has never been formally examined. Having a plan with identified areas of flooding concern will provide all participants and citizens with an understanding of the hazards, risks and vulnerabilities to identify and prioritize mitigation measures and projects. a) Laramie County will document the hazard mitigation planning process, including but not limited to: How the plan was prepared How the public was involved (i.e. workshops, community outreach) Including the formal plan adoption by either a resolution or ordinance b) As part of the public process, Laramie County will appoint a local planning team. Members will include a cross-section of the county, such as residents, government officials, community leaders and business owners. The local planning team will, but is not limited to: Hold public hearings, meetings and/or workshops during the plan development. Solicit input from citizens and professionals with knowledge of applicable hazards. Solicit input regarding the feasibility of potential mitigation measures and the prioritization of mitigation projects. Review the final draft of the plans goals and proposed mitigation projects. The committee will be involved in the implementation as well as the updating of the plants goals and proposed mitigation projects. A minimum of three local planning team meetings and two public workshops will be held during the plan update process to identify hazards and develop a prioritization of the hazards that have occurred within Child's Draw Basin. Hazard Mapping will occur using the best available existing data from Laramie County and any other available sources, a base map of areas affected by flooding in the Child's Draw Basin. This mapping will identify a comprehensive inventory/database and map data layers, all repetitive flood loss and substantial damage structures, as defined by FEMA, maps that depict the location of structures, land use, and populations. Vulnerability Assessment-the information collected will be utilized by the local planning team to develop an overview of specific vulnerability to flooding. Local Adoption: Laramie County will approve the plan by resolution and the plan will be maintained by Laramie County and updated every five years.

What are the primary sources of information and data and how it will be incorporated into existing planning mechanisms?

The plan will examine data, risk analysis and recommendations for implementable actions to prepare and mitigate flooding issues in Child's Draw Basin. Expected components of this plan will include the following: Identify and analyze current drainage issues identified in neighborhoods. Identify additional projected development for the area to anticipate any future drainage concerns. Identify appropriate strategies and practices that can be implemented to mitigate the identified threats and risks. The selected contractor will be using existing hydrology data that has been collected off of the 2014 Aerial topographic materials during the last County/City GIS fly-over.

What staff and resources will be used to implement this planning activity?

The Laramie County Public Works Department is the project lead and will oversee the process and completion of the plan. Because of the importance which has been placed on successful completion of this project, LCPW will devote the time and

resources necessary for its completion and has access to any of the County's departments, facilities, or resources which might be necessary for the successful completion of the project. The majority of the cost of this project will involve hiring a contractor to assist Laramie County to execute the work plan. The final outcome of the project will be a FEMA approved plan and the various components of Child's Draw Basin The grant requested is based upon the best estimates on similar project, which are available to Laramie County at the time this application is being filed. Laramie County will provide GIS services and other reasonable project resources as it may have available. The contractor will be expected to provide all research materials, and documents necessary for the local planning meeting and processes and any necessary materials needed for public meetings. The contractor will also provide any copies necessary of draft plans, revisions or final copies for distribution. Additionally, the contractor will also provide electronic versions of the final copy in both Microsoft Office and Adobe PDF formats. Laramie County will own all rights and title to the final plan and its documentation and may use, reproduce or distribute any portions of the plan as necessary in their sole discretion. Because of the timelines involved until a grant is awarded, Laramie County Public Works will initiate work on the project with the local planning team prior to hiring a contractor.
