County Attorney Mark Voss said the agenda item authorizes additional terminals at one 307 Horse Racing location.

Traci Lacock, general counsel for 307 Horse Racing, explained her client had a joint venture with Wyoming Downs. Wyoming Downs closed its Outlaw location as the result of a foreclosure, and her client seeks to transfer 45 of those terminals to its Ridge Rd location. Written approval from the board is required to increase the number of terminals at that location. She confirmed approval of this item does not increase the number of gaming machines in Laramie County. Lacock added the WY Gaming Commission has final approval of the additional terminals.

Justin Arnold, Planning, said Steil Surveying Services, LLC, on behalf of landowners Patrick and Robert Blythe, submitted a subdivision permit and plat application for The Life subdivision, located at 1760 I-25 Service Rd. He said the application was submitted to subdivide the property into four residential lots, each averaging 11.51 acres.

Shane Hansen, agent, stated for the record that the owners of the subject property are Scott and Angela Denny.

Arnold said based on evidence provided, staff recommends approval with the adoption of findings of fact a and b with one condition: All agency comments will be addressed and/or corrected prior to recordation.

Chairman Malm opened the hearing for PUBLIC COMMENT. Molly Cook, Public Works, informed that Note #6 on the plat needs to be updated, and she requested current verbiage on the proposed plat for Note #6 be changed to reflect that Tract 2 and Tract 3 can utilize the existing and established access easement as recorded in Book 2520, Page 1484; Tract 4 can obtain access off I-25 Service Rd; and Tract 1 can be accessed from either location.

Hearing no further PUBLIC COMMENT, Chairman Malm closed the hearing.
