

Laramie County Charitable Relief Grant Applications

Consideration of thirty-seven charitable relief applications submitted to the Laramie County Commissioners for review and approval under The Governor's Office Community Charitable Relief Program.

The State of Wyoming has provided County's with Emergency Rules and Regulations outlining the purpose, distribution, deadlines, certifications, awards, prohibitions, reporting and audit requirements for the CARES Act funding in relation to eligible nonprofits.

The county commissioners announced the funding opportunity on Monday December 22, 2020 and applications were due by February 1, 2021 at 5pm.

Applicants were required to be a charitable organization which qualifies as tax-exempt under either Section 501c3 or Section 501c19 of the Internal Revenue Code and which provided goods, services, or payments to the public related to the COVID-19 public health emergency.

Applicants could submit applications to request awards for direct charitable expenditures related to COVID-19 or awards for lost donations or other revenue associated with providing COVID-19 related services to the public.
