Due to Winter Storm Xylia

WY Homeland Security Director Lynn Budd and Section Chief Ashley Paulsrud, described the process to obtain funding from the Federal Emergency Management Agency (FEMA). Ms. Budd explained there would have to be at least \$1 million in damages statewide in order for a Presidential Declaration of Emergency to be signed. Ms. Budd noted that in order for Laramie County to qualify for reimbursement, county-level damages would need to be around \$357,000, based on preliminary figures.

Ms. Budd said Governor Mark Gordon did sign a declaration of emergency. A county declaration of emergency would set a timeline for the event and facilitate resources and assistance from the State. Ms. Budd said a 48-hour event period would need to be established for reimbursement. She noted federal government reimbursement is set at 75 percent with a local match of 25 percent in cash or in-kind contribution. Ms. Paulsrud explained an additional 48-hour period could be requested but approval would be required by FEMA headquarters. Ms. Paulsrud further explained she will send a preliminary damage assessment form to the County to determine its costs. The form needs to be completed within 30 days of the incident period.

There was discussion of possible flooding in the aftermath of the winter storm. EMA Director Jeanine West said the county's emergency declaration will also help with

getting additional assets from the State and partners in Colorado.

Chairman Malm questioned Ms. Budd about assistance for Laramie County's agricultural producers. Ms. Budd explained such assistance would have to be requested through local farm service agents to the U.S. Dept. of Agriculture.

A motion was made by Commissioner Thompson, seconded by Vice Chairman Holmes, to pass a resolution declaring a state of emergency in Laramie County, WY, due to Winter Storm Xylia. The motion carried by the following vote:
