Justin Arnold, Planning, said Steil Surveying Services, LLC, on behalf of Michael G and Abbey T Kercher, submitted an administrative plat application for Lodgepole Estates, 3rd Filing for Tract 5, Portions of Tract 6 and 7, Lodgepole Estates, Laramie

County, WY. He said the purpose of the application is to combine three parcels, located at 2245 Rainbow Ridge, into one tract for residential use. Arnold said the overall density of the new parcel is 8.09 acres, and there is an existing residence on the parcel.

Arnold said based on evidence provided, staff recommends approval of the vacation and the administrative plat with the adoption of findings of fact a, b and c.
