The term of this Amendment shall be from July 1, 2022 through June 30, 2023.



## **Annual Renewal Proposal to Provide Comprehensive Inmate Medical, Ancillary and Community-Based Inmate Healthcare Programs and Services for Laramie County, WY**

3<sup>rd</sup> Year Renewal Effective: July 1<sup>st</sup>, 2022 through June 30<sup>th</sup>, 2023

CorrHealth is excited to continue providing quality comprehensive inmate medical, ancillary and community-based inmate healthcare programs and services for the inmates held at the Laramie County Jail in accordance with our Agreement, which went into effect on July 1<sup>st</sup>, 2021 with CorrHealth's transition into the Laramie County Adult and Juvenile Detention Centers. The detailed breakdown of our renewal for the 2022-2023 contract year consists of:

### **Annual Renewal w/ Detail of Consumer Price Index (CPI) and Employee Price Index (EPI) Increase for the 3<sup>rd</sup> Year Term**

#### **3<sup>rd</sup> Year Renewal- July 1<sup>st</sup>, 2022 through June 30<sup>th</sup>, 2023**

\$2,017,897.65 Annual Price from July 1<sup>st</sup>, 2021 through June 30<sup>th</sup>, 2022 (current annual program rate)

- \* 3% CPI Increase equating to an increase of \$60,536.93 annually as stipulated in section 4, which is specific to the "Compensation" on page 3 and 4 of our Agreement.
- = **New annual contract rate of \$2,078,434.58 annually or \$173,202.88 per month, which activated on July 1<sup>st</sup>, 2022 for the 2022-2023 annual term.**
