SWANSON SERVICES CORPORATION COMMISSARY SERVICE CONTRACT AND  
COBRA CASHIER CONTRACT ADDENDUM**

This Amendment to the Swanson Services Corporation Commissary Service Contract, Cobra Cashier Contract Addendum and Addendum to Swanson Services Corporation Commissary Service Contract and Cobra Cashier Contract Addendum is made effective upon the execution of this Amendment by both parties by and between the **Laramie County Detention Center**, 1901 Pioneer Avenue, Cheyenne, WY 82001 (hereinafter referred to as "Client") and **Swanson Services Corporation**, a Florida corporation with principal offices at 477 Commerce Boulevard, Oldsmar, FL 34677 (hereinafter referred to as "Swanson"). Swanson and the Client are referred to as the "Parties."

WHEREAS, the Client and Swanson are parties to a Swanson Services Corporation Commissary Services Contract, a Cobra Cashier Contract Addendum and Addendums to Swanson Services Corporation Commissary Service Contract and Cobra Cashier Contract Addendum, dated the 5<sup>th</sup> day of December, 2007 and March 16, 2016 (the "Agreements"), and

WHEREAS, the Agreements have been amended from time to time in the past, and

WHEREAS, the Parties desire to amend the Agreements to renew and extend the term of the Agreements as stated herein.

NOW, THEREFORE, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree follows:

1. The foregoing recitations are true and correct and made a part hereof.
2. The Agreements are all hereby amended and renewed for one (1) year commencing April 1, 2017.
3. Except as expressly stated herein, all of the terms and conditions of the Agreements, as previously amended, shall remain in full force and effect.
