Nathan Silberhorn, Ayres Assoc, presented the West Crow Creek Corridor Study, part of the Cheyenne Greenway Plan. He noted the Greenway Plan was introduced in 1992. Silberhorn discussed the obstacles to the segment, which included crossings, challenges in the floodplain along the creek, and coordination constraints.

Silberhorn said the cost estimate is approximately \$3.6 million in 2025 dollars. He said the implementation is expected to be shared rather than funded by a single entity.
