#### Members of the Board,

I request your consideration of my application for appointment to the Laramie County Library System Board. I have reviewed the duties of the position and believe that I would be an asset to the Board.

As I am sure is the case with all applicants, I am a life-long library patron and supporter. I grew up in a small town that had the good fortune of having a beautiful Carnegie library. Although that library did not have even a fraction of the materials available in Laramie County, similarly, it promoted knowledge and served as a hub for the community.

As an adult, I have moved all over the world and have seen and patronized many libraries of all sizes. Each provided a different level of service. But the Laramie County Library is, without a doubt, the best of them all at both supporting literacy and building community. If selected to serve on the System Board, I would do my best to enable the library to continue leading and growing in both of these important areas.

With the decline of traditional ways of socializing – churches, bowling leagues, civic organizations – I see the library as holding an increasingly important role as a community hub. I am analytical and take fiscal responsibility seriously.

I also believe that the System Board can only ensure the future success of the library if it ensures the success of the library's professional staff. In my opinion, the library has met the needs of the times while maintaining a focus on its fantastic materials only because of the top-level staff the Board has hired and been able to retain. Therefore, as a System Board member, I would focus on collaborating with and supporting the library's professional staff members to the maximum extent possible. Even where the Board must make the ultimate decision, there is value in working to bring the team to consensus around the path forward. In my professional life, I have worked in collaborative environments where success depended on the expertise of a variety of people. I would bring my skills in such settings to my work on the Board.

Finally, it is important to acknowledge that because of the tenor of our times, there is a real possibility that the Board might deal with difficult issues in the future. Although I have personal opinions, I am

cognizant that my role would be to forward the strategic goals of the library and not my own agenda. I am aware that the library has already established policies to deal with issues such as access for a growing homeless population and placement of materials deemed controversial. The Board and staff have dealt with these issues in a pragmatic and professional manner. As a System Board member, I would follow that same path in the future.
