Dear Board of Commissioners and County HR:

I am forwarding to you an email resignation from Genny Rose, one of the two county at-large positions on the board. This position is up for appointment for the term beginning July 1, 2024 through June 30, 2027. While the county could fill the last two months of Genny's remaining term, it might be simpler for all concerned to fill the vacancy effective July 1.

I'm copying Holly Martinez in the Mayor's office since she also tracks board membership and re-appointments.

Aside from Genny, the other four positions up for re-appointment have not objected to serving another term if re-appointed. Sullivan (not at-large) requires both city and county re-appointment. John Brodie and Kimberly Skoutary-Johnson require city re-appointment only and Ericka Smith requires county re-appointment only. Genny's replacement will require county appointment only.
