Chairman Holmes informed that the viewer's report and public comments on the two road vacation petitions would be taken together, but the Board would consider each petition separately.

Rob Geringer, director of Public Works and designated Viewer, read his report on the two road closure proposals. He stated that 50-60 persons sent comments against the road vacation.

Chairman Holmes opened the hearing for PUBLIC COMMENT. Jack Twiford, 642 Horseshoe Creek, Glendo, spoke on behalf of the petitioners, Lorenz Ranch Inc. Mr. Twiford explained that he leases land in the area and he and other landowners have experienced numerous acts of vandalism and gates left open creating problems with cattle management. He summarized the problem as a 'people management' one. If the board does not agree to vacate the roads, he requested control be done through signage and cattle guards. He asked the board to table action on the item so that ranchers' concerns can be addressed.

Speaking against the proposed road vacation, Jordan Evans, 729 Shoshoni, Cheyenne, said that restricting access to public lands in Laramie County serves no public interest. Buzz Hettick, Backcountry Hunters & Anglers, 1778 Eagle Crest Ct, said his organization will support public access by helping ranchers with signage and other measures to prevent vandalism. Michael Hogan, BLM realty manager, said the closure would defeat BLM's primary purpose to make public lands accessible. Brian Taullie, 1411 Gettysburg, said the roads are an evacuation route for Table Mountain residents.

Commissioner Thompson requested a meeting be set between Public Works, BLM, Wyoming Backcountry Hunters & Anglers, and the ranchers to find solutions to prevent vandalism of property and risks to livestock.

Hearing no further PUBLIC COMMENT, Chairman Holmes closed the hearing.

Seth Frentheway, Laramie County Planning, informed that Steil Surveying Services, LLC, on behalf of J Pat Sullivan Et Ux c/o Jack Stadel, Stadel Construction, has submitted a Subdivision Permit and Plat application for Sullivan Subdivision, 2nd Filing, located southeast of Glencoe Dr. & Westedt Road. The application was submitted for the purpose of subdividing the existing parcel into three (3) separate tracts to prepare for single-family residential development, averaging 5.79 acres each. Mr. Frentheway said based on evidence provided, staff recommends approval with no conditions.

Seth Frentheway, Planning, informed that CEPI, Inc, on behalf of Granite Springs Apartments, LLC, and AYH, LLC, submitted a Subdivision Permit and Plat application for Granite Springs Subdivision, located northeast of E Jefferson Rd. & Ave C. The application was submitted for the purpose of replatting four tracts owned by Granite Springs, LLC, and AYH, LLC, into three lots, correcting previous lot line location errors and consolidating Granite Springs Apartments onto one legally-subdivided lot. The property requires a dual application process with the city since it is within one mile of city limits. Based on evidence provided, staff recommends approval with the condition that the 20' utility easement shown on the northern portion of Lot 3 be addressed per County Engineer comments.

Bill Fehringer, CEPI, 6080 Enterprise, Casper, agent for the applicant, stated the purpose of the replat is to correct lot lines errors, based on an agreement of the two property owners.

Chairman Holmes opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Holmes closed the hearing.

- 23.** Citizens' comments regarding flooding issues in the Thomas Heights area.

Chairman Holmes said a number of citizens had requested an audience before the board to air concerns about flooding in the Thomas Heights subdivision.

Rod Stone, 4011 Summit, said he has had extreme flooding and a large volume of runoff. He said his home has had major flooding five times and his neighbors' homes have also flooded. Mr. Stone said the increase in water is related to development of Thomas Heights. He said he is frustrated because the city says the problem is a county issue and the county says they cannot help.

Rob Cortier, 3803 Summit, said flooding in a detention pond on his property started when N. College Dr. was built and development of Thomas Heights made it worse. Rich Hortle, 4402 Summit, said his driveway is sinking and water sits on it; water volume has increased and the direction of water flow has changed.

Rob Geringer, Public Works director, said the county engineer reviewed the drainage report with the design engineer and city staff and determined it met city standards at that time. Mr. Geringer noted that the area is not mapped as being in a FEMA floodplain. Mark Voss, county attorney, said residents could seek civil recourse as the county is not legally in a position to act.

Mayor Marian Orr said her office has been in communication with residents. She stated that the city engineer said there is relief but a cost would be involved.

Commissioner Thompson said commissioners cannot control city subdivisions, and the city is responsible for drainage studies. He recommended residents seek relief from the legislature. He stated commissioners do not have the authority to make rules or regulations on city subdivisions.

In response to a question from Commissioner Heath, Mr. Geringer said Public Works would check the culverts for possible blockage and silt.

Jason Wasserburger, Throne Law Office, stated that county pockets within the city will continue and lawsuits are expensive. He said creative solutions are needed.

Citizen Comments were received and filed.

The meeting adjourned at 6:32 p.m.
