Peter Liguori, Wyoming Horse Racing, gave an update on the project and future expansion of the facility. He said the project which opened in June 2024 has taken two years for planning and construction. Liguori said the tax benefits to the county, city, and state are roughly a million dollars a year. Liguori noted that 70% of the business comes from out of state. Liguori spoke about their philanthropic mission.

Liguori explained about phase two of the project, includes restaurants, a theater, a hotel, and a larger space to accommodate additional historical horse racing machines. The cost would be around \$76 million, and 450 team members would be hired. He noted that the potential financial impact to the county would be around \$2 million a year in revenue.

Liguori said the city has agreed to give a letter of support. Liguori said his organization will go before the gaming commission in January or February, and he requested a resolution from the county before then. Commissioner Malm thanked him for his presentation and investment in the community. He said the next step would be a formal request for a resolution and work with the county attorney's office.

36. PUBLIC HEARING regarding a site plan for the Whitt's End Farmstand located in a portion of Sect 30, T14N, R68W of the 6th PM, Laramie County, WY.

Justin Arnold, Planning, said Sarah Lene and Augustus Whitt, and Kenneth Ball submitted a site plan application for Whitt's End Farmstand, located at 1249 Happy Jack Rd. He said the application was submitted to expand the existing farm stand with a 360 sq ft addition, install RV electrical connections, and plan future livestock shelters.

Arnold said based on evidence provided, staff recommends approval with the adoption of findings of fact a and b, with the condition that all agency recommendations, including public improvements deemed necessary, are addressed prior to the issuance of a certificate of review.

Commissioner Thompson questioned Arnold about hiring a surveyor to establish the right-of-way. Arnold deferred the question to Lene Whitt, the applicant. Whitt said the right-of-way is still being worked on. Commissioner Thompson further questioned bringing the road on the southern property line to county standards. Molly Bennett, Public Works, said the agency comment refers to the States Rd east of the Whitt property line to the Steiner property line. Bennett noted there is potential to create a hammerhead turnaround or something similar to accommodate emergency services. Commissioner Thompson asked if the condition would include establishing the easement and bringing the road to county standards. Arnold said the condition addresses all agency review comments and incorporates roadway improvements. Commissioner Thompson asked if the farm stand was within the right-of-way. Arnold said they would have to verify the structure and a number of variables would need to be addressed during the building permit process.

In response to Commissioner Thompson's question about running water and the plan for black and gray water from RVs, Whitt stated there is no running water for the farm stand and it is dry camping for sewer. She explained that hand sanitizer and porta-potties are used.

Commissioner Thompson then asked if there is an appropriate ingress and egress for the volume of vehicles planned for the site. Whitt explained the use of T-posts and caution tape to direct vehicles to the parking areas, with possible use of volunteers.

Commissioner Thompson discussed the agricultural exemptions and asked if the condition would address public safety concerns and require construction of buildings appropriate for the volume of people visiting the area. Arnold discussed what constitutes agricultural and commercial use.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Three residents, two of whom were vendors at the farm stand, spoke in favor of the application. Hearing no further PUBLIC COMMENT, Chairman Lovett closed the hearing.

A motion was made by Vice Chairman Malm, seconded by Commissioner Holmes, to approve the Whitt's End Farmstand site plan located in a portion of Sect 30, T14N, R68W, of the 6th PM, Laramie County, WY, with one condition and adopt the findings of fact a and b of the staff report.

Commissioner Thompson said he struggles with agricultural residential property being turned into a commercial venture with four campers, use of water from the property, and tripling the size of the farm stand with 200 parking spaces for events. He expressed concerns that too much is going on with the project and asked about being fair to the neighbors.

Commissioner Holmes also expressed concerns but said he hates to make it more difficult for entrepreneurs. However, he feels there is not enough information about the access and egress, traffic flow, and restrooms.

A motion was made by Commissioner Thompson, seconded by Vice Chairman Malm, to place a second condition that any sort of construction requires a commercial building permit.

Commissioner Thompson wanted it noted for the record that the States Rd will be built to county standards to the southern property line.

Commissioner Holmes asked about county health standards for public places. County Attorney Mark Voss said he would ask the health department about inspections of farm stands. Commissioner Thompson said he has previously received complaints about the farm stand over the years and when he contacted the health department, their response was that a farm stand is under the Department of Agriculture, not the health department.

Whitt said the site is fully licensed, with three different licenses that comply with any health requirements and building licenses that need to be obtained.

Justin Arnold, Planning, said Steil Surveying, LLC, on behalf of Sara Smith, submitted a subdivision permit and plat application for property located generally in the NE1/4 of Sect 34, T14N, R66W of the 6th PM, Laramie County, WY. 39. PUBLIC HEARING regarding a subdivision permit and plat for Cowboy Kids at Ridley Ranch, 2nd Filing, located in a portion of Sect 11, T15N, R67W, of the 6th PM, Laramie County, WY.

Justin Arnold, Planning, said AVI, PC, on behalf of Cowboy Kids Land Co, LLC, submitted a subdivision permit and plat application for Cowboy Kids at Ridley Ranch, 2nd Filing, located southwest of the I-25 and Ridley Rd (Road 220) intersection. He said the purpose of the application is to divide a 283.1 gross acre parcel into 45 tracts. Arnold said the subdivision will have 41 developable lots and four open-space lots. The open-space lots will be owned collectively and controlled by the subdivision's HOA. He said the open space lots can never be developed. Arnold said the proposed subdivision will remain zoned as LU-Land Use, and any commercial development will require a site plan and possible zone change.

Arnold said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact a and b with no conditions.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Cory Isaacson, resident, spoke about preserving the quiet neighborhood and expressed concern about the developer reserving the right to put commercial use there, well water usage, traffic and potential crime. Hearing no further PUBLIC COMMENT, Chairman Lovett closed the hearing.

A motion was made by Commissioner Holmes, seconded by Vice Chairman Malm, to approve the subdivision permit and plat for Cowboy Kids at Ridley Ranch, 2nd Filing, located in a portion of Sect 11, T15N, R67W, of the 6th PM, Laramie County, WY, with no conditions and adopt the findings of fact a and b of the staff report.

Commissioner Malm questioned Arnold whether the subdivision would fall under the new land use rules and regulations. He noted the possibility that the outbound lots, which are larger and dedicated for residential use, may in the future become commercial. Arnold said multiple guardrails would be in place governing that situation - a zone change application and a conditional use permit to act as a new zoning with conditions placed by the pertinent body. Arnold noted the area has a major interchange and commercial development is a likely possibility.

Commissioner Thompson spoke about placing a note on the plat prohibiting further subdivision. He said he was concerned about preventing future subdivision of the property and pointed to the tracts greater than 5.2 acres. He referred to the AMEC memo and the goal of protecting the aquifer.

Commissioner Holmes asked County Attorney Mark Voss about placing a note on the plat. Voss advised the board has the authority to place a note on the plat, and a request to remove the note could be made through a replat at a future time.

A motion was made by Commissioner Thompson, seconded by Commissioner Holmes, to add a note to the plat: "No further subdivision of any of the lots within this subdivision will take place."

Commissioner Malm asked for input from the developer. Mark Christensen, AVI, PC, and agent for the applicant, pointed out the plat contains a note designating that no further subdivision of the open space shall be permitted.

The amended motion carried by the following vote:

Christensen requested the board consider more flexible language on the plat to allow for future changes in regulations and technology. Commissioner Malm noted that plats are routinely amended. Commissioner Thompson said he was not in favor of Christensen's request.
