**Rick Robinson's term ended on June 30, 2016 – he just needs to be reappointed for new term (July 1, 2016-June 30, 2019)**

Gay VanHorn's term ended on June 30, 2016 – she needs to be reappointed for new term (July 1, 2016-June 30, 2019)  
Danny Glick's term ended on June 30, 2016 – needs to be reappointed for new term (July 1, 2016-June 30, 2019)  
Kiersti Wilmmms was appointed on June 16, 2015 to fill vacancy of term ending on June 30, 2016 - needs to be reappointed for new term (July 1, 2016-June 30, 2019)
