AGREEMENT TO PROVIDE RODEO ARENA EQUIPMENT FOR THE EVENT CENTER AT ARCHER

between LARAMIE COUNTY, WYOMING and PRIEFERT.

This Agreement is made and entered into by and between Laramie County, Wyoming, 310 W. 19th Street, Suite 300, Cheyenne, Wyoming, 82001 ("COUNTY") and Priefert located at 2630 South Jefferson Ave, Mount Pleasant, Texas 75455 ("CONTRACTOR").

I. PURPOSE

The CONTRACTOR is to provide a complete portable rodeo arena equipment for the Event Center at Archer, as requested in the RFP issued by the Laramie County Events Department.

II. TERM

This Agreement shall commence on the date last executed by the duly authorized representatives of the parties to this Agreement, and shall remain in force until the project is completed by CONTRACTOR and accepted by COUNTY as set forth in the Agreement.

III. PAYMENT

COUNTY shall pay CONTRACTOR for services upon receipt of the CONTRACTOR'S invoice to the COUNTY as detailed in the RFP attached hereto as Exhibit A, which is fully incorporated herein. The total payment to CONTRACTOR under this Agreement shall not exceed \$172,141.22 (bid amount), unless negotiated by both parties in writing. Payment will be made to CONTRACTOR for materials upon invoice. No payment shall be made before the last signature is affixed to this Agreement. Payments shall be in accordance with Wyo. Stat. § 16-6-602 (as amended).

IV. RESPONSIBILITIES OF CONTRACTOR

- A. CONTRACTOR shall provide a complete portable rodeo arena equipment for the Event Center at Archer as specified in the bid attached hereto as Exhibit B.
- B. CONTRACTOR shall work closely with COUNTY in coordinating the purchase and delivery, CONTRACTOR will work with COUNTY as needed in accordance with such individuals or curriers as deemed appropriate by COUNTY.
- C. CONTRACTOR agrees to retain all required records for three (3) years after the County makes final payment and all other matters relating to the Agreement are concluded. CONTRACTOR agrees to permit access by the COUNTY or any of its duly authorized representatives to any books, documents, papers and records of the CONTRACTOR, which are directly pertinent to this specific Agreement for

purposes including but not limited to audit, examination, excerpts, and transcriptions.

V. GENERAL PROVISIONS

- A. <u>Termination:</u> This Agreement may be terminated (a) by either party at any time for failure of the other party to comply with the terms and conditions of this agreement; (b) by either party, with thirty (30) days' prior written notice to the other party; or (c) upon mutual written agreement by both parties.
- B. Entire Agreement: This Agreement (5 pages), and the attached RFB (19 pages) and the attached Proposal (10 pages) represent the entire and integrated agreement and understanding between the parties and supersede all prior negotiations, statements, representations and agreements, whether written or oral.
- C. <u>Assignment:</u> Neither this Agreement, nor any rights or obligations hereunder shall be assigned or delegated by a party without the prior written consent of the other party.
- D. <u>Modification:</u> This Agreement shall be modified only by a written agreement, duly executed by all parties hereto.
- E. <u>Invalidity:</u> If any provision of this Agreement is held invalid or unenforceable by any court of competent jurisdiction, or if the COUNTY is advised of any such actual or potential invalidity or unenforceability, such holding or advice shall not invalidate or render unenforceable any other provision hereof. It is the express intent of the parties that the provisions of this Agreement are fully severable.
- F. Applicable Law and Venue: The parties mutually understand and agree this Agreement shall be governed by and interpreted pursuant to the laws of the State of Wyoming. If any dispute arises between the parties from or concerning this Agreement or the subject matter hereof, any suit or proceeding at law or in equity shall be brought in the District Court of the State of Wyoming, First Judicial District, sitting at Cheyenne, Wyoming. The foregoing provisions of this paragraph are agreed by the parties to be a material inducement to CONTRACTOR and to COUNTY in executing this Agreement. This provision is not intended nor shall it be construed to waive COUNTY's governmental immunity as provided in this Agreement.
- G. <u>Contingencies:</u> CONTRACTOR certifies and warrants no gratuities, kickbacks or contingency fees were paid in connection with this Agreement, nor were any fees, commissions, gifts or other considerations made contingent upon the award of this Agreement.
- H. <u>Discrimination</u>: All parties agree they will not discriminate against any person who performs work under the terms and conditions of this Agreement because of race, color, gender, creed, handicapping condition, or national origin.

- I. <u>ADA Compliance:</u> All parties agree they will not discriminate against a qualified individual with disability, pursuant to law as set forth in the Americans With Disabilities Act, P.L. 101-336, 42 U.S.C. § 12101, et seq., and/or any properly promulgated rules and regulations relating thereto.
- J. <u>Governmental/Sovereign Immunity:</u> COUNTY does not waive its Governmental/Sovereign Immunity, as provided by any applicable law including W.S. § 1-39-101 *et seq.*, by entering into this Agreement. Further, COUNTY fully retains all immunities and defenses provided by law with regard to any action, whether in tort, contract or any other theory of law, based on this Agreement.
- K. <u>Indemnification</u>: To the fullest extent permitted by law, CONTRACTOR agrees to indemnify and hold harmless COUNTY, its elected and appointed officials, employees and volunteers from any and all liability for injuries, damages, claims, penalties, actions, demands or expenses arising from or in connection with work performed by or on behalf of CONTRACTOR for COUNTY except to the extent liability is caused by the sole negligence or willful misconduct of COUNTY or its employees. CONTRACTOR shall carry liability insurance sufficient to cover its obligations under this provision and provide COUNTY with proof of such insurance.
- L. <u>Third Parties:</u> The parties do not intend to create in any other individual or entity the status of third party beneficiary, and this Agreement shall not be construed so as to create such status. The rights, duties and obligations contained in this Agreement shall operate only between the parties to the Agreement, and shall inure solely to the benefit of the parties to this Agreement.
- M. <u>Conflict of Interest:</u> COUNTY and CONTRACTOR affirm, to their knowledge, no CONTRACTOR employee has any personal beneficial interest whatsoever in the agreement described herein. No staff member of CONTRACTOR, compensated either partially or wholly with funds from this Agreement, shall engage in any conduct or activity, which would constitute a conflict of interest relative to this Agreement.
- N. Force Majeure: Neither party shall be liable to perform under this Agreement if such failure arises out of causes beyond control, and without the fault or the negligence of said party. Such causes may include, but are not restricted to, Act of God or the public enemy, fires, floods, epidemics, quarantine restrictions, freight embargoes, and unusually severe weather. In every case, however, a failure to perform must be beyond the control and without the fault or the negligence of said party.
- O. <u>Limitation on Payment</u>: COUNTY's payment obligation is conditioned upon the availability of funds, which are appropriated or allocated for the payment of this obligation. If funds are not allocated and available for the continuance of the services and equipment provided by CONTRACTOR the Agreement may be terminated by COUNTY at the end of the period for which funds are available. COUNTY shall notify CONTRACTOR at the earliest possible time of the services, which will or may be affected by a shortage of funds. At the earliest possible time means at least thirty (30) days before the shortage will affect payment of claims, if COUNTY knows of the shortage at least thirty (30) days in advance. No penalty shall accrue to

COUNTY in the event this provision is exercised, and COUNTY shall not be obligated or liable for any future payments due or for any damages as a result of termination under this provision. This provision shall not be interpreted or construed to permit COUNTY to terminate this Agreement in order to acquire similar services from another party.

- P. <u>Notices:</u> All notices required and permitted under this Agreement shall be deemed to have been given, if and when deposited in the U.S. Mail, properly stamped and addressed to the party for whom intended at such parties' address listed herein, or when personally delivered personally to such party. A party may change its address for notice hereunder by giving written notice to the other party.
- Q. <u>Compliance with Law:</u> CONTRACTOR shall comply with all applicable laws, regulations and ordinances, whether Federal, State or Local.

1.0 PURPOSE & OVERVIEW

Laramie County is soliciting competitive sealed bids from qualified vendors to provide a portable rodeo arena for the Event Center at Archer.

2.0 SCOPE OF SERVICES

Description of Work:

The Laramie County Events Department operates several recreational event facilities, including the Event Center at Archer, Exhibit Hall, and Community Center. The department is also responsible for the coordination and execution of multiple county events, such as the Laramie County Fair and Laramie County Sportsman's Expo.

The Event Center at Archer opened in July of 2019 and features 110,000ft² of indoor event space, including a 49,000ft² finished concrete main floor. We are looking for mats for approximately 27,000ft² of concrete flooring. Mats are not part of this RFP.

This is a lump sum contract that is broken out by major items of work. Bidders shall completely fill out the entire bid schedule. All labor, equipment, materials and incidentals related to the bid items shall be included in the unit costs whether or not specifically listed in the pay ttems.

GENERAL SCOPE OF WORK:

The project includes the new Rodeo Arena for Laramie County. The Rodeo Arena shall comply with the plans and specifications as attached.

PART 1 - GENERAL

1.1 RELATED DOCUMENTS

A. Drawings and general provisions of the Contract, including General and Supplementary Conditions apply to this Section.

1.2 SUMMARY

A. Fabricate and install horse stall and arena systems complete as specified and as shown on the Drawings. Selected bidder would be expected to provide a representative to be present and available for installation consultation, but not required to complete the install themselves.

1.3 SUBMITTALS

- A. Product Data: Provide product data for all manufactured components including hardware, anchorage and connection methods and finishes.
- B. Shop Drawings: Scaled drawings showing arena layouts in each building. Provide elevations, sections and details of each panel type that fully demonstrate frame construction, profiles, components, hardware type and locations, connections and installation details.
- C. Provide samples of standard Powder Coating colors available.
- D. Manufacturer Qualifications: Submit information as outline in Paragraph 1.4.A.
- E. Installer Qualifications: Submit information as outlined in Paragraph 1.4.B.

1.4 QUALITY ASSURANCE

- A. Manufacturer Qualifications: Company specializing in manufacturing horse stalls and rough stock rodeo equipment with not less than five (5) years of documented experience.
- B. Installer Qualifications: Company regularly engaged in the installation of horse stalls and rough stock rodeo equipment approved by the manufacturer, and with not less than five (5) years of documented experience.
- C. Qualification of Welding Work: Welders shall produce 1/8" thru 1/4" fillet weld using 70,000 psi (or greater) tensile strength wire.
- D. Pre-installation Conference: Installer to attend conference at project site to clarify compliance with installation requirements.

1.5 DELIVERY, STORAGE, AND HANDLING

- A. Owner or its representative shall inspect packaged units upon delivery and notify manufacturer of any damaged units within 48 hours of delivery.
- B. Installer to provide equipment, operator and supervision for safe unloading as directed by the General Contractor.
- C. Support stacked products to prevent deformation and to allow air circulation.
- D. Store on site in location as directed by Owner's Representative.

1.6 PROJECT SCHEDULING

- A. The Contractor shall comply with the following schedule.
 - 1. Production of shop drawings are to commence upon receipt of executed contract and upon receipt of completed architectural drawings.
 - 2. Provide all submittals and samples for approval prior to construction of the mockups. All submittals and samples shall be delivered to the Architect and/or Owner for review and approval.

1.7 WARRANTY

- A. Manufacturer shall warrant the livestock stalls and rodeo arena equipment for a period of one (1) year from the date of substantial completion.
 - 1. All materials and equipment furnished shall be of good quality and new unless otherwise requested by Owner.
 - 2. The Work shall be free from faults and defects and conform to the contract Documents.

3. The manufacturer shall repair or replace defective equipment or materials and provide any labor necessary to repair or replace defective equipment or material at no expense to the Owner.

PART 2 – PRODUCTS

1.1 FINISHES

- A. General: Comply with NAAMM "Metal Finishes Manual" for recommendations relative to application and designations of finishes. Finish metal fabrications after shop assembly.
- B. Surface Preparation
 - a. All manufactured panels, gates and equipment shall be shot blasted so that all rust and debris is removed from the metal surfaces. The blasting shall leave an etched surface to promote the adherence of the finishing materials.
 - b. Dust and oils shall be removed from panels, gates and equipment by means of an aqueous paint pretreatment wash system. This system shall also apply a phosphate conversion coating with a minimum coating weight of 60 mg per square meter. Pretreatment system must have integrated rinse stage(s) between stages and final rinse.
 - c. Moisture from the rinse cycle shall be immediately dried by forced heat.

C. Powder Coating

- a. Factory Finish for all stall and livestock equipment components: All stall and livestock equipment components shall be finished with an architectural grade (often called super-durable or ultra-durable by some coating manufacturers) TGIC polyester powder coating. The color shall be selected by the Owner.
- b. Performance Requirements
 - 1. Coverage/Hide: The the powder coating shall achieve full hiding at 2.5 mil over a black/white test panel.
 - 2. Thickness: The minimum applied thickness of the coating shall be 2.0 mil.
 - Smoothness: The application of the coating shall achieve a smoothness rating of Ford 4-6 at 2.0 mil.
 - 4. Salt spray / Corrosion Resistance:
 - 1. A single coat system shall be tested and demonstrated to "pass" salt spray exposure for 1,000 hours. Failure point to be defined as 1/8 creep from scribe (ASTM score of 5).
 - 2. The plural coat system with separate primer and top coat shall be tested and demonstrated to pass salt spray exposure for 1,700 hours given same failure condition as described in #1.
 - 5. Adhesion: The powder coating application must demonstrate an adhesion score of 5b (100%) in response to testing in accordance with ASTM D- 3359-95.
 - 6. Weathering / UV fade resistance: Resistance to color fade and loss of gloss shall be demonstrated by retaining 75% of its original gloss after 500 hours of exposure under UV-B 313 lamps per ASTM G-53 and 50% of its original gloss after 750 hours. Color shift after 350 hours of exposure to UV-B must be less than 1 Delta E. The UV testing is to be performed under a cycle of 4 hrs UV exposure at 60C followed by 4 hours condensate at 50C.
 - 7. Hardness: The cured powder coating shall achieve a hardness rating of H-2H.
 - 8. Impact resistance: The coating system shall demonstrate resistance to impacts of 160 in-lbs direct, and 160 in-lbs reverse, in response to testing in accordance with ASTM D-2794-93, by being free of cracks and free of lost adhesion.

1.2 FASTENERS AND ANCHORAGE SYSTEMS

A. Fastening and anchorage shall be provided to support applied loads of the equipment and livestock.

1.3 FABRICATION, GENERAL

- A. Use materials of size and required thickness to produce strength and durability in finished product. Work to dimensions shown using proven details of fabrication and support.
- B. Form exposed work true to line and level with accurate angles and surfaces. Ease exposed edges to a radius of approximately 1/8" unless otherwise noted.
- C. Weld corners and seams continuously, mitered or butt joints are acceptable, complying with AWS recommendations. Any open ends shall be welded closed with a minimum of 18 gauge materials in the stalls and 16 gauge in the rough stock equipment. At exposed connections, welds shall be free from any snags or pits, remove any sharp or rough areas by grinding smooth. Grind any exposed welds that

- protrude more than 1/8" from the surface.
- D. Fabricate items with joints neatly fitted and properly secured.
- E. Preassemble items in shop to greatest extent possible to minimize assemble. Disassemble units only as necessary for shipping and handling limitations. Clearly mark units for reassembly and coordinate installation.
- F. Fabricate joints that will be exposed to water in a manner to exclude water.

1.4 BUCKING CHUTES

- A. Bucking chutes shall have an 8-guage steel frame construction. Bucking chute skids shall be constructed of 3" square steel tube with 3/16" wall thickness.
 - a. Steel frames and skids shall have a powder coat finish.
- B. Bucking chute release gates shall have oval, 11-guage steel rail construction with an 8-guage steel frame.
 - a. Steel frames and rails shall have a powder coat finish.
 - b. Release gates shall have a leveling adjustment.
 - c. Release gates shall open using a spring-loaded lever latch that locks when open. Latches shall be shielded to prevent accidental opening and should work in a manner which allows the latch to open under intense pressure.
 - d. Tie down bars shall be welded to each release gate.
 - e. Release gate hinges shall pivot and be urethane-lined.
- C. Bucking chutes shall have 2" by 8" tongue and groove Rumber® filled roll gates.
- D. Roll gates shall "roll" using ball-bearing rollers and shall lock shut with gravity latches.
 - a. Roll gates shall have a roll guide located at the bottom of each chute to reduce dangers of top gate support.
 - b. Roll gates shall have a dirt "kick-out" outlet to keep roll track free of debris.
- E. Bucking chutes shall utilize pin connectors.
- F. Bucking chutes shall include a 3' wide folding contestants' platform on the back of each chute.

1.5 ROPING CHUTES

- A. Roping chute shall be fabricated using welded steel construction.
- B. Roping chute shall have sides with solid sheeted bottoms extending up from ground level.
- C. Roping chute head gate shall operate by utilizing a single pivot release trigger to open the over-center locking latch.
 - 1. Each head gate partition shall utilize adjustable individual spring tension to ensure consistent opening action.
 - 2. Roping chute head gate shall utilize adjustable rubber stop blocks to reduce noise and prevent bounce-back of head gate partitions.
 - 3. Roping chute head gate shall close utilizing a dual handle mechanism, with one handle on each side.
 - 4. Roping chute head gate partitions shall be sheeted on top and bottom sections.
- D. Roping chute tailgate shall be a split tailgate that opens from either side.
- E. Roping chutes shall have a side window on each side, located just behind the head gate.
 - 1. Windows shall open using a spring-loaded latch.
- F. Roping chutes shall be designed and manufactured to minimize the opportunity for competitors' ropes to become entangled in the chutes.

2.7 PANELS AND GATES

- A. ROUGH STOCK PANEL
 - 1. Frames shall be of 2" O.D. 14-gauge, tubing.
 - 2. The overall frame size shall be 72" tall, after attachment to connector post.
 - 3. Panels shall be available in nominal 1', 3', 4', 5', 6', 8', 9', 10', 12', 14' and 16' lengths.
 - 4. The spacing of horizontal rails shall be 11 1/4", maximum.
 - 5. All posts shall be seamless and closed ended. Joint connection shall be saddle cut.
 - 6. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.
- **B.** ROUGH STOCK ARENA PANEL
 - 1. The frame shall be made of 2" O.D. 16-gauge tubing.
 - 2. The overall frame size shall be 72" tall.
 - 3. Panels shall be available in nominal 8', 10', 12', 14' or 16' lengths.
 - 4. The spacing of horizontal rails shall be 11 1/4", maximum.
 - 5. All posts shall be seamless and closed ended. Joint connection shall be saddle cut.
 - 6. Pin connections shall be integrated into the panel. Pins shall be 5/8" smooth rounded bar and

secured to the panel with 1/8" thick steel attachment loops.

7. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.

C. ROUGH STOCK SHEETED PANEL

- 1. The frame shall be made of 2" O.D. 14-gauge tubing.
- 2. The bottom of the panel shall be sheeted with 22" of 14 gauge steel sheeting.
- 3. The overall frame size shall be 72" tall, after attachment to connector post.
- 4. Panels shall be available in nominal 8' or 10' lengths.
- 5. The spacing of horizontal rails shall be 11 1/4", maximum.
- 6. All posts shall be seamless and closed ended. Joint connection shall be saddle cut.
- 7. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.

D. ROUGH STOCK SHEETED ARENA PANEL

- 1. The frame shall be made of 2" O.D. 16-gauge tubing.
- 2. The bottom of the panel shall be sheeted with 22" of 14 gauge steel sheeting.
- 3. The overall frame size shall be 72" tall.
- 4. Panels shall be available in nominal 8' or 10' lengths.
- 5. The spacing of horizontal rails shall be 11 1/4", maximum.
- 6. All posts shall be seamless and closed ended. Joint connection shall be saddle cut.
- 7. Pin connections shall be integrated into the panel. Pins shall be 5/8" smooth rounded bar and secured to the panel with 1/8" thick steel attachment loops.
- 8. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.

E. ROUGH STOCK CONNECTOR POSTS

- 1. Connector posts shall be manufactured of 2 3/8" O.D. 11-gauge standard tubing with formed
- 2. Connector posts shall be available in 6' and 8' lengths.
- 3. Connector posts' pins shall be fabricated from 5/8" round steel bar and secured with formed 1/8" steel loops.
- 4. The top ends of connector posts shall have enclosed ends. The bottoms of the connector posts shall remain open.
- 5. Connector posts shall be available with 1, 2, 3 or 4-way connections.
- 6. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.

F. ROUGH STOCK BOW GATES

- 1. Frames shall be of 2" O.D. 14-gauge, tubing.
- 2. Gates shall be of 2" O.D. 14-gauge steel tubing.
- 3. Rough stock bow gates shall be available in 3', 4', 5', 6' and 8' widths by 7' tall and 6', 7', 8', 10' and 12' widths by 9' tall.
- 4. The spacing of horizontal rails shall be 11 1/4", maximum.
- 5. Joint connection shall be saddle cut.
- 6. Frames shall be closed-ended on top and open ended on bottom.
- 7. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.
- 8. The latch shall be a double-piston slam-lock lever latch; this shall include a gravity safety latch.
- 9. Gate frames shall be closed-ended on top and bottom.
- 10. Hinges shall be 11-gauge, 2 3/4" collars welded over 2 3/8" 8-gauge hinge posts.

G. ROUGH STOCK WALK THROUGH

- 1. Frames shall be 2" O.D. 14-gauge tubing.
- 2. Gates shall be of 2" O.D. 14-gauge steel tubing.
- 3. Panels shall be available in nominal 10' and 12' lengths.
- 4. The panel height size shall be 6' after attachment to the connector posts and the bow height shall be
- 5. The spacing of horizontal rails shall be 11 1/4", maximum.
- 6. Joint connection shall be saddle cut.
- 7. Frames shall be closed-ended on top and open ended on bottom.
- 8. The rough stock arena walk thru shall have pin connectors on both ends.
- 9. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.
- 8. The latch shall be a double-piston slam-lock lever latch; this shall include a gravity safety latch.
- 9. Gate frames shall be closed-ended on top and bottom.
- 10. Hinges shall be 11-gauge, 2 3/4" collars welded over 2 3/8" 8-gauge hinge posts.

H. ROUGH STOCK ARENA WALK THROUGH

- 1. Frames shall of 2" O.D. 16-gauge, tubing.
- 2. Gates shall be of 2" O.D. 16-gauge steel tubing.
- 3. Panels shall be available in nominal 10' and 12' lengths.
- 4. The panel height shall be 6' and the bow height shall be 7'.

- 5. The spacing of horizontal rails shall be 11 3/16", maximum.
- 6. All posts shall be seamless and closed ended. Joint connection shall be saddle cut.
- 7. The rough stock arena walk through panels shall be connected via pin connectors.
- 8. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.
- 9. The latch shall be a single-piston slam-lock lever latch; this shall include a gravity safety latch.
- 10. Hinges shall be 11-gauge, 2 3/4" collars welded over 2 3/8" 8-gauge hinge posts.

I. ALLEY STOP

- 1. The frame shall be fabricated from 2-3/8" 11-gauge and 1.315" diameter 11-gauge steel tubing.
- 2. The overall size shall be 14 1/2" wide by 36" long.
- 3. The alley stop shall be adjustable from 18" to 32" and shall have a 3/16" proof coil chain.
- 4. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.
- 5. All components except chain shall have a powder coated finish.

J. STEER ALLEY PANEL

- 1. Alleyway sheeting shall be minimum 16-gauge sheeting material.
- 2. Closure sheeting shall be 12-gauge sheeting material.
- 3. Edges of all sheeting to be encapsulated in minimum 11-guage tubing.
- 4. Posts and frames shall be seamless and tops of all post ends must be enclosed.
- 5. All joints shall be fully welded with 1/8" throat size. Welds shall be smooth and free of burrs.

PART 3 – EXECUTION

3.1 EXAMINATION

- A. Before beginning work, Installer must verify that project conditions are ready for installation of components and are true and correct.
- B. Verify all dimensions related to installation of stall systems. Incorporate verified dimensions in Shop Drawings.

3.2 SCHEDULING

- A. Delivery and installation of pre-fabricated stall components and rough stock arena equipment shall be in coordination with designated construction projects and events at Will Rogers Coliseum Complex.
- B. General Contractor shall schedule deliveries and work such that delivery of panels does not interfere with ongoing Owner/General Contractor operations.
- B. General Contractor shall provide adequate storage and staging space on site prior to installation of components.

3.3 INSTALLATION


- A. Set units plumb, level and true to line, without warp or rack. Anchor securely in place.
- B. Repair damaged finish surfaces on site, utilizing method recommended by manufacturer.


3.4 ADJUSTING

A. Adjust all stall components for proper and smooth operation.

3.5 CLEANING AND PROTECTION

- A. General Contractor shall clean all work in accordance with Division 1 requirements.
- B. General Contractor shall protect installed components from subsequent construction operations.

The County will not be responsible for any oral representation(s) given by any employee, representative or others. The issuance of a written addendum is the only official method by which interpretation, clarification or additional information can be given.

If it becomes necessary to revise or amend any part of this RFP, notice may be obtained by accessing the County web site. Respondents in their bid must acknowledge receipts of amendments. Each respondent should ensure that they have received all addenda and amendments to this RFP before submitting their bid. 3.9 Award

3.13 Payment Terms

3.14 Conflict of Interest Disclosure Form

All respondents shall complete and have notarized the attached disclosure form of any potential conflict of interest that the respondent may have due to ownership, other clients, contracts, or interest associated with this project.

3.15 Minor Irregularities

The County reserves the right to waive minor irregularities in bids, providing such action is in the best interest of the County. Minor irregularities are defined as those that have no adverse effect on the County's best interests, and will not affect the outcome of the selection process by giving the respondent an advantage or benefit not enjoyed by other respondents.

3.16 Deviations

All bids must clearly and with specific detail, note all deviations to the exact requirements imposed upon the respondent by the General Terms & Conditions. Such deviations must be stated upon the Bid Form; otherwise Laramie County will consider the subject bids as being made in strict compliance with said General Terms & Conditions to respondents; the respondent being held therefore accountable and responsible. Termination or cancellation of the contract will not relieve the respondent of any obligations or liabilities resulting from any acts committed by the respondent prior to the termination of the contract.

3.20 Incurred Expenses

This RFP does not commit Laramie County to award a contract. Nor shall Laramie County be responsible for any cost or expense which may be incurred by the respondent in preparing and submitting the bid called for in this RFP, or any cost or expense incurred by the respondent prior to the execution of a contract agreement.

3.21 Presentations by Respondents

Laramie County, at its sole discretion, may ask individual respondents to make oral presentations and/or demonstrations without charge to the County.

The County reserves the right to require any respondent to demonstrate to the satisfaction of the County that the respondent has the fiscal and managerial abilities to properly furnish the services proposed and required to fulfill the contract. The demonstration must satisfy the County and the County shall be the sole judge of compliance.

Respondents are cautioned not to assume that presentations will be required and should include all pertinent and required information in their original bid package.

3.22 Minimum Specifications

The specifications listed in the Scope of Service are the minimum required performance specifications for this RFP. They are not intended to limit competition nor specify any particular respondent, but to ensure that the County receives quality services.

3.23 Respondent's Personnel

The respondent shall be responsible for ensuring that its employees, agents and subcontractors comply with all applicable laws and regulations and meet all federal, state and local requirements related to their employment and position. The respondent certifies that it does not and will not during the performance of the contract employ illegal alien workers or otherwise violate the provisions of the federal Immigration Reform and Control Act of 1986, as amended. During the performance of the contract, the respondent agrees to the following:

The respondent shall not discriminate against any employee or applicant for employment because of race, religion, color, sex, age, handicap or national origin, except when such condition is a bona fide occupational qualification reasonably necessary for the normal operations of the respondent.

The entire bid cannot be designated as proprietary or a trade secret. If a request is received to examine portions designated as proprietary or a trade secret, Laramie County will notify the vendor to permit the vendor to defend the proprietary nature of the information.

If a respondent discovers any ambiguity, conflict, discrepancy, exclusionary specifications, omission, or other error in this document, the respondent shall immediately notify the issuing office. If a respondent fails to notify the issuing office of any error, ambiguity, conflict, discrepancy, exclusionary specifications, or omission, the respondent shall submit a response at its own risk and under such conditions. If the respondent is awarded a contract, then such respondent will not be entitled to additional compensation, relief, or time by reason of the error or its later correction.

Termination

The selection may be terminated (a) by either party at any time for failure of the other party to comply with the terms and conditions of the RFP or any subsequent agreement; (b) by either party, with thirty days' prior written notice to the other party; or (c) upon mutual written agreement by both parties.

Force Majeure
