With the exception of items explicitly delineated in this Amendment, all terms and conditions of the original Agreement, and any previous amendments, between the CONTRACTOR and the COUNTY, including but not limited to sovereign immunity, shall remain unchanged and in full force and effect.
- 8. GENERAL PROVISIONS.
 - A. ENTIRE AGREEMENT. The Original Agreement (5 pages), Attachment A (12 pages), Attachment B (6 pages), Attachment C Insurance Requirements (3 pages) and this Amendment One (3 pages) represent the entire and integrated agreement and
