Chairman Lovett opened the meeting for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Lovett closed the comment period.

A motion was made by Commissioner Thompson, seconded by Commissioner Holmes, that this agenda item be approved.

Commissioner Thompson said he had received a couple of phone calls about the purchase of the building. He said that both courthouses are full. He noted the county is obligated to house the judicial system. Commissioner Thompson spoke about the need for expansion in the future and that building new space at the Archer Complex would cost 10 times or more than the building in question.

Commissioner Thompson stressed the county's stance on not competing with the private sector, particularly in terms of leasing space in the building at market value if it is leased out in the future.

Commissioner Thompson emphasized the county's proactive approach, noting that the purchase of the building would help reduce the chance of additional absentee owners and distressed properties in the downtown core.

Commissioner Holmes discussed the purchase of the building and noted that the county would not subsidize rental rates. He said the county's building is full, and with the growing community, there will be a demand for expanded services. He noted that the county has done its due diligence by hiring consultants to perform inspections and make the county aware of any potential problems with the building.

Commissioners Holmes and Heath reiterated the county's unwavering commitment to maintaining offices in the downtown area and ensuring the community's continued access to essential services.

Justin Arnold, Planning, said Steil Surveying Services, LLC, on behalf of Cheyenne Church of Christ and Airport Parkway Church of Christ, submitted zone change and administrative plat applications. He said the administrative plat is for Tract 1, Church of Christ Subdivision, 1st Filing, situated in a portion of the SE1/4 of Sect 19, T14N, R65W of the 6th PM, Laramie County, WY. Arnold said the subject property lies at 4707 Allan Rd, and the 17.19-acre parcel will be divided into two tracts, to be known as Church of Christ Subdivision, 2nd Filing. He said Tract 1 will be an 11.92-acre tract, including the existing church, and Tract 2 will have 5.25 acres of vacant land to sell. Arnold said the zone change for Tract 2, Church of Christ Subdivision, 1st Filing, and Tract 2, Church of Christ Subdivision, 2nd Filing is to change the zone district from AR - Agricultural Residential to a MU - Mixed Use zone district to accommodate commercial uses on the two tracts.

Arnold said based on evidence provided, staff recommends approval of the administrative plat and zone change with the adoption of findings of fact a, b and c.

Chairman Lovett opened the hearing for PUBLIC COMMENT. James Schick, Clint Taylor and Bill Eckrich, residents, expressed concerns about the zone change. Comments were about maintaining a rural lifestyle and a residential neighborhood, and the lack of information on commercial uses.

Commissioner Thompson spoke about a condition for any site plans to come back to the board to give residents the ability to make comments on any uses for the property.

Hearing no further PUBLIC COMMENT, Chairman Lovett closed the hearing.

Justin Arnold, Planning, said Steil Surveying Services, LLC, on behalf of The Ramona Niland Trust, submitted a subdivision permit and plat application for Mesa Tracts, 5th Filing. He said the intent is to subdivide one sixteen-and-a-half (16.55) acre tract into three tracts of approximately five-and-a-half (5.45) acres each. Arnold said the property is located at 8420 E Pershing Blvd, approximately 1/4 of a mile east of Christensen Rd, and the land is within the A2 - Agricultural zone district. He said that since the new density would violate the requirements of the A2 zone district, the applicant also asked to rezone the property to AR - Agricultural Residential.

Arnold said based on evidence provided, staff recommends approval of the zone change and the subdivision permit and plat with the adoption of findings of fact a, b

and c.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Seth Lloyd, the city of Cheyenne Planning, recommended an easement to extend Mesa Trail.

Hearing no further PUBLIC COMMENT, Chairman Lovett closed the hearing.
