Justin Arnold, Planning, said the applicant informed the project will not be completed and requested the application be withdrawn. No board action is required.

19. PUBLIC HEARING regarding the Project Jade site plan and the BFC Power and Cheyenne Power Hub Project site plan located in Sects 5 and 7, T12N, R66W, of the 6th PM, Laramie County, WY.

Justin Arnold, Planning, said Tallgrass Integrated Solutions, LLC, and WY DC 1, LLC, submitted applications for the Project Jade site plan and the BFC Power and Cheyenne Power Hub Project site plan. He said the projects require two separate board actions.

Arnold said the two projects were combined into a single report for ease of readability. The purpose of the projects is to develop a data center (Project Jade) and a power plant (BFC Power and Cheyenne Power Hub Project) within the newly formed Switchgrass Industrial Park. He said board approval is requested because the projects have significant impact on the surrounding area. Arnold said Project Jade's site will be developed on Sect 5, a 600-acre parcel, and will consist of five data center buildings, two support buildings, and associated infrastructure. He said the BFC Power and Cheyenne Power Hub's site will be developed on Sect 7, a 659-acre parcel, and will consist of two power generation facilities and associated infrastructure.

Raymon Williams, Tallgrass, Matt Field and Sara Axelrod, Crusoe, spoke about their respective companies and projects. They noted the various mitigation efforts that will be undertaken, including limiting truck traffic in residential areas, acquiring water from the Lance Formation aquifer, and opening a local office with a dedicated liaison to answer resident questions and help with issues. They said the projects represent a significant investment in Laramie and will help move the country forward by making it more competitive as an AI leader. They said the projects are being developed with the community in mind to maximize benefits and minimize impacts.

Arnold said based on evidence provided, staff recommends approval of both site plans with the adoption of findings of fact a and b with four conditions: 1) All agency comments will be addressed, and/or corrected prior to the issuance of a Certificate of Review by Laramie County Planning and Development, 2) Access and Drainage easements will be recorded with the County Clerk's office prior to the issuance of a Certificate of Review by Laramie County Planning and Development, 3) Legal access to the property must be established and 4) Approval from WYDOT is required.

Chairman Malm opened the hearing for PUBLIC COMMENT.

Randy Fox, Hyndman Heights HOA, expressed concerns about traffic congestion, questioned whether there is a sufficient survey of the Lance Formation, creation of a man camp, and asked whether there is a need for future review if the power plant increases in size. Fox expressed that the companies have been responsive and have demonstrated good neighborliness, and that some concerns have been alleviated through the review of the staff report.

Amber Leyba, Greater Cheyenne Chamber of Commerce; Senator Evie Brennan, SD31; Chief of Staff Drew Perkins, Governor's office; Riley McCauley and Noah Loetscher, Western States Regional Council of Carpenters; Betsy Hale, LEADS; Pete Obermueller, Petroleum Association of Wyoming; Tyler McLachlan and Tucker Fagan, residents, support the projects. Comments included the positive economic impact of projects which help Laramie County remain competitive, opportunities for young people to stay in Wyoming, national security, advancements and the need to win the AI race, closed-loop data center using water, self-power generation, expansion of additional core industries, creation of jobs and return on investments.

Ryan Cox, State Engineer's office, said he believes the applicants will be 100 percent within the Lance Formation when the projects are completed.

Commissioner Heath expressed concerns about the impact of workers staying in hotels, the limitation on tourists' ability to get rooms, and decreased revenue from lodging taxes when workers remain for more than 30 days.

Thomas White and Michelle Jessica, residents, expressed concerns about contamination and consumption of groundwater, traffic, lighting, changes to the viewshed, and the need to fund the educational system.

Hearing no further PUBLIC COMMENT, Chairman Malm closed the hearing.

A motion was made by Vice Chairman Thompson, seconded by Commissioner Hollingshead, to grant approval of the Project Jade site plan permit, and adopt the findings of fact a and b of the staff report with the following conditions: 1) All agency comments will be addressed, and/or corrected prior to the issuance of a Certificate of Review by Laramie

County Planning and Development, 2) Access and Drainage easements will be recorded with the County Clerk's office prior to the issuance of a Certificate of Review by Laramie County Planning and Development, 3) Legal access to the property must be established and 4) Approval from WYDOT is required. The motion carried by the following vote:

A motion was made by Vice Chairman Thompson, seconded by Commissioner Hollingshead, to grant approval of the BFC Power and Cheyenne Power Hub Project site plan permit, and adopt the findings of fact a and b of the staff report with the following conditions: 1) All agency comments will be addressed and/or corrected prior to the issuance of a Certificate of Review by Laramie County Planning and Development, 2) Access and Drainage easements will be recorded with the County Clerk's office prior to the issuance of a Certificate of Review by Laramie County Planning and Development, 3) Legal access to the property must be established and 4) Approval from WYDOT is required.

Commissioner Thompson said if residents have concerns, they should come and talk with the board. He noted he feels the applicants will be good neighbors, as demonstrated by Fox's testimony.

Commissioner Zwonitzer echoed the sentiments regarding stakeholder engagement and due diligence. He spoke about how Tallgrass will use Wyoming's legacy industries. Commissioner Zwonitzer said the power plant will be located out of sight and will have a low visual impact.

Commissioner Heath said there will be pros and cons to every project or change coming into the community. She spoke about property taxes and reinvesting in education, which are under the state legislature's control. Commissioner Heath discussed the benefits, noting that applicants will pay property and sales taxes, which will benefit education and county services.

Commissioner Hollingshead said, as a father and grandfather, one thing he considers in evaluating developments in Laramie County is keeping our young people here, and he wants it to be a multi-generational community.

Chairman Malm spoke about private property rights, mitigating risks and ensuring public safety. He expressed hope that the legislature will fund education at the level needed. On the subject of water, he said the applicants will use significantly less water than if the land were a subdivision. He spoke about the county's future role at the forefront of the next arms race in AI and compared it to our role in nuclear deterrence.

He noted how proud he is of the military and what the county has accomplished for generations, now and in the future.
