Chevenne Community Public Recreation District Narrative

Laramie County purchased the Archer Complex in 2004. Since its purchase, the land is now
home to several County departments to include EMA, Planning, Coroner, Public Works, The
Juvenile Justice Center and the Shooting Sports Complex. Archer is also home to the Laramie
Events Department. The Events Department has several buildings located at Archer to include
the Fair Office, Commercial Kitchen, Community Center and the Multi-Use Events Center.

Archer has become an activity and destination spot in Laramie County. The County has recruited several outside organizations and events to be hosted at the facilities to include Windy Wyoming, Motocross Park, arena, and a dog agility course. Events are booked through the Laramie County Events Department throughout the year. We also have an RV Park to accommodate the influx of visitors to Laramie County out at Archer. The RV park has been operational since June 2017 consists of 20 wet sites (water & electrical) and 40 dry sites (electrical). This RV Park is adjacent to Leadership Park where the CCRD board funded a playground. This small playground is for younger children and ties into the history of Archer and the West with a stagecoach and train play set. The board also funded our community's first and only musical instrument park out at Archer in Leadership Park. We would like to continue to build on play opportunities for youth in the community by offering an Inclusive playground space. This will be located south of the existing playgrounds and made accessible for all.

The Laramie County Events Department currently brings approximately 325 event days to the Archer complex per year. These events range from conventions, animal auctions, rodeos, 4H/FFA, meetings and various community events. These events bring large crowds to Archer and usually includes children.

Laramie County in partnership with the Laramie County Recreation Planning and Advisory Board
along with the Laramie County Events Department is seeking funding to assist in providing four
play inclusive structures to be located at Archer near the Events Center.

Our expected outcomes are simple; we anticipate generating greater usage of the Archer Complex by providing inclusive playground equipment. We predict that the playground will be heavily used by the youth frequenting the park, both with their families and on their own. Having this play opportunity in the community will provide all children of Laramie County with a safe recreational activity space.

If selected for funding, we could start immediately with the bid process to hire a qualified vendor to provide this specialized playground equipment. We have conducted basic research into the existing vendors who might be interested in our project.

3. This is and will be a public space that is open from 7am until dusk, seven days a week. We have reviewed the usage of the existing Archer facilities on an annual basis and we can estimate that fifteen kids play at Archer per day and that one hundred twenty five kid's access the area on a weekly basis. There is a higher usage of the park in the warmer months than there is during the Wyoming winter. Being a public space, it is open to everyone and we anticipate heavy usage when events are booked at the Archer Complex. Frequent users will be 4H, FFA, Boy Scouts and it will be open to all children and families coming into Archer for the events being held by Laramie County. Surrounding events and facilities such as the Motocross and Windy Wyoming will also bring visitors to this particular park. The Archer Complex is located right off of I-80 and

we anticipate non-residential visitors stopping by to access this one of a kind park in Laramie County.

4. Budget Details

We are requesting \$50,000 towards our inclusive playground; we are open and flexible to the type and style of equipment, but here is what we think would be the best fit.




