Currently, LCCC students rent 241 of these beds. Next year student local panely is projected to rent 350-400 beds. Rooms not occupied by LCCC students are made available to external parties for rent for short and long-term stays.

We have not advertised, but rather, provide these vacant rooms for rent through short term and long-term rental agreements, or word of mouth. Interest in renting our rooms by external parties is growing as we have grown room capacities, and have the availabilities to do so.

- Cheyenne CRMC rents rooms for visiting health care professionals

- Holly Frontier contractors coming to Cheyenne rent rooms during their extended stays in Cheyenne

- UW Family Medicine rents rooms for medical rotations in Cheyenne
- Wyoming high school welding teachers rent rooms for activities they have in Cheyenne
- Wyoming high school thespians traveling to Cheyenne have rented rooms
- New employees arriving in Cheyenne rent rooms while sourcing permanent housing



pricing, serving breakfast, lunch and dinner, and has become popular within the Cheyenne community.


