

A RESOLUTION TO SUSPEND THE RETAIL LIQUOR LICENSE ISSUED TO BULLSEYE OPERATIONS, LLC d/b/a OUTLAW SALOON

WHEREAS, on or about May 20, 2025, the Laramie County Board of Commissioners (“Board”), acting pursuant to Wyo.Stat.Ann. § 12-4-101 et seq., issued a retail liquor license to Bullseye Operations, LLC d/b/a Outlaw Saloon (“Licensee”), for Licensee’s establishment located at 312 S. Greeley Highway, Cheyenne, WY, in unincorporated Laramie County. Wyo.Stat.Ann. § 12-4-201(f).

WHEREAS, on or about November 12, 2025, the Liquor Division of the Wyoming Department of Revenue (hereinafter “Division”) issued a “Sales Tax Hold Notice,” which was provided to Laramie County and is attached hereto. The Notice states: “Pursuant to W.S. 12-2-306, the Liquor Division has received certification of a sales tax delinquency for” Licensee. The Notice also states that “Liquor Division sales to the license holder have been suspended” and that this suspension “shall remain in effect until the Liquor Division has received certification from the Wyoming Department of Revenue, Excise Tax Division that the sales tax delinquency has been resolved.”

WHEREAS, pursuant to Wyo.Stat.Ann. § 12-7-103, “[a] local licensing authority may suspend any license issued under this title if the licensee fails to pay sales taxes and the division has ceased sales of alcoholic liquor to the licensee pursuant to W.S. 12-2-306.”

NOW THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF LARAMIE COUNTY, WYOMING, as follows:

The Laramie County Board of Commissioners finds that the retail liquor license issued to Bullseye Operations, LLC d/b/a Outlaw Saloon should be suspended pursuant to Wyo.Stat.Ann. § 12-7-103, because Licensee failed to pay sales tax and the Liquor Division ceased sales of liquor to Licensee.

THEREFORE, the Board decides and resolves that the retail liquor license issued to Bullseye Operations, LLC d/b/a Outlaw Saloon shall be, and hereby is, suspended.

Pursuant to W.S. 12-2-306, the Liquor Division has received certification of sales tax delinquency for the liquor license holder named above.

Liquor Division sales to the license holder have been suspended as of the hold date shown above and this suspension shall remain in effect until the Liquor Division has received certification from the Wyoming Department of Revenue, Excise Tax Division that the sales tax delinquency has been resolved.

Wyoming Statute 12-7-103 allows the local licensing authority to suspend any license under Title 12 if the licensee fails to pay sales tax and the division has ceased sales of alcoholic liquor to the licensee pursuant to W.S. 12-2-306. The licensee may appeal license suspension to the District Court in the manner specified under W.S. 12-4-104(f) and the appeal proceedings shall be in accordance with the Wyoming Rules of Appellate Procedure. The suspension shall remain in effect pending a decision by the Appellate Court.

Wyoming Statute 12-4-601(b) prohibits the transfer of any license if the transferring licensee is certified as delinquent.

The Liquor Division will be send notification upon release of the certification.
