**BE IT FURTHER RESOLVED** that Trudy L. Eisele, the Laramie County Treasurer, shall have the authority to place investments on behalf of Laramie County in those instruments authorized pursuant to W.S. § 9-4-831(a) and to enter into agreements with the listed depositories and appropriate investment companies, after review by the County Attorney.
