Michael Surface, Planning, said AVI, consultant for Cheyenne LEADS and the North Range Business Park Commercial Owners Association, submitted a Subdivision Permit and Plat application for North Range Business Park, 13th Filing. The property fronts Happy Jack Rd. It is bound by Logistics Dr on the east and Bruns Way to the west. The application was submitted to subdivide the property into three lots. Lot 1 is 7.15 acres, Lot 2 is 11.75 acres, and Lot 3 is two acres. Lot 1 is a shared open space owned by the North Range Business Park Commercial Owners Association. Lot 2

has a small utility building located upon it.
