Justin Arnold, Planning, said Dennis Dawson, PLS on behalf of Elizabeth Barkell, Roy P. Medina, Molina Munoz, Zapata Torres, Socorro R. Munoz, Edgar Torres, Hermila Torres and Rene Socorro Molina submitted a Subdivision Permit and Plat application located on the Territorial Plat of Egbert. It essentially is a corrective replat action. The

application was submitted to subdivide the property from the existing 21 lots into three lots. The applicant indicated the replat is necessary because: 1) Structures have been built on unused alleys in Block 16 2) The extension of 3rd Street across Block 16 is not in the public domain but across properties owned by Barkell/Medina and the Munoz family 3) Lot 15 of Block 16 of the existing Egbert plat is owned by Laramie County which wishes to dispose of the property and 4) Existing structures built over platted alleys preclude clear title to any prospective buyer.

Mr. Dawson stated there was a shed in a right-of-way. Mr. Dawson noted the need for the chain of title, completion of some title transfers, and for the property to be conveyed to the new legal descriptions. Commissioner Malm asked about the closing and the chain of title. Mr. Dawson said the title company, TownSquare Title of Wyoming LLC, was aware of the issue and the recommendation came from the title company.

Mr. Arnold said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact with two conditions: 1) The applicant must provide all appropriate signatures, along with correction of clerical errors on the plat, and conveyance documentation prior to recording and 2) All survey errors are to be corrected prior to recording.

County Attorney Mark Voss advised condition #1 should have more detail on the meaning of the terms. Mr. Voss advised the shed may need to be removed in the future if a complaint is made.

Chairman Thompson opened the hearing for PUBLIC COMMENT. Susan Chaires, resident, wanted to know if any of the properties in question included her property. Mr. Arnold said there would be no impact on property surrounding the proposed plat. Hearing no further PUBLIC COMMENT, Chairman Thompson closed the hearing.

Commissioner Malm asked Mr. Voss if the modification to condition one should read: 1) applicant must provide all appropriate signatures, along with correction of clerical errors on the plat, and conveyance documentation with additions of further detail required and provided by the County Attorney prior to recording. Mr. Voss concurred.

Justin Arnold, Planning, said Charmaine Dregalla of SSC submitted an application seeking approval for a telecommunications tower located on Sunset Tracts, 3rd Filing, Tract 10. The property is owned by Glory Evangelical Lutheran Church, which will enter into a lease if the Board of County Commissioners approves the application. On March 1, 2022, the Board deferred the project for at least 45 days so the public notice process could be corrected and made whole. An error showing the incorrect project number in the certified mailing was the cause for deferment of the hearing.

Charmaine Dregalla, applicant, explained her company represents Dish and the tower would be stealth in appearance with light blue color to blend in with the sky and line up with the existing crosses. She noted the tower would accommodate up to three carriers.

Mr. Arnold said based on evidence provided, staff recommends approval of the telecommunication tower with the adoption of findings of fact a and b.

Chairman Thompson opened the hearing for PUBLIC COMMENT. Dale Davis, County Clerk's office, read an ecomment from Matthew Hoffman, Iron Core Capital, LLC, about protection of the viewshed. Hearing no further PUBLIC COMMENT, Chairman Thompson closed the hearing.

Mason Schuricht, Planning, said AVI PC, on behalf of Todd Glandt, submitted a Subdivision Permit and Plat application for Alpine Valley Subdivision, located over half a mile east from the intersection of Klipstein Rd and Telephone Rd. The application was submitted to subdivide approximately 17 acres into three residential tracts.

Kelly Schroeder, agent for the applicant, said details for maintenance responsibility of the existing access easement would be noted on the plat. Ms. Schroeder said the applicant has spoken with the owners to the east and north and has an agreement to maintain the access easement. She noted covenants had been created for the subdivision, detailing maintenance responsibilities for the access easement.

Mr. Schuricht said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact a with the following condition: The applicant is required to determine and submit ownership and maintenance details of the existing access easement to be used by Tract 3.
