CONSIDERATION OF A RESOLUTION AUTHORIZING THE ACCEPTANCE OF A GRANT AWARD FROM THE DEPARTMENT OF JUSTICE FOR A FY2021 BULLET PROOF VEST GRANT IN THE AMOUNT OF \$11,276.35 WITH A 50% MATCH, ON BEHALF OF THE GOVERNING BODY OF LARAMIE COUNTY, WYOMING

FOR THE PURPOSE OF: FUNDS WILL BE USED TO PURCHASE UP TO 24 BULLET PROOF VESTS FOR THE LARAMIE COUNTY SHERIFF'S DEPARTMENT.

WITNESSETH

WHEREAS, the Governing Body of Laramie County desires to participate in the DEPARTMENT OF JUSTICE BULLET PROOF VEST PROGRAM grant by accepting this grant award to assist in financing this project; and

WHEREAS, the Governing Body of Laramie County has been provided with preliminary cost estimates and information on this project; and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF LARAMIE COUNTY that a grant award in the amount of \$11,276.35 be accepted from the Department of Justice, and that the County provides a 50% match (\$11,276.35) towards the purchase of up to 24 bulletproof vests through August 31, 2023.

BE IT FURTHER RESOLVED, that Sandra Newland, or her successor in the position of Laramie County Grants Manager, is appointed as agent of the Laramie County Board of Commissioners to execute and submit requests and certifications for these funds and to receive funds and implement the programs funded under this grant.
