**ADDENDUM TO MEMORANDUM OF UNDERSTANDING between LARAMIE
COUNTY, on behalf of the LARAMIE COUNTY COMBINED
COMMUNICATIONS CENTER and AMERICAN MEDICAL RESPONSE
AMBULANCE SERVICE, INC.
REGARDING EXTENSION OF TERM TO DECEMBER 31, 2014**

THIS ADDENDUM is made and entered into by and between Laramie County, 310 W 19th St., Suite 300, Cheyenne, Wyoming 82001, on behalf of Laramie County Combined Communications Center, 2020 Capitol Avenue, Cheyenne, Wyoming 82001 (LCCCC) and American Medical Response Ambulance Service, Inc., 6200 South Syracuse Way, #200, Greenwood Village, Colorado 80111 (Contractor). The parties agree as follows:

I. PURPOSE

The purpose of this Addendum is to modify section II of the MOU between LCCCC and Contractor regarding the Term of the MOU.

II. TERM

This Addendum shall commence on the date last executed by the duly authorized representatives of the parties to this Addendum and shall remain in full force pursuant to the terms of the MOU and this Addendum. Unless specified herein, all other term and conditions of the MOU remain unchanged and in full force and effect.

III MODIFICATIONS

Pursuant to Section V, Subsection D of the MOU titled "Modification", Section II of the MOU titled "Term" is modified by the addition:

II Term. The term of the MOU will remain in effect for a period of five (5) years beginning April 1, 2009. Said Term is to be extended to December 31, 2014, to allow the completion of negotiations, mutual agreement and approval by the parties of a new MOU between the parties, should an extension of such length be required for mutual agreement to the terms of a new MOU. The execution of any new MOU regarding the subject matter herein shall be considered to have terminated the instant MOU at the time the new MOU comes into full force and effect. Nothing in this extension shall be interpreted to modify any other term and condition of the MOU or to affect the rights of the parties other than as specified herein.
