A legal ad was placed in the Wyoming Tribune Eagle to solicit nominations for directors of the Laramie County Weed and Pest Control Districts Area 1, 2, 4, and 6 with a deadline of Dec. 27, 2022, for submission of a petition.

The following nomination petitions for directors of Laramie County Weed & Pest Control District, Areas 1, 4 and 6 were reviewed by the County Clerk's Office for conformance with W.S. 11-5-104(a):

- Area 1: Guy Landers, 559 Happy Jack Rd., Cheyenne, WY
- Area 4: William Bonham, 1990 Horsecreek Rd, Cheyenne, WY
- Area 6: Ryan Farthing, HC 59, Box 11, Iron Mountain, WY

Each nominee is a qualified elector in Laramie County, Wyoming, and each nomination petition contained the number of signatures of Laramie County landowners required under W.S. 11-5-104.

The County Clerk's office did not receive a nomination petition for director of Laramie County Weed & Pest Control **District Area 2**. Pursuant to 11-5-104 (f) when a vacancy occurs on a district board, the County Commissioners shall at the next regular meeting appoint an individual who possesses the necessary qualification as a district board member to fill the unexpired term.
