**Entry Tag Pick-Up Dates:** Static entries (non-livestock) can be picked up July 20<sup>th</sup>, 21<sup>st</sup>, 23<sup>rd</sup>, and 24<sup>th</sup> from 8:00am-4:00pm at the Fair Office at 3801 Archer Parkway, Cheyenne, WY 82009. **NO PICK UP ON JULY 22<sup>nd</sup>.** Only entry corrections will be done during entry tag pickup. No additional entries will be accepted. If you are unable to pick up your tags during this time, entry tags will be available for pick up at the Exhibit Hall during drop-off on Thursday July 30<sup>th</sup>.

The Laramie County Fair Staff welcomes you to the 2026 Laramie County Fair- **“Fair’s Poppin’”** We encourage you to participate in this year’s events.

**PLEASE NOTE: ALL NEW RULES AND INFORMATION ARE NOTED IN RED. PLEASE READ CAREFULLY. ALL ENTRANTS, EXHIBITORS, AND PARTICIPANTS IN THE LARAMIE COUNTY FAIR ARE REQUIRED TO AND WARRANT THAT THEY READ, UNDERSTOOD, AND ARE BOUND BY THE FOLLOWING FAIR RULES AND REGULATIONS.**

### LARAMIE COUNTY FAIR GENERAL RULES AND REGULATIONS

#### A. Authority and Purpose

1. The purpose of Laramie County fair rules and regulations is to endorse and support the health, safety and welfare of all individuals who either attend and/or participate in as exhibitors or otherwise in the activities of the Laramie County Fair
2. These Rules and Regulations are adopted by Laramie County Commissioners under the authority granted by Wyoming statutes: WS 18-2-101 et seq, 18-9-101. Exclusion or absence from this enumerated list of authority shall not abrogate or otherwise prevent exercise of any authority or enforcement of same, granted to Laramie County by law, regulation, judicial decision or interpretation. The rules and regulation’s requirements instructions, as well as any processes contained in these regulations are the result of the legislative decision-making authority of the Board of County Commissioners granted by the Wyoming statutes.
3. Severability: should any specific section or provision in these regulations and rules be declared invalid or unconstitutional by any court of competent jurisdiction, the declaration shall not affect the validity of the regulations and rules of the whole or any other part thereof, which is not specifically declared to be invalid or unconstitutional.
4. These regulations and rules are not intended to revoke or repeal any other public law, regulation or permit. Where the conditions imposed by any provision of these rules and regulations are either more or less restrictive than comparable conditions imposed by any other provision within these regulations, or any other applicable public law or resolution, rule or regulation of any type that applies, the regulations which are more restrictive and impose higher standards or requirements shall govern.

#### B. General

1. The “Laramie County Fair” is an annual activity conducted by Laramie County through the Laramie County Events Department. References to “the Laramie County Fair” are and should be interpreted as, references to “Laramie County,” a governmental entity in the State of Wyoming. The Laramie County Events Department, which manages the Fair is an agency of, Laramie County. The Laramie County fair reserves the final and absolute right to interpret general rules and regulations and settle and determine matters and differences that may arise in accordance with the procedures set forth in these Rules and Regulations.
2. Laramie County, through the Laramie County Events Department maintains sole and discretionary control over all activities and uses which take place in, upon or associated with, Laramie County’s Archer complex, including the facilities used for the Laramie County Fair.
3. The Laramie County Fair is a member of the International Association of Fairs and Expositions (IAFE) who supports the IAFE National Code of Show Ring Ethics. It is the exhibitors’ responsibility to read, understand, and comply with the IAFE National Code of Ethics. A full description of the IAFE National Code of Ethics is located at [www.fairsandexpos.com](http://www.fairsandexpos.com).

#### IAFE (International Association of Fairs and Expositions) Code of Showing Ethics:

- All exhibitors must present, upon request of fair and livestock show officials, proof of ownership, length of ownership, and age of all animals entered. Misrepresentation of ownership, age, or any facts relating thereto is prohibited.
- Owners, exhibitors, or absolutely responsible persons shall provide animal health certificates from licensed veterinarians upon request by fair or livestock show officials.
- Junior exhibitors are expected to care for and groom their animals while at fairs or livestock shows.
- Animals shall be presented to show events where they will enter the food chain free of violative drug residues. The act of entering an animal in a livestock show is the giving of consent by the owner, exhibitor, fitter, trainer and/or absolutely responsible person for show management to obtain any specimens of urine, saliva, blood, or other substances from the animal to be used in testing. Animals not entered in an event which culminates with the animal entering the food chain shall not be administered drugs other than in accordance with applicable federal, state and provincial statutes, regulations and rules. Livestock shall not be exhibited if the drugs administered in accordance with federal, state and provincial statutes, regulations and rules affect the animal’s performance or appearance at the event.
- The use of showing and/or handling practices or devices such as striking animals to cause swelling, using electrical contrivance, or other similar practices are not acceptable and are prohibited.
- Direct criticism or interference with the judge, fair or livestock show management, other exhibitors, breed representatives, or show officials before, during, or after the competitive event is prohibited. In the furtherance of their official duty, all judges, fair and livestock show management, or other show officials shall be treated with courtesy, cooperation and respect and no person shall direct abusive or threatening conduct toward them.
- No owner, exhibitor, parent/guardian, or absolutely responsible person shall conspire with another person or persons to intentionally violate this code of ethics or knowingly contribute or cooperate with another person or persons either by affirmative action or inaction to violate this code of ethics. Violation of this rule shall subject such individuals to disciplinary action.
- The application of this code of ethics provides for absolute responsibility for an animal’s condition by an owner, exhibitor, fitter, trainer, or participant whether or not he or she was actually instrumental in or had actual knowledge of the treatment of the animal in contravention of this code of ethics.
- The act of entering an animal is the giving of consent by the owner, exhibitor, fitter, trainer, or absolutely responsible person to have disciplinary action taken by the fair or livestock show for violation of this Code of Show Ring Ethics and any other rules of competition of the fair or livestock show without recourse against the fair or livestock show. The act of entering an animal is the giving of consent that any proceedings or disciplinary action taken by the fair or livestock show may be published with the name of the violator or violators in any publication of the International Association of Fairs and Expositions, including Fairs and Expos and any special notices to members.

- The act of entering an animal in a fair or livestock show is the giving of verification by the owner, exhibitor, fitter, trainer, or absolutely responsible person that he or she has read the IAFE Code of Show Ring Ethics and understands the consequences of and penalties provided for actions prohibited by the code. It is further a consent that any action which contravenes these rules and is also in violation of federal, state, or provincial statutes, regulations, or rules may be released to appropriate law enforcement authorities with jurisdiction over such infractions.
  - The Laramie County Fair reserves the right to remove any person, at their discretion, from the grounds who violates the Rules & Regulations and/or the Code of Conduct. The Laramie County Fair reserves the right to change or add to these rules and regulations as they, in their judgment, may deem advisable. All Laramie County Fair decisions are FINAL.
  - If the exhibitor and/or the exhibitor's adult supervisor, parent or other family member's actions are deemed to be illegal or inhumane to livestock, the proper authorities will be notified for further investigation by those agencies for possible prosecution and/or civil penalties.
  - Conduct by the exhibitor, their parents, guardians, or guests, determined to be unacceptable will be dealt with on a case-by-case basis by the Laramie County Fair staff.
  - Anyone attending events either as an exhibitor, advisor, volunteer, parent, spectator, superintendent, vendor, judge, committee member, fair official or staff must conduct themselves in a manner consistent with the IAFE Code of Show Ring Ethics, which is incorporated by reference and attached hereto, along with this Code of Conduct and according to the Rules and Regulations of the Laramie County Fair. These codes of conduct and rules are not limited to the show ring, but are applicable to any event held at the Laramie County Fairgrounds including but not limited to meetings, workshops, clinics, contests, shows, county fair, social events, etc.
  - Consequences to violating this code of conduct may include but are not limited to: Verbal Warning Removal from Fairgrounds Suspension, reduction and/or loss of premiums, showcase, other awards and prize money Loss of future participation privileges Loss of privilege to be on Fairgrounds property Removal of exhibits/individuals from the grounds Loss of Junior Livestock Sale privileges. Youth of any age may be required to have an adult present after any code of conduct violation at the discretion of Fair Management. Code of conduct violations should be reported to the Fair Manager
4. All shows are open for public viewing.
  5. Special rules are published in each department and division where necessary. The Laramie County Fair is a Fair that involves the collaboration of two different Organizations; Fair and FFA, and as such, must have a separation between those Organizations' shows and rules. You will find Rules and Regulations regarding each Organizations' individual guidelines that need to be followed depending on what show you may be involved in at the time. Please be aware of what Organizations' show you are participating in and what Rules, Regulations, procedures, and enforcements you may need to follow. Please be aware that the Laramie County Fair cannot and will not enforce any rules or regulations for FFA shows.

  6. By making entry to the Laramie County Fair each exhibitor, exhibitor's parent(s) and/or legal guardian acknowledge that he/she has read, understands, accepts, and will abide by the liability requirements, exceptions and waivers contained herein and all policies, the National Code of Show Ring Ethics, and rules and regulations of the Laramie County Fair.

#### C. Eligibility

1. To be eligible to show at the Laramie County Fair, a youth exhibitor must:
  - a) Be enrolled and in good standing with their organization AND
  - b) Be a resident of Laramie County, OR attend school in Laramie County OR reside in Laramie County during Fair due to a court ordered custody arrangement AND
  - c) Are subject to any ownership deadlines, required weigh-in dates, and other project requirements.
  - d) Any discrepancy in residency of an individual that has entered in the Laramie County Fair is open to verification by any means the Events staff sees fit.
2. Any attempt to circumvent or violate these requirements or rules may result in disciplinary action, which may include the removal of all entries and indefinite removal from the grounds.
3. All 4-H and FFA entries are limited to Laramie County 4-H members and Laramie County FFA Chapter members.
  - 4-H Eligibility 4-H "age" is your age as of January 1 of the current year. You may turn 19 during the year, you may not show in 4-H showmanship or the Laramie County Fair Youth show(s) if you were 19 on January 1 of the current year. 4-H eligibility is determined by Wyoming State 4-H Rules.
  - FFA Eligibility FFA members in Laramie County are eligible to exhibit and sell at the Laramie County Fair up to the second county fair following their high school graduation regardless of age. FFA members will be able to show as an FFA member for a maximum of eight years. FFA members must be bona-fide members and in good standing with their FFA Chapter. Any issues regarding FFA member eligibility will be decided upon by the members FFA advisors and the Wyoming State FFA Rules. You must meet the requirements for active membership as listed in the current FFA rulebook to participate in any contest at this fair. This is defined by enrollment in a secondary agricultural education class, dues current and eligible to show

#### D. Liability Statements

1. All exhibitors and exhibits must comply with the policies and regulations of the Laramie County Fair and the Laramie County Events Department as well as applicable law. By entering into and/or participating in, any County Fair event, show or other activity, entrants and exhibitors agree that the Laramie County Fair/Laramie County, its employees, agents, elected and appointed officials will in no case be liable or responsible for any loss or damage that may occur to or with any exhibit or to any exhibitor.
2. Exhibitors or participants in fair events or activities hereby acknowledge that engaging in activities in connection and association with the programs, events and activities of the Laramie County Fair carries an inherent risk of injury, property damage and financial loss; including, physical, financial risks and risks to property, including but not limited to loss or damage to property and transmission of infectious disease to any animal or person. Exhibitors and participants also acknowledge and understand that the Laramie County Fair makes no representations, guarantees, assurances or warranties for safety, function or my continued participation, in regard to its actions, plans, work, activities, events, equipment or supplies. By entering as an exhibitor or participant in any fair event or activity, said exhibitors or participant do so with full acknowledgment of the inherent risks and indicate their consent and understanding by said entry.
3. Each exhibitor, and in the case of minors, their parents or legal guardians, heirs and assigns: Agree and understand the following **WAIVER** and **RELEASE** applies to participation in the Fair. By participating in, or entering any activity or event at the Fair, including but not limited to livestock shows, exhibitors and participants agree to **RELEASE** and **DISCHARGE** the Laramie County Fair/Laramie County, its elected and appointed officials, employees, volunteers and agents from all causes of action, damages claims or demands both direct and consequential for all known or unknown personal injuries property damage or death resulting from or arising out of participation in the activity and events. Further, to the fullest extent provided by law, they agree to **INDEMNIFY** Laramie County, its employees, agents, elected and appointed officials against all legal or other proceedings in regards thereto, as well as: damage, injury or loss, including but not limited to, loss injury or damage to any other person or property, caused by the exhibitor or any animals

exhibited by him/her, or arising out of, or in any way connected with, such exhibition of any of the animals so exhibited.

By entering as an exhibitor or participant into any Fair event or activity, any entrants certifies and warrants that they have read and fully understand this waiver and release. By entering into any event or activity entrants agree and certify that they are **REQUESTING TO PARTICIPATE AND RELEASING LIABILITY**, freely, voluntarily and without coercion and in consideration of the opportunity to participate in activities of the Laramie County Fair and other good and valuable consideration. They further certify that they are 18 years of age or older or, **If the Exhibitor or Participant is a minor, their parent(s) or guardian(s), fully participate in and acknowledge the contents and effect of this waiver and release on the minor's behalf.**

4. All Fair participants including, but not limited to, exhibitors, spectators, vendors, entertainers, superintendents, etc. are responsible for their own negligence and/or damage they may cause to the property or persons of others and/or Laramie County; They will be responsible to the injured party, either by paying for any and all damages directly to the injured party or by paying a subrogation claim made by the injured party's insurance company.

#### **E. Complaints**

1. All complaints must be brought to the attention of an FFA Advisor, Show Superintendent, or the Fair Manager before the end of the show to which the Complaint is related. The complainant must provide sufficient time for the Complaint to be reviewed without interruption of the show(s) or the complaint will not be considered.
2. No complaints will be accepted or reviewed after the completion of the show in question.
3. All complaints will be reviewed by no less than (3) representatives made up of individuals from each organization (FFA & Fair).
  - The FFA Advisors will make the final determination regarding complaints associated with all FFA Division Shows and
  - The Fair Manager will make the final determination regarding complaints associated with all youth, open class, and contest Division Shows
5. All determinations by the foregoing are final and may not be protested
6. Judges may exercise their discretion in the application and implementation of applicable rules and guidelines. Judges' decisions may not be protested.

#### **F. Arrival/Departure of Entries**

1. All exhibits must be in place for inspection by the public and/or judges in accordance with the Fair schedule published within this book.
2. All livestock exhibits, except for sale animals, will be allowed to leave after the corresponding species show and/or Born and Raised.
3. If you choose to take your animals home after their show, you must check in with your specie superintendent and clean out your pen(s).
4. Removing an exhibit prior to release time without the permission of the Superintendent/Fair Staff will result in forfeiture of all premiums.
5. Sale animals must stay on grounds. If they are removed before the sale, they will not be allowed to sell.
6. Exhibit Hall exhibits will be released the last Saturday between 8:00 am and 12:00 pm.
7. The Fair Staff or Superintendents will not be responsible for items left or not picked up at the designated times.

#### **A. Entries**

1. Each FFA, 4-H, Open Class, Fair Fun static (non-animal) and animal exhibit in the Fair must have an entry listing on the correct official paper entry form or online.
2. All exhibitors, 4-H Clubs, and FFA Chapters must have a completed exhibitor profile in ShoWorks entered by the exhibitor online or by submitting a paper entry form by the entry deadline in order to enter a class, show, or contest and to receive premiums and awards.
3. Official Fair entry forms and the online entry link are available at [www.laramiecountyfair.com](http://www.laramiecountyfair.com) . Paper entry forms may be scanned and emailed to [fairoffice@laramiecountyfair.com](mailto:fairoffice@laramiecountyfair.com) , mailed to 3801 Archer Parkway, Cheyenne, WY 82009, or dropped off.
4. Entries are due on July 15<sup>th</sup>. There will be a grace period of 10 days past that deadline at which there will be a late fee of \$100 per exhibitor to enter. Once past the grace period, there will be no late entries accepted.
5. All open class static entries are limited to Laramie County Residents.
6. Open Class Superintendents have the right to change entries to correct age division if they see fit.
7. Exhibits must be the handiwork of the exhibitor and must not have been previously shown at the Laramie County Fair.
8. Only entry corrections will be done during the designated entry tag pickup dates and times and no additional entries will be accepted.
9. No additional classes or entries will be added past the first day of the Fair; including showmanship.

#### **G. Tagging**

1. All Market animals exhibiting in the Laramie County Fair will be tagged at the centralized tagging events with a Laramie County Fair approved RFID tag. In addition to the approved RFID tag, we will require an additional form of identification for each animal exhibiting. If there is no additional form of identification in/on the animal's ear on the day of tagging, we will provide the animal with an additional tag.
2. Each market animal exhibiting/showing must have an entry in ShoWorks and the correct ear tag numbers from the species tagging event listed. Proof of ownership will be required.
3. All Sheep and Goats must have a USDA/APHIS Scrapie Identification tag or tattoo in place prior to tagging. If not in place at tagging, the animal will not be tagged.
4. **All animals must be brought to the centralized tagging to be tagged. No other accommodation will be provided.**
5. **Ear tags that fall out or break must be reported to the fair office as soon as they are discovered missing. Replacement tags will be provided after the secondary tag number/ear notch is provided to us.**
6. **During tagging, each exhibitor will be given a copy of the tags that are put into their animals' ears. Once these tags are approved by the exhibitor or the exhibitor's representative, the tag numbers will not be changed for any reason.**
7. **No exhibitor shall be allowed to show an animal that was not tagged in their name with the exception of helping someone show an animal with duplicates in a class.**

#### **H. Premiums and Awards**

1. No prize will be awarded or sponsored by any individual or group without the permission of the Laramie County Fair.
2. Premiums and awards will only be awarded to exhibitors, 4-H Clubs and FFA Chapters that have a completed exhibitor profile and official entry in ShoWorks either entered by the exhibitor online or by submitting a paper entry form.
3. Judges will not award prizes to any exhibit/animal that does not meet minimum qualifications of the division in which it is entered. It is the intention of the Fair Staff that no premium or distinction of any kind be given to any animal or article that is not deserving. The rule will be adhered to whether or not there is competition. The awarding of a trophy for those classes so designated is at the discretion of the judge of that class. When there are fewer than three exhibits in any class, some classes can be combined and the judge will award whatever placing the exhibits deserve on the basis of quality. When there is no competition between exhibitors in a class, only one award will be given. No exhibit will be eligible for more than one premium in any one class.
4. No premium shall be awarded, nor will any premium be paid on any animal or article not mentioned or classified in this premium list.
5. Premium Disputes: **September 30 of the current exhibiting year**, is the deadline for reporting any errors in a premium check or for a check not having

been received by the exhibitor. No changes will be made nor checks issued after September 30. Premiums are paid based on placement on official Judging Sheets, not ribbons received.

6. Premium checks will be made payable to the exhibitor name designated on the entry form and mailed to the address provided by the exhibitor. Exhibitors are responsible for notifying the Fair Office of any change to the exhibitors mailing address.
7. Exhibitors who receive premiums above the reporting limits set by the IRS will be required to complete a W-9 prior to receiving their premium check. A Form 1099-MISC will be mailed to you for your taxes.
8. Premium checks must be redeemed by December 31st of current fair year to avoid forfeiture.
9. All exhibitors requesting consideration for adjustment of a premium must submit their request online or by mail on a premium adjustment request form. Mailed premium adjustments must be post marked by September 30th of current year. Neither adjustment requests nor reissue of unreceived checks will be considered after September 30th of current year. Requests made by phone will not be accepted.

**I. Vet Check Rules and Procedures-** These rules and procedures encompass Fair as a whole

1. All livestock, unless otherwise stated under the specific department, are required to pass a veterinarian inspection before unloading animals on grounds. If an animal does not go through vet check, the animal will be removed from the grounds, and will not be allowed to show.
2. Any animal deemed ineligible to show may not remain on the fairgrounds.
3. All Veterinarian decisions are final and may not be protested.
4. If the Veterinarian is unable to make a determination on animal eligibility, Events Director, or designee, reserves the right to declare an at-risk animal ineligible out of precaution for the health and safety of the exhibitors and other livestock.
5. **During vet check, all animals must have all coverings removed. This includes blankets, leg wraps, or anything else that covers any part of the animals body.**
6. **Any animal exhibiting signs of a contagious disease or illness will be sent home immediately to prevent the spread of infection. Animals with skin conditions will be evaluated to determine whether the condition is active and poses a risk of transmission to other animals or humans. This determination will be made at the sole discretion of a licensed veterinarian.**
7. **A skin condition may be considered active if it exhibits any of the following characteristics:**
  - a) **Presence of an open or scabbed wound**
  - b) **Lack of new hair growth in the affected area**
  - c) **Visible blood or bleeding**
  - d) **Presence of pus or other signs of infection**
8. **Final determination of activity and risk of transmission will be made at the discretion of a licensed veterinarian.**
9. **Health inspection paperwork or determinations from outside veterinarians will not be accepted during or after vet check with the exception of the shows that specifically require them. All health evaluations and final decisions regarding contagious conditions, skin issues, or any other symptoms will be made exclusively by the designated on-site veterinarian.**

**J. Animal and Livestock Policies-** These policies encompass Fair as a whole

1. All market animals will enter the appropriate Market Animal Division. Youth show and FFA designations, breeds, and weights will be determined at the weigh-in. Each market animal exhibiting/showing must have an entry in ShoWorks and the correct ear tag numbers from the species tagging event listed. Proof of ownership will be required.
2. All Market animals exhibiting in the Laramie County Fair will be tagged at the centralized tagging events with a Laramie County Fair approved RFID tag. In addition to the approved RFID tag, we will require an additional form of identification for each animal exhibiting. If there is no additional form of identification in/on the animal's ear on the day of tagging, we will provide the animal with an additional tag.
3. All livestock will be checked in by the specie superintendent and assigned stalls. No animal will be stalled without first checking with the specie superintendent. Closing time for check-in and weigh-in in all livestock areas will be in accordance with the Fair schedule.
4. All animals must be declared Youth or FFA before stepping on the scale.
5. Once an animal exits the scale, no changes will be made to their weight, breed classification, market/breeding designation, or Youth/FFA status.
6. No livestock will be re-weighed.
7. All animal exhibitors are responsible for complying with all State Brand Laws and all Wyoming animal health laws.
8. No animal or exhibit may be entered by more than one exhibitor within any given year.
9. No animal or exhibit may be shown in both FFA and the Youth show within any given year.
10. No animal can be shown in both Market and Breeding in the same year.
11. All entered animals must be halter broken and manageable by the exhibitor. Any animal that is considered a hazard to exhibitors, spectators, or others will be excused from the show and the grounds.
12. Inhumane treatment or abuse of animals will not be tolerated. This includes dragging, beating, kicking, spanking, slapping or anything that causes an audible noise when done to the animals while in or out of the show ring. Exhibitors will receive one warning. Second offense will result in automatic disqualification of exhibitor and all entries for that species with no recourse. This will be a Fair wide rule and will encompass every show.
13. The Youth Show Grand Champion and Reserve Market Beef, Sheep, Swine and Goat will compete against the FFA Grand Champion Market Beef, Sheep, Swine and Goat for the combined Overall Grand Champion Title.
14. Any act of artificially filling animals internally will not be tolerated. This will include stomach pumping, drench tubes, or any other esophageal method. Violation of this rule will result in forfeiture of premiums and disqualification of animal and exhibitor without recourse.
15. Drench guns are permitted.
16. All Sheep and Goats must have a USDA/APHIS Scrapie Identification tag or tattoo in place prior to tagging.
17. In the interest of ensuring the maximum possible fire protection rating, the Laramie County Fair will require wood shavings as the primary bedding material for animals exhibited at the Laramie County Fair. Poultry and rabbits without trays at the bottom of the cage must have bedding on the ground under the cage. However, because of special health considerations, ONLY Dairy Goats and Breeding Sheep will be permitted to use the bedding material of their choice. All other animals will be bedded on wood shavings. While the Laramie County Fair does provide some bedding, exhibitors need to provide additional bedding if the bedding that is provided is not sufficient.
18. All livestock must be kept in assigned stall areas while on the fairgrounds.
19. With the exception of designated cattle tie out times of 7:00 pm- 9:00 am, cattle are not allowed to be taken to trailers or other areas away from the cattle barns/chute area at any time.

**K. Camping**

1. Camp Space Reservations will open online beginning June 1<sup>st</sup>. Spaces are limited and therefore they will be assigned by a drawing. Only online submissions will be accepted, and a drawing will be run to determine recipients of the Water/Electric spaces. At a date determined by Fair Staff, spaces will be awarded using random number selection that correlates directly to your entry.

2. Camp space fee is \$100.00 for Water/ Electric, \$75.00 for Electric Only, and \$50 for Dry Camping per space per unit for the week of fair.
3. The corresponding fee must be paid in full no later than July 1<sup>st</sup>. If left unpaid, The Laramie County Fair reserves the right to reassign your space.
4. There are limited amount of spots available with 50 amps hookups. We make every effort to place you in the space requested, but you will be required to provide any additional adapters needed to make your space useable.
5. Campers and RVs are required to stay within designated camp space. Pop outs cannot extend past assigned camp space.
6. No mailed or phone reservations will be accepted.
7. Campers are responsible for any damages or waste left in camper spaces.
8. Unsanitary, inadequately cleaned or damaged spaces may result in denial of reservation for the following year.
9. There will be no spaces available until the day before Fair begins. Please do not arrive before this time.
10. No camping will be allowed on the grounds unless proper health and fire regulations are met.
11. NO juvenile camps will be permitted. Each campsite must be supervised at all times by an adult (age 21 & over).
12. Self-contained units will be allowed to remain in the park providing no waste material is expelled from the unit. Campers who do not have waste facilities will be allowed, provided all trash and debris are disposed of in barrels located around the park, and restrooms facilities are used.
13. ABSOLUTELY NO TENTS will be allowed to be set up on the grounds under any circumstances.
14. Alcohol use is subject to State and Federal law. No alcoholic beverages may be transported more than fifty (50) feet from the Campground area.
15. Archer/Fair Grounds curfew is 11:00 p.m, all nights. Quiet hours are from 11:00 p.m. until 5:00 a.m.
16. Your assistance in meeting County fire (W.S. 18-5-201 & W.S. 18-5-301) and health codes (W.S. 35-1-303) is required.

#### L. Safety Rules for Archer Fairgrounds

1. Certain fire lanes as posted must be kept open for minimum safety. A 25 foot fire lane must be kept open directly in front of all barns, and trailer and camper units cannot be left in these areas without maintaining proper safe distance from fire lanes. Any electrical hook-up can only be made at properly designated electrically grounded units. The park will be patrolled daily by fire and health authorities. A warning will be issued and time given to correct deficiencies. A second notice will be cause for ejection from the park. No privately-owned heavy equipment will be allowed on the grounds (i.e. tractors, loaders, etc.)
2. Any electrical equipment used by an exhibitor at Laramie County Fair must be UL approved and meet National Electrical code.
3. For your safety as well as others-BICYCLES, SCOOTERS, AND PETS, INCLUDING DOGS AND CATS, WILL ONLY BE ALLOWED IN DESIGNATED AREAS. NO PETS, SCOOTERS, OR BICYCLES IN LIVESTOCK BARN OR EXHIBIT HALL. Service animals are welcome. Per the Laramie County Animal Control regulations and State Statute, W.S. 11-31-301 et seq, as amended, if a pet is found to be a "public nuisance" as defined, the owner shall be subject to the penalties provided for in Article V of the County Animal Control Regulations and/or any other penalty imposed by applicable law, ordinance or regulation. Due to this, we ask that all pets be kept on a leash while on public property. Owners of any nuisance animal may be required to remove the animal from Laramie County Archer grounds.
4. Public use of ATV's (All-Terrain Vehicle), RUV's (Recreational Utility Vehicle) and Golf Carts at the Archer Fairgrounds with the exception of Fair Staff Official Use and Emergency Personnel is **prohibited**.
5. Curfew will be 11:00 p.m. on all nights.
6. No alcohol is allowed in the barns and must be contained within 50 feet of the campground.

#### M. Superintendents

1. Barn and Department Superintendents, as Laramie County Fair representatives, shall have charge of the department/division assigned to them. The Superintendent will have responsibility of the stalls, pens, or display spaces in their department. It shall be the duty of each Superintendent to inform the judges, in their department, of the policies governing the shows and awards before judging begins.

#### Herdsmanship

The purpose of Herdsmanship is to encourage exhibitors in developing and maintaining clean and presentable stalling areas as well as demonstrating good animal husbandry and welfare. It also promotes pride and enthusiasm for the industry and rewards those exhibitors that achieve this purpose. Herdsmanship duties are the primary responsibility of the livestock exhibitor.

**Herdsmanship Awards:** 100% in any species= \$25; 95%-99% in any species=\$15; 90%-94% in any species=\$5

There will also be a "Supreme Exhibitor" winner of each species that will receive a banner. This will be given to the exhibitor that goes above and beyond in Herdsmanship.

**Judging:** Judging will be completed by the Herdsmanship Superintendent along with the assistance of a Herdsmanship committee The Herdsmanship contest will begin at the time the division of animals is to be in place and ends when animal exhibits are released. Judging for Herdsmanship may take place any time between 7:00 am and 9:00 pm.

Herdsmanship will be judged on the following criteria:

**Animals: (15 Points)** Clean at all times with proper grooming, feed, bedding, and care apparent, properly penned and secured. Appear healthy and free of disease or insect infestation.

**Stalls: (25 Points)** Clean and neat, clean bedding, full water bucket, feed and feed pans and buckets clean and in place, no excessive manure in stall area, stall cards/exhibitor signs clearly in place. Project presentation boards, posters, etc. are highly encouraged. This is your opportunity to educate the public about your project!

**Tack/Feed Area: (10 Points)** Kept clean and neatly arranged, grooming and tie-out areas kept clean, personal items out of sight or neatly stored.

**Alleyways: (25 Points)** Exhibitors designated alleys and commons areas kept clean, free of equipment, loose dirt and dust kept under control with proper sweeping and/or sprinkling, no manure in piles.

**Exhibitors: (25 Points)** Proper courtesy and conduct shown by exhibitors at all times and in all places including with the public and other exhibitors. This will include all aspects of Sportsmanship. All exhibitors are expected to participate in Herdsmanship.

**Any animals not meeting general health or Herdsmanship standards can/will be identified to the species Superintendent. If necessary, the specie Superintendent will bring the issue to a member of the Fair staff. At which point, a decision will be made on whether the animal(s) will be removed from the grounds.**

# LARAMIE COUNTY FAIR YOUTH LIVESTOCK SALE

**General Information:**

Each market beef, sheep, goat, poultry, rabbit, and swine exhibitor may sell one qualified animal. Exhibitors who have two Grand Champion Youth and /or Reserve Grand Champion Youth Animals may sell those two animals in the livestock sale. (For example, if a 4-H member has the Grand Champion Youth Steer and the Reserve Champion Youth Lamb, he/she may sell both animals). (Member who has the Grand Champion Youth Turkey, and a breed champion steer may only sell one animal). Animals consigned to the sale will sell only one time.

Sale order is determined by the Laramie County Events staff and published prior to the sale with rotation of species and placings. Champions will sell first. Any exhibitor planning on donating portions or whole proceeds to charity, scholarship, or similar causes must notify the Laramie County Events staff prior to the sale. The Laramie County Events staff will place those animals in the sale order appropriately and may not sell where the animal ranked.

The animal sold in the sale must be the animal delivered to the buyer/processor. If a member wishes to keep an animal, they should not enter it into the sale. Exhibitors may not buy back their animal at the time of the sale. Exhibitors shall not ask their buyer for their animal to be donated back to them after the sale of the animal. Violations may disqualify the exhibitor from participating in future Laramie County Fair Youth Livestock sales.

**General Rules:** Exhibitors must abide by the following rules for selling an animal:

- Sale animals must stay on grounds. If they are removed before the sale, they will not be allowed to sell.
- Exhibitors planning on selling in the Laramie County Fair Youth Livestock Sale must attend one of the exhibitor meetings published in the Laramie County Fairbook schedule after arrival.
- **Only 4-H Members regularly enrolled in Laramie County 4-H will be allowed to sell an animal in this sale.** Any animal shown in a Youth Market show are eligible to sell. No FFA or Breeding designated animals will be allowed to sell through this sale.
- Exhibitors must complete applicable age division Quality Assurance Training provided by Laramie County 4-H prior to the sale.
- Youth exhibitors must comply with 4-H Rules for Quality Assurance.
- Exhibitors must accurately complete a sale consignment card prior to the sale. Sale cards will be handed out during Mandatory sale meetings (see schedule)
- **All sales are final, by consigning your animal to the sale, after it is purchased, the exhibitor no longer owns it and may not contact the buyer to negotiate trading/switching/or buying back the animal. Violation of this rule may cause the sale to be negated and the buyer's money to be returned**
- Exhibitors must complete a thank you card. It is understood that exhibitors may choose to send a personalized thank you card following the sale, but it is required to complete a general thank you card prior to the sale for buyers.
- Exhibitors must have an official photo taken by the photographers on site with their designated sale animal. At the time of the photograph, exhibitors must bring their sale consignment card to the photographer. An official signature will be placed on the card for later verification that the photo was completed.
- When stamped and signed consignment cards are turned in, the exhibitor will be provided a duplicate copy of their consignment card.
- **All consignment cards must be turned into the 4-H office by 5 pm on Thursday, August 6<sup>th</sup>, 2026. In the event that a sale card is not turned in by the deadline, the youth will be allowed to sell but will be charged a 15% commission until 8 am on Friday, August 7<sup>th</sup> After that time, no consignment cards will be accepted, and the exhibitor will not be allowed to sell.**
- **All exhibitors who turn in consignment cards between Thursday at 5:01 pm and Friday at 8 am will be placed at the end of the sale.**
- Lamb and Beef exhibitors must turn in ownership papers to the brand inspectors before entering the sale ring. Brand inspectors will write transport papers to State Fair during the sale. Please approach them after you have sold.
- **Exhibitors are required to present their animal(s) in the sale ring during the sale. Exceptions given to medical emergencies, and/or illness. Exhibitor or exhibitor's representative must notify the respective fair management/show superintendent of any extenuating circumstances. For scenarios not outlined above the fair manager should be notified as soon as possible**
- Animals will be sold by the head. According to standard auction procedure, a commission will be deducted from each consignor's check to cover the cost of advertising, supplies, recognition of buyers and volunteers, etc. Commissions are:  

2% Beef	5% Goats, Sheep, and Swine	5% Poultry/Rabbit
---------	----------------------------	-------------------
- Commissions will not be removed from add-on money.
- Animals may be disqualified from the sale if the official judge, veterinarian, or Fair Staff recommends disqualification based on market readiness, health, or sale rule infraction.
- **Due to animal processors request, no glitter or paint may be used on sale animals. If an animal comes to sale check in with these items, they will be told to go wash their animal, potentially missing your sale spot.**
- The Laramie County Events staff will make arrangements for the delivery of the animals not reserved for State Fair following the sale. Every precaution will be taken for safe delivery; however, ownership is changed to the buyer when sold.
- **State Fair Animals - once an animal is sold at the sale, it becomes the 4-H member's responsibility to transport State Fair animals to the designated processor on the predetermined dates following State Fair. All resale animals reserved for State Fair are to be delivered to LCCC the day they are released from State Fair.**
- **Failure to return the same animal for slaughter that was sold through the Junior Livestock Sale or the attempted substitution of another animal will result in an automatic no sale. In that case, the buyer's money will be refunded, and ownership reverts to the seller. If an exhibitor decides to not attend the state fair, the animal must be taken to the designated spot at the announced time/date. Failure to comply will result in a voided sale and potential sale suspension.**
- Any question about the Laramie County Fair Youth Livestock Sale after fair should be directed to the Fair Manager.

- You must turn in your paperwork for State Fair to the Extension Office by August 6<sup>th</sup> at 12 PM for all animals except horses. Horse entries are due by 12 PM on Aug. 4<sup>th</sup>.
  - When stamped and signed consignment cards are turned in, the exhibitor will be provided with a receipt.
1. All animals sold must be legally owned by the 4-H member in accordance with species ownership deadlines **by proof with ownership paperwork.**
  2. Youth age for all 4-H events is calculated as their "4-H Age" which is their age on Jan. 1 of the current 4-H year. Age groups are broken down as follows:
    - **Cloverbud**-Age 5-7 on Jan. 1
    - **Junior** – Age 8-10 on Jan. 1
    - **Intermediate**- Age 11-13 on Jan. 1
    - **Senior**- Age 14-18 on Jan. 1Cloverbuds are non-competitive and can only participate in certain 4-H events during fair.
  3. 4-H Showmanship.
    - 4-H members competing in 4-H showmanship in one species contest are not precluded from competing in the same species contest in FFA
    - Showmanship exhibitors must compete with their own animals.
    - Preparation and showing of animals must be consistent with the rules in the livestock section.
    - **No breeding animals may be shown in the Market showmanship classes.** Cats and Dogs should refer to individual rules in the appropriate species sections.
    - All showmanship classes must be pre-entered.
  4. **To verify entries at your event please bring a copy of your ShoWorks online entry receipt or a copy of your verified paper entry to all contests and events.**

## FITTING RULES:

### **Laramie County Fair Youth Show Fitting rule- Applies to all Youth Market shows, Born and Raised, Breeding, and Open shows**

- Exhibitors are expected to take care of, groom and fit their own animal(s) at Fair. In the interest of safety and education, a member may be assisted by other Laramie County 4-H/FFA members/advisors, as well as immediate family. Immediate family is defined as parents, grandparents, sister/brother - only. Please remember that Fair is an educational experience. The exhibitor is expected to perform the majority of fitting procedures on their own.  
Fair Staff will monitor fitting and preparation prior to the start of each show and will deal with any violations at the time. Any protests must be reported to the Fair Manager before the animal enters the ring.

In the event of violation of the above, consequences will include:

- 1) Violator may be asked to leave the show.
- 2) Dismissal of Exhibitor from the show.

**Premium Disputes:** September 30 of the current exhibiting year, is the deadline for reporting any errors in a premium check or for a check not having been received by the exhibitor. No changes will be made nor checks issued after September 30. Premiums are paid based on placement on official Judging Sheets not ribbons received.

### **Phase I: First Year**

- Bred Heifer-The bred heifer will be weighed the morning of the Supreme Cow show.
- Criteria for judging will include: Visual Appraisal (30 pts), Record Book (20 pts.), Interview (15 pts.), Performance (20 pts.)
- Bred Heifers must be no older than 20 months of age with vet certified proof of being bred at Laramie County Fair the year they are to be shown in Phase I.
- Certificate of pregnancy from a certified vet must be included in the record book.

### **Phase II: Second Year**

#### **Cow/Calf Pair**

- A clear, color picture of the calf with cow will be taken within two weeks of the calf's birth for placement in the record book.
  - The cow calf pair will be weighed the morning of the Supreme Cow show.
  - Cows must come with vet certified proof of being bred at Laramie County Fair the year they are to be shown in Phase II.
  - Criteria for judging will include: Performance (40 pts.), Interview (15 pts.), Record Book (20 pts.), Visual appraisal (25 pts.)
    - Performance points will be split, and 10 pts will be used in evaluating the cow closest to weaning a calf at 50% of her body weight.
  - Certificate of pregnancy from a certified vet must be included in the record book.
  - The heifer must be shown both years to make the contestant eligible for second-year awards.
  - All Phase II record books must be accompanied by the appropriate Phase I record book.
- Calf at side must be the natural calf (no grafts).

- **Shorthorn**- Solid red or solid white with red hair or red pigment on ear, muzzle, anus or tail or any combination of red and white with the red and white color pattern bleeding together.
- **Red Angus**- Solid red (shades may vary), polled, blonde, light red or mixed switch, may have black hair on tail, muzzle, face, neck, or legs. No white above the navel.
- **Angus**- Solid black, polled, tight sheath that is round and perpendicular to the ground, angus type ear set, small to moderate ear size high on the head. No white in front of the navel. No horns or scurs breaking through the skin.
- **AOB English Cross**- Any cross breed of following breeds: Galloway, Hereford, Shorthorn, or British breed. Can vary in color and markings but will be smaller framed.
- **Maine Anjou/Maine Anjou Cross**- Can be dark red and white, black, solid red or black and white. May have white patches on the head, tail, underside, and legs. May be horned or polled.
- **Charolais**- Must physically appear with breed characteristics of a half-blood Charolais. White, yellow gray, or silver (moderate dappling allowed, minimal painting or spotting. Skunk tail, line back, baldy.

- **AOB Continental Cross**- Any cross breed of following breeds: Limousin, Simmental, and Continental breed. May vary in color and markings but will be larger framed.
- **Crossbred**- Any steers not meeting the above description will be classified as a crossbred.

#### Rules and Regulations

- The "Household Pet" cat is of mixed breed or unknown descent.
- A purebred cat is one belonging to a recognized breed with characteristics maintained through generations of unmixed descent; may be registered with a recognized registry.
- Kittens must be at least 4 months old and not older than 8 months of age. Adult cats are older than 8 months of age. Because of susceptibility to disease, no kitten under 4 months of age will be accepted for competition.
- No pregnant or nursing cats may be entered.
- All cats and kittens must have their claws clipped. Declawed cats may enter the show and will not be counted down for declawing.
- Do not enter your cat if you feel it will not be easily handled by the judge.
- Each cat or kitten must be wearing a harness or collar (not a safety collar) and a leash. The exhibitor must always wear the leash on their wrist for safety reasons.
- Exhibitors must furnish their own carpet square during judging. Exhibitors must also bring cage or carrier for their cats/kittens.
- All exhibitors MUST wear long sleeve shirts or blouses with pants or skirts. **No shorts allowed.**

- All presentations will be held to a 5–7-minute time limit. Please plan accordingly.

#### Health Requirements

Cats must have current rabies and distemper, and feline leukemia shots are strongly recommended. All vaccinations must be given by a certified, licensed Wyoming Veterinarian. Vaccinations should not be received within three weeks prior to the show. Health Certificates are required. **Cats found to be ill or with parasites (fleas, ear mites, etc.) will not be allowed to show and will be dismissed from the grounds. No cat or kitten may enter the show if there is any (feline) infectious or contagious disease in the household within three weeks prior to the show date.**

#### **Rules and Regulations**

- 4-H members qualify to enter the State 4-H Dog Show by showing in their county Youth dog show AND:
- **Showmanship** - youth competed in showmanship at county fair or the county 4-H Educator approved the youth.
- **Obedience** - received a qualifying score of (170) or above.
- **Rally** - received a qualifying score of (70) or above.

- **Agility** - received a qualifying score of (75) or above.
- 4-H members participating in the dog project may use co-owned dogs (owned by the immediate family). The member must have sole care, training and showing of that dog for the current 4-H year.
- **Ownership:** The dog lives in the same residence with the 4-H member and is owned by the 4-H youth or immediate family member (grandparents, mother, father, brother, sister).
- **Co-Ownership:** Ownership ID Sheets extend beyond the family with two or more names on the papers to prove co-ownership exists. One of the names on the ID Sheet must be the 4-H youth or an immediate family member.
- **Dog Training Contract:** The 4-H member may enter into an agreement to train someone else's dog in situations that may benefit the member, the dog or both. This arrangement is used for families with the inability to own a dog. **The training contract should not be used as a substitute for normal dog ownership.**
- All dogs must be at least 6 months of age by May 1st to compete at the County 4-H Dog Show and 1 year of age by May 1st for agility classes. Dog ID forms should reflect the age of the dog.
- Certificates for dog entries must show current immunization as per state veterinary guidelines. **No animals will be allowed to exhibit at the Wyoming State Fair without a valid Animal Health Certificate.**
- **All dogs must be on leash (excluding competition) and under control at all times. County Fair rules prohibit any dog from being any place but the site of the dog show.** Once the 4-H dog show is completed, all dogs must be removed from the fairgrounds.
- Vicious dogs will be dismissed from the ring and must be removed from the premises.
- Bitches in season will be allowed in classes. However, they will run at the end of each class.
- Spayed, monorchid, or neutered dogs may be shown without judging discrimination.
- All dogs must be vaccinated by a certified, licensed Wyoming Veterinarian.
- Dogs must be clean and well groomed.
- The show committee reserves the right to ask anyone violating these rules to leave.
- Entries for Rally classes and Agility classes will need a current Wyoming 4-H Jump Height card at check-in to verify correct class entries.

**Obedience**

- A 4-H member may compete in only one obedience class per dog with a total maximum of two entries (dogs). Their first dog is referred to as the "A" dog. The other is referred to as the "B" dog for class entries.
- The first-year class is for members who are in their first year of the dog project, not the first year with a new dog. It is designed as a training class for members who do not feel competent to start in the On Leash class. Members may compete in the first-year beginner novice class only once.
- An exhibitor who competes in the A groups with their first dog stays in the A groups with that dog for each level. The same is true for the B groups and levels. A member advances from On Leash A to Novice A. Same applies for moving in B classes.
- B Groups are classes for all additional/second dogs entered after first dog.
- A 4-H exhibitor with a dog shown previously in obedience classes by another 4-H member, or a dog that has a title from another organization or has three qualifying scores from the designated annual county 4-H show must show the dog by these guidelines:
  - o Junior and Intermediate age exhibitors may move back or down one level
  - o Senior age exhibitors must show the dog at the highest level the dog has achieved
- A dog receiving a qualifying score of at least 170 points at county fair may advance the following year to the next higher class but must advance after receiving 3 qualifying scores. Once the higher level of obedience is selected for the dog, the member may not drop back down to the lower level with the same dog.
- Score Sheets: They are intended as guides for judges. Judges use their discretion in deciding the seriousness of errors.
- All dogs must enter/leave the show ring on a leash.
- Dogs soiling or urinating in the ring during judging will be disqualified and receive no score.
- Bait and/or toys are not allowed in obedience competition.
- Males and females will be shown in the same class. Females in heat will be shown last in the class and must be kept away from the obedience ring until call time.
- Class A and B may be combined at discretion of Superintendent(s) based on entry numbers.

- Classes 012-019 will be judged according to AKC standards, but it is not necessary that dogs be registered; they must be purebred - both animal parents of the same breed.
- Classes 020-021 are for cross-bred dogs-parents of different breeds and will be judged according to the predominant breed characteristics.

- A dog receiving a qualifying score of at least 75 points at county fair may advance the following year to the next higher class but must advance after receiving 3 qualifying scores. Once the higher level in agility is selected for the dog, the member may not drop back to the lower level with the same dog.
- Youth, with a dog shown in previous years by another 4-H member, or a dog that has a standard agility title from another organization, or has received three qualifying scores from the designated annual county 4-H show must show the dog under these guidelines:
  - Junior and Intermediate aged 4-H youth may move "back down" one level.
  - Senior aged 4-H youth must show the dog at the highest level the dog has achieved.
- All dogs must enter/leave the ring on a leash.
- Level 1 dogs will run on a leash. Level 2 dogs may use a 6-inch tab for quick corrections or run off leash.
- Collars must be of a flat, buckle variety with nothing hanging from it such as tags.
- Bait is not allowed in agility competition.
- Dogs in season will run at the end of each class.
- A time for all handlers to familiarize themselves with the course they are competing in will be established and announced. (NO dogs)

- o **Southdown**- Hair color on muzzle should be mouse colored, gray to brown. Nostril pigmentation may be black to purplish-gray. Muzzle should be broad, head of moderate length. Ears of moderate length, covered with short hair or wool. Black hoof color. Dark pigmentation on hide and/or birth marks are acceptable.
- o **AOB**- Any other breeds of lambs that do not fall into any of the listed breed classifications.
- o **Natural**- A silver/blue/dark grey, black color that is above the flank/shoulder and is either solid or fades into the rest of the body. Birthmarks will not be an indicator of color. 75% of the body needs to be of silver/blue/dark grey/black tones.
- o **Hampshire**- The face should be of good length, dark in color, and practically free of wool from the eyes down. An unbroken wool cap should extend from the neck over the forehead. The ears should be moderate in length, thick, covered with coarse dark brown or black hair, and free from wool. Some wool is desirable below the knee. Should be open around the eyes, wool feathering is acceptable and desired.
- o **Black face**- Any lamb with a solid black face with or without wool cap that does not meet the criteria of other listed breed categories. No mottling (prominent or faded round spots) or evidence that there is speckling on the face or legs. Face cannot appear muddy, brown, or gray. No pattern of regular blotchy discoloration on the face or legs will be allowed.

General adoption of AQHA Rules and USEF Rules: The Current Official Rules and Regulations of the American Quarter Horse Association (AQHA) and United States Equestrian Federation (USEF) govern this Show and Gymkhana, except as otherwise stated within this document.

**Conflicts in Rules:** Whenever a conflict exists, LCF Open show rules shall apply.

**Gate Call:** For all events, there is a 2-minute gate call. After 2 minutes the gate will be closed. If the contestant is having trouble entering the gate, they have an additional 1 minute, and may be offered assistance.

## Horsemanship regulations and disqualifying infractions:

All eliminations, dismissals, and disqualifications will be at the discretion of a judge and/or show officials, and the decision is final. Contestant will not be entitled to a refund for any class.

**Age of a Horse:** The age of the horse will be based on all horses having a January 1 birth date.

## Speed Event Safety and Information

- A safety helmet (ASTM/SEI certified) is highly recommended for use when competing in speed events. However, if a contestant is wearing a Western hat, some method of restraint must be used to ensure the hat does not come off. **Hats are optional for all speed events.**
- A horse will enter an arena the quickest and safest way whether it is led or ridden; however, after a horse and rider are in the arena, all gates will be closed and the rider will complete the pattern.
- Acceptable western attire must be worn.
- For speed events the using of a hackamore or other type of bridle is an option; however, an event official, or a judge may prohibit the use of bits or equipment he or she may consider severe or inhumane. Contestants have the option of using a tie-down.
- The judge or show official will be allowed to eliminate an entry or call a no time if either the rider or horse:
  - Fails to begin the pattern within two minutes after arena entry and gate closure.
  - Falls while riding the pattern.
  - Displays any kind of cruelty whether or not it is specifically mentioned in the rules.

- d. Crosses the finish line before completing the prescribed pattern.



## YOUTH CATTLE FITTING CONTEST

1. Contest is open to junior, intermediate, and senior individuals from each county/chapter.
2. Teams will consist of three (3) individuals all within the age division: junior (ages 8-10), intermediate (ages 11-13) and senior (ages 14 up).
3. All team members must be properly enrolled and in good standing in 4-H or FFA and have eligible Beef entered in the current Laramie County Fair.
4. The Contest Superintendent and Judge will meet with all competitors before the show to clarify rules and scoring.
5. Teams will compete in preliminary heats if entry numbers dictate.
6. Each team is to provide their own grooming products and tools based on a checklist of approved/allowed fitting items. The checklist will be provided to each team.
7. The animals to be fitted must be owned by one of the fitting team and be a valid entry in either Breeding or Market Beef at the current year's Laramie County Fair.
8. Teams will be allowed 30 minutes to work on their animal in preparation to show. A ten-minute warning will be given. At the end of the 30-minute allotted time, all equipment is to be turned off, laid down, and all work stopped.
9. All animals must be wet at the beginning of the competition.

10. There will be one 1 judge with proven beef cattle fitting experience. Judging will be based upon skills demonstrated to prepare the animal: (a) teamwork; (b) accepted use of equipment; (c) handling of the animal; (d) quality of end result. NOTE: In case of a power outage in one or more chutes, a horn will be sounded and all work shall halt for all teams.

11. Each team will present their animal to the judges at the completion of the allotted time.

8. No player may use gloves, spikes, hooks, or any other object to help catch a pig.
9. There will be 2 players on each side of entry gate.
10. All players must have one hand on the fence before they are allowed to begin.
11. Pig must be put in the barrel butt first. **With the exception of the PeeWee division which will be timed by when the team releases the ribbon from the pig.**
12. No pulling the pigs ears, tail, or hitting the pig or otherwise harm the animal. This will be cause for disqualification.
13. Barrel must be upright at all times.
14. There will be a one-minute time limit on each match.
15. Players must stay and help unload the pig out of the barrel.
16. All contestants MUST stay out of the general seating areas and building restrooms until cleaned up.
17. All contestants MUST use designated clean-up areas. Any person using restrooms or unauthorized areas to clean up will forfeit any prizes and may be disqualified from the event.
18. Payouts will be made payable to the Team Sponsor, Team Captain or Team Parent listed. Sponsor, Captain, or Parent will be responsible for distributing payout among team members. Payouts will be made following the Pig Wrestling.
