Plan of PlanCheyenne for the City of Cheyenne and the Cheyenne Urban Area

#### Dear Laramie County Planning Commission:

The Cheyenne Metropolitan Planning Organization (MPO) respectfully submits for your review and consideration the resolution Adopting *Connect 2050: Update to the Long-Range Metropolitan Transportation Plan (MTP)*. This plan serves as the federally required long-range transportation plan for the Cheyenne Urbanized Area and represents an update to the *PlanCheyenne* Metropolitan Transportation and Future Land Use Plan.

The Connect 2050 MTP outlines the community's transportation vision through the year 2050 and provides the policy framework and project priorities necessary to guide multimodal transportation investments across the region. Developed in coordination with the City of Cheyenne, Laramie County, the Wyoming Department of Transportation (WYDOT), the plan integrates transportation, land use, environmental, and economic development goals to support sustainable regional growth and mobility.

Public participation was a critical component throughout the planning process, in accordance with the MPO's adopted Public Participation Plan and federal planning requirements under 23 CFR 450. The MPO conducted popup event meetings, online surveys with comments and reviews, and online engagement, and agency coordination to ensure the plan reflects the needs and aspirations of the Cheyenne community.

Adoption of this resolution will certify *Connect 2050* as the official long-range transportation plan for the Cheyenne MPO area and as the transportation element of *PlanCheyenne*. Upon approval, the MPO will transmit the adopted plan and resolution to the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) for final acceptance.

We appreciate your continued support and partnership in advancing a safe, efficient, and connected transportation system for the Cheyenne region.











### **Roadway Capital Project Prioritization**



ENTITLED: "A RESOLUTION ADOPTING *CONNECT 2050*: UPDATE TO THE METROPOLITAN TRANSPORTATION PLAN AND FUTURE LAND USE PLAN OF *PLANCHEYENNE* FOR LARAMIE COUNTY AND THE CHEYENNE URBAN AREA."

#### **RECITALS**

WHEREAS, Wyo. Stat. Ann. § 9-8-301 mandates that all local governments shall develop a local land use plan; and

**WHEREAS,** Wyo. Stat. Ann. § 18-5-202(b) provides for the creation of a Planning Commission and states in pertinent part:

"b) The planning and zoning commission may prepare and amend a comprehensive plan including zoning for promoting the public health, safety, morals and general welfare of the unincorporated areas of the county, and certify the plan to the board of county commissioners"; and

**WHEREAS,** Wyo. Stat. Ann. § 18-5-202 allows each board of county commissioners to adopt and amend a comprehensive plan to promote the public health, safety, and general welfare of the unincorporated areas of the county; and

WHEREAS, 23 U.S.C. § 134(i) requires the Metropolitan Planning Organization to prepare and update a transportation plan every five years; and

WHEREAS, 23 CFR § 450.324 requires each Metropolitan Planning Organization (MPO) to develop and maintain a Metropolitan Transportation Plan (MTP) with a planning horizon of at least twenty (20) years, including both long-range and short-range strategies that lead to the development of an integrated multimodal transportation system to facilitate the safe and efficient movement of people and goods; and

**WHEREAS,** Connect 2050: Transportation Update to PlanCheyenne amends Connect 2045: Transportation Update to PlanCheyenne of PlanCheyenne which was adopted by the Laramie County Board of Commissioners by Resolution #201201-8 in December 2020; and

**WHEREAS**, Metropolitan Transportation Plans have a 5-year life and *Connect 2045: Transportation Update to PlanCheyenne* expired in December of 2025 therefore, the Cheyenne MPO prepared a *Connect 2050: Transportation Update to PlanCheyenne* which was adopted in December 2025; and

**WHEREAS**, the Cheyenne Metropolitan Planning Organization (MPO) retained Kimley-Horn and Associates November 12, 2024 to develop the *Connect 2050: Transportation Update to PlanCheyenne*, and

WHEREAS, Connect 2050: Transportation Update to PlanCheyenne was developed under the processes required by state law for the adoption and amendment of master plan (comprehensive plan); and

**WHEREAS,** Connect 2050: Transportation Update to PlanCheyenne included a robust public involvement process which included "pop-up" events, Superday Event, interactive maps, mass emails, and on-line surveys for comments and reviews, etc.; and

WHEREAS, Connect 2050: Transportation Update to PlanCheyenne was prepared with a Connect 2050 Steering Committee, and active involvement of the MPO Online Citizens Advisory Committee and the MPO Technical Committee who has recommended adoption to the MPO Policy Committee; and

**WHEREAS**, a public comment period was advertised via plancheyenne.org and newspaper legal ads announcing the Public Hearing which was conducted by the Laramie County Planning Commission on November 18, 2025, and included the various means for citizens to review the proposed *Connect 2050* and to provide comments.

# NOW, THEREFORE, BE IT RESOLVED BY THE LARAMIE COUNTY BOARD OF COMMISSIONERS, LARAMIE COUNTY, WYOMING:

**THAT,** the Laramie County Board of Commissioners hereby adopts the "Connect 2050: Transportation Update to PlanCheyenne" dated December 2025.

**THAT**, the "Connect 2050: Transportation Update to PlanCheyenne" amends and replaces the Connect 2045: Transportation Update to PlanCheyenne of PlanCheyenne.

**THAT,** this resolution shall become effective after its passage and approval.

**FURTHERMORE, BE IT RESOLVED,** that "Connect 2050: Transportation Update to PlanCheyenne" will be in effect for five-years from its adoption by the MPO Policy Committee and will be used as a guide for the prioritization of all transportation modes in Laramie County and the Cheyenne Urban Area.
