Molly Bennett, Public Works, and Scott Larson, appointed viewer, reported to the board that they recommended denying the petition because a parcel would be landlocked.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Mike Urban, resident, said he doubted the feasibility of the proposed road because telephone poles would have to be relocated and property would have to be taken from landowners. Cotton Jones, agent for the applicant, said he did not see the area south and east of the proposed vacation as a valid access point because the road will not be able to meet county or city road requirements. He stated the vacation will benefit those immediately adjacent to and within a subdivision development where multi-family housing is being built. Hearing no further PUBLIC COMMENT, Chairman Lovett closed the hearing.

Commissioner Holmes asked County Attorney Mark Voss about the legality of abandoning a public right of way and disposition when there are two landowners. Voss referenced Title 34, noting that with a road vacation, the property underlying the road goes to adjacent property owners. Voss said the caveat is in the event of a reserve of right to the road where possible control could be noted on the deed or a history of ownership could determine ownership.

Commissioner Malm questioned Larson about a 1995 vacation through a plat action. Larson said he could not find McAllister Ln's partial vacation. Jones pointed out that the exhibit has a book and page showing the vacation and the date.

A motion was made by Vice Chairman Malm, seconded by Commissioner Thompson, to accept the viewer's report and deny the vacation of the alley.

Commissioner Malm said he could understand the petitioner's point of view based on the maps. He said it was unfortunate that a former governing body had vacated two other portions, and if that action had not been done, today's decision would have been much easier. Commissioner Malm said he would hate to landlock a parcel. He acknowledged that even though a single owner currently owns both parcels, landownership can change.

Chairman Lovett clarified that a yes vote on the motion is to deny the vacation.

Justin Arnold, Planning, said Steil Surveying Services, LLC, on behalf of Triple Dot Capital Investments, LLC, submitted an administrative plat application for Archer Estates, 11th Filing. He said the Board of County Commissioners on Dec 3, 2024, postponed the hearing until the entire board could be present.

Arnold said based on evidence provided, staff recommends approval of the administrative plat with the adoption of findings of fact a and b with no conditions.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Richard Wright and Rod Guthrie, residents, expressed concern about water. Hearing no further PUBLIC COMMENT, Chairman Lovett closed the hearing.

A motion was made by Vice Chairman Malm, seconded by Commissioner Thompson, to approve the administrative plat for Archer Estates, 11th Filing, located in a portion of the NE1/4 of the SE1/4 of Sect 16, T14N, R65W, of the 6th PM, Laramie County, WY with no conditions and adopt the findings of fact a and b of the staff report.

Commissioner Holmes said he opposes splitting larger tracts into 5-acre tracts and considers it poor planning.

Commissioner Malm said he understands and appreciates concerns about water. He said the county needs to follow science, and the county has relied on the AMEC memo for an extended period of time. Commissioner Malm said the governing body owes residents a clear set of rules and must abide by them.
