Consideration of the "Acceptance of Petition for Establishment, Alteration and/or Vacation of County Highway pursuant to W.S. §24-3-101 et seq, of public roads previously dedicated by plat or otherwise and Appointment of Viewer."

WHEREAS, petitioner's in the attached Laramie County road petition have requested the vacation of a portion of County Road 202 from the NE corner of Section 7, T 12 N, R 61 W, to a point approximately 2,400 feet west along the North Boundary of Section 7 (See Attachment A); and

WHEREAS, the Laramie County Board of Commissioners, having reviewed said petition and had seen and examined by the office of the Laramie County Clerk hereby determines that the petition meets the requirements pursuant to W.S. §24-3-101; and

WHEREAS, the Board having considered the Petition herein, pursuant to W.S. § 24-3-103, may appoint a suitable and disinterested person, who may be a member of the board of county commissioners, to examine into the expediency of the proposed road, alteration or vacation thereof, and to report to the Board their findings as soon as practical;

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS, LARAMIE COUNTY, WYOMING, the Board hereby appoints, the Laramie County Director of Public Works or his designee as you are in this matter pursuant to W.S. § 24-3-103 and directs set viewer to report to the Board at a public meeting as soon as practically possible upon the expediency of the alteration of the road proposed by the petition attached hereto.

The Burnett family respectfully submits the attached petition to vacate a portion of right-of-way associated with Laramie County Road 202. The portion to be vacated begins at the northeast corner of Section 7, Township 12N, Range 61W to a point approximately 2,400 feet west along the north boundary of Section 7.

We do not believe vacating the proposed portion of right-of-way will adversely affect accessibility to nearby landowners or the general public. If approved, access is still available via County Road 156 if needed in the future. The existing right-of-way is not currently part of the Laramie County Public Works maintenance program and would not require any physical alteration to vacate.

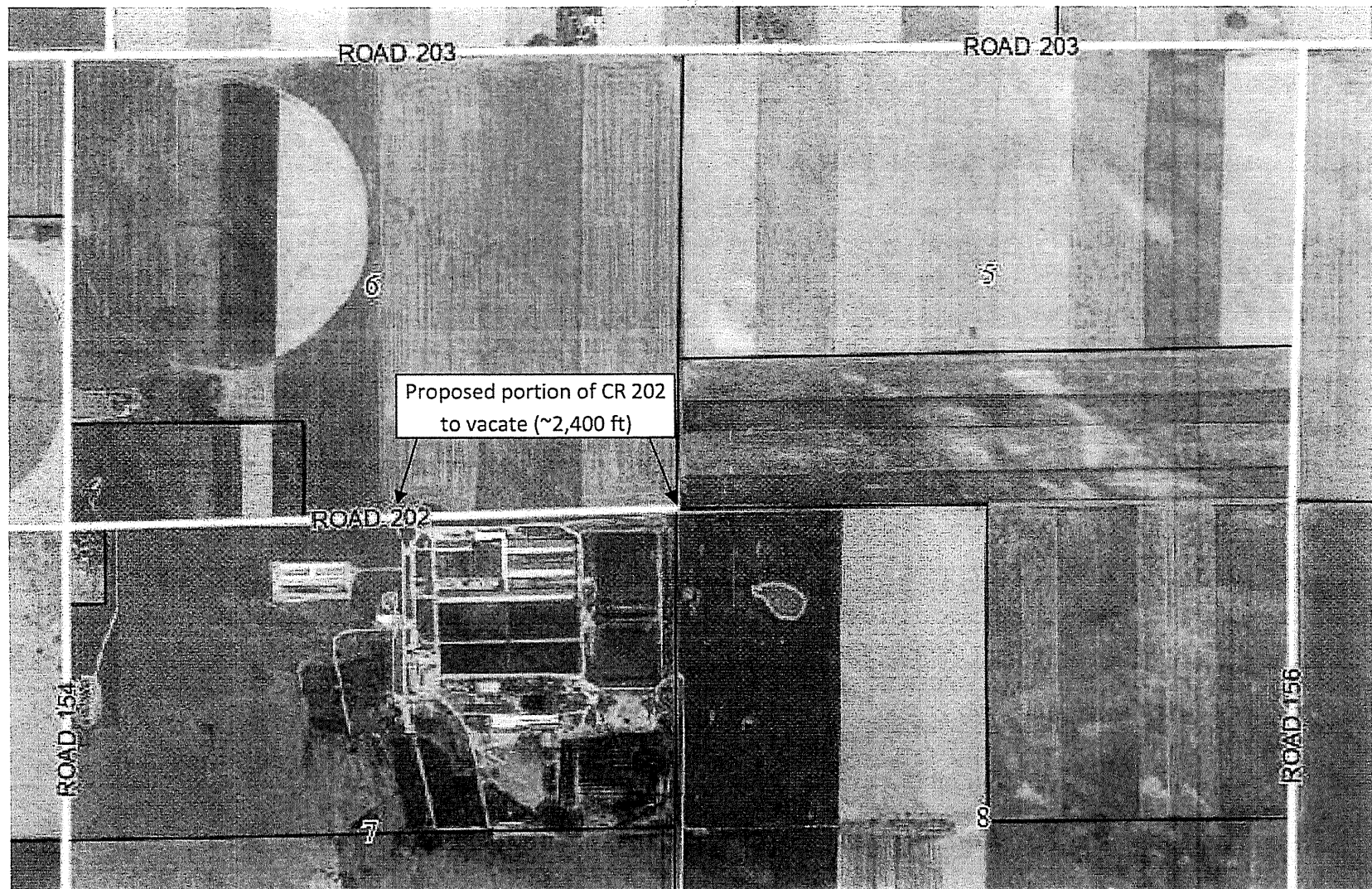

County Road 202 physically ends at the driveway of Burnett dairy, but an 80' dedicated County right-of-way exists between Section 6 and Section 7, Township 12N, Range 61W.

This petition requests a portion of the right-of way for County Road 202 be vacated as follows:

From the northeast corner of Section 7, Township 12N, Range 61W to a point approximately 2,400 feet west along the north boundary of Section 7.

Distance estimated according to Laramie County Assessor's MapServer; distance has not been surveyed.
