Laramie County Proposed Budget FY2019

FY 2019 Budget Presentation

County Clerk Debra Lee introduced the proposed FY2019 budget and noted this is the first time Laramie County has approved its budget before the start of the July 1 fiscal year. She said the change is significant because it will assist department managers, agencies, and grants. Clerk Lee stated a plan developed by the finance department to self-fund the courthouse remodel and jail expansion through use of county reserves will save the county an estimated \$2.5 million in interest and fee charges. She thanked the Board for their consideration and acceptance of the self-funding proposal and for their careful and timely review of the budget.

Stanley Walker, Finance, presented the proposed FY2019 budget. He highlighted five fund changes since the budget was published. Changes were in the areas of General Fund, Jail O&M, SPOT2017, County Improvements Fund, and SLIB grants. The changes brought the overall budget total to \$138,244,441.

Chairman Holmes opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Holmes closed the hearing. Commissioner Ash thanked the elected officials for meeting with the board and answering their questions and acknowledged the departments and everyone for putting together a good budget.
