Rae and Holly,

The Juvenile Services Joint Powers Board has received an application for the position previously held by Rick Robinson. Rick was up for renewal and had opted to retire fully. Rick recommended Renee Hansen and she has agreed to serve. The board had no objections to her joining. She's a prominent expert in our community with a lot of experience with the restorative and therapeutic providers in our area.

Rick's term ended in June of 2022, so Renee's appointment would be from the term September 2022 (the effective date of the resolution) to June 30, 2025 - what would have been Rick's three year term and the normal cycle for this seat.

Please let me know if Mayor Collins or either of your governing bodies have any questions or interest in this, or when this moves forward. I'd be happy to ask Renee to attend a meeting or to attend myself to represent the board and answer any questions. The board has been through a lot of change as it lost it's DFS funding and now regained it along with a lot of contact from DFS and various working groups set up to meet legislative mandates, so there will be more substantive work going on around juvenile justice system policies and priorities. I'm sure the board would welcome any opportunity to visit with the city and county electeds about this. Commissioner Malm has done a great job of keeping the board and county commissioners in close contact.
