Marissa Pomerleau, Planning, said Steil Surveying Services, LLC, on behalf of Wes Moody of 489 Barlow Canyon Rd., Lovell, WY, submitted a Zone Change application for Tract 5, Mountain View Homes, located at 1310 Southwest Dr. The purpose of the application is to change the zone district from LR to PUD.

Ms. Pomerleau said based on the evidence provided, staff recommends approval of the zone change with the adoption of findings of fact a and b.

Chairman Malm opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Malm closed the hearing.

Marissa Pomerleau, Planning, said a public hearing on the application was held on Jan. 14, 2021 by the Laramie County Planning Commission. Public comment was received regarding a possible runway and airport located within the subdivision, traffic, and access roads. The Planning Commission voted 5 - 0 to recommend approval of the application to the Board with the following conditions: 1) A complete Traffic Study for the subdivision shall be submitted, reviewed and approved prior to the Feb. 2, 2021 Board of County Commissioners Public Hearing. 2) Evidence of submittal of the Chapter 23 study to DEQ shall be provided with proof of DEQ approval prior to plat recordation. 3) All agency comments regarding clerical corrections to the plat shall be addressed prior to plat recordation. Ms. Pomerleau said conditions 1 and 2 have not yet been met; the Planning Office requests a postponement of the application to the Feb. 16, 2021 Board of County Commissioners meeting.

Cotton Jones, Jones Land Surveying Co., Inc., and agent for the applicant, requested the agenda item move forward and not be postponed. He said conditions 1 and 3 have been satisfied. Mr. Jones said he has contacted a geologist for the Chapter 23 study and requested approval of the agenda item with the condition that the Chapter 23 study be completed prior to Board of County Commissioners' signing the plat.

Brad Emmons, Planning, said the traffic study has been received and is under review by the County Engineer. He noted the County requires proof that the Chapter 23 study request has been submitted.

Chairman Malm opened the hearing for PUBLIC COMMENT. Tom Jacobson, #1 Properties and agent for the applicant, stated that in his professional opinion, he recommended approval of the permit and plat and requested the item not be postponed. George Halyak, Patrice Gapen, John Earnshaw, residents, spoke against approval until issues could be addressed. The issues cited were the traffic study, traffic problems, drainage problems, safety issues, and the name of the subdivision.

There was a discussion about the ownership of the runway in the area. Residents currently maintain the runway through private funds. Dave Bumann, Public Works

Director, confirmed the County does not allow airplanes to use or cross public roads and Aviator Court is not a County road. County Attorney Mark Voss noted the County and adjacent landowners granted an easement dedicated to the public for the runway. Hearing no further PUBLIC COMMENT, Chairman Malm closed the hearing.

A motion was made by Vice Chairman Holmes, seconded by Commissioner Heath, to postpone the application for the Subdivision Permit and Plat for Meadowlark Airpark to the February 16, 2021 Board of County Commissioners meeting. The motion carried by the following vote:
