Justin Arnold, Planning, said AVI, PC, on behalf of Lance E Gleich and Mindy Grunewald, submitted an application for a zone change for Tracts 1, 2, 3, and 5 Gleich Tracts. He said the application was submitted to change the zoning district from AR - Agricultural Residential to MU - Mixed Use to accommodate the expansion of the water well business and allow the existing residence to remain. Arnold said a concurrent application was also submitted with a site plan for a shop, office, and employee and equipment parking. Arnold said the site plan will address comments from Public Works regarding deed restrictions and easement notes noted on the Gleich Tracts plat, and the site plan will be approved administratively and included in the report for information.

Arnold said based on evidence provided, staff recommends approval of the zone change with the adoption of findings of fact a and b with no conditions.

Chairman Malm opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Malm closed the hearing.

A motion was made by Vice Chairman Thompson, seconded by Commissioner Heath, to approve the zone change for Tracts 1, 2, 3, and 5, Gleich Tracts, Laramie County, WY, from AR to MU with no conditions and adopt the findings of fact a and b of the staff report. 19. PUBLIC HEARING regarding a subdivision permit and plat for Recco Ranch, situated in the NW1/4 of Sect 11, T14N, R65W of the 6th PM, Laramie County, WY.

Justin Arnold, Planning, said Steil Surveying Services, LLC, on behalf of Recco, Inc, submitted a subdivision permit and plat application for property in the SW1/4 of the NW1/4 of Sect 11, T14N, R65W. He said the application was submitted to subdivide 83 acres into 14 residential lots of around six acres each.

Shane Hansen, agent for the applicant, said the applicant would like the third condition removed and to build the remainder of the access easement to a 24-ft wide fire apparatus because it is a family exemption. Commissioner Thompson asked if the access easement could be dedicated as a public road. County Attorney Mark Voss said it would need to go through Title 24, the road petition process.

Arnold said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact a, b, c and d with three conditions: 1) A non-adverse Chapter 23 DEQ recommendation is received by the Planning Dept prior to plat recordation; 2) The developer of the subdivision shall build Railway Ln from Railroad Rd as shown on the plat up to the access of the exempt subdivision to the north to county standards and shall build Recco Ranch Rd and Raymond Trl as shown on the plat to county standards; and 3) The developer shall build the remainder of the private access easement duly recorded at Bk 2421, Pg 1003, to county road standards.

Chairman Malm opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Malm closed the hearing.

A motion was made by Vice Chairman Thompson, seconded by Commissioner Zwonitzer, move to approve the subdivision permit and plat for Recco Ranch with the three conditions outlined in the staff report and adopt findings of fact a, b, c and d of the staff report.

Commissioner Thompson asked about the agent's request not to build the access easement to county standards. He added the entire portion needs to be built to county standards because, at some point, the northern lots will sell.

Chairman Malm asked if the applicant was aware of a proposed change in county road standards that would reduce right-of-way width by approximately 6 ft. He asked if the proposed change, under consideration by the board, was more appealing as a condition to the applicant. Taft Love, applicant, said it would be a great compromise,

saving about six feet of width on the road. Molly Bennett, Public Works, agreed it would be manageable. Voss did not see an issue with the compromise.

A motion was made by Vice Chairman Thompson, seconded by Commissioner Zwonitzer, to amend conditions #2 and #3 to the proposed local county road standard for rural subdivision (buildout volume less than 350 ADT). The motion carried by the following vote:

Justin Arnold, Planning, said Steil Surveying Services, LLC, submitted applications for an administrative plat and zone change for a parcel located at the northwest corner of Avenue D and Persons Rd. He said the applications are to separate the residence from the remainder of the existing towing business, requiring changing the residential zoning from LI - Light Industrial to MU - Mixed Use. Arnold said the business will remain as LI - Light Industrial.

Arnold said based on evidence provided, staff recommends approval of the zone change with the adoption of findings of fact a and b.

Chairman Malm opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Malm closed the hearing.

A motion was made by Commissioner Heath, seconded by Vice Chairman Thompson, to approve the zone change from LI – Light Industrial to MU – Mixed Use for Tract 2, Cheyenne Irrigated Gardens, 3rd Filing, Laramie County, WY, with no conditions and adopt the findings of fact a and b of the staff report.
