HIGHWAY SAFETY PROGRAM FEDERAL FISCAL YEAR (FFY) 2026 SUBAWARD AGREEMENT BETWEEN THE WYOMING DEPARTMENT OF TRANSPORTATION, HIGHWAY SAFETY PROGRAM AND LARAMIE COUNTY GOVERNMENT, LARAMIE COUNTY SHERIFF'S OFFICE

- 1. Parties. This is a Subaward Agreement (Agreement) of federal financial assistance from the Wyoming Department of Transportation, Highway Safety Program (WYDOT), whose address is: 5300 Bishop Boulevard, Cheyenne, Wyoming 82009-3310, to Laramie County Government, Laramie County Sheriff's Office (Subrecipient), whose address is: 1910 Pioneer Avenue, Cheyenne, Wyoming 82001-3605.
- 2. Purpose of Agreement. The purpose of this Agreement is to set forth the terms and conditions by which the Subrecipient shall provide advanced impaired driver training and education to peace officers, judicial officials, and traffic safety advocates. This training will equip participants with the knowledge and skills to address emerging trends in impaired driving, from on-road detection to effective courtroom tactics. By enhancing officers' ability to identify impaired drivers, this initiative will contribute to a substantial reduction in impaired driving fatalities and serious injuries.
- 3. <u>Term of Agreement.</u> This Agreement is effective when all parties have executed it (Effective Date). The term of this Agreement is from October 1, 2025, or the Effective Date, whichever is later, through January 28, 2027. Subrecipient's Budget Period is from October 1, 2025, or the Effective Date, whichever is later, through September 30, 2026. The WYDOT's Performance Period is from October 1, 2025, through January 28, 2027.
- 4. <u>Deliverables.</u> Subrecipient shall administer the Advanced Impaired Driving Detection Training and Coordination, as outlined in Attachment C, Deliverables, which is attached to and incorporated into this Agreement by this reference.
- 5. <u>Performance Measures.</u> Performance Measures are set by the Safety Management System (SMS) Committee based on an analysis of five (5) and ten (10) year running averages along with recent trends. The Deliverables described in Section 4 above and Subrecipient responsibilities described in Section 7 below will assist the WYDOT in reaching the following statewide performance measures:
 - A. C-1 Number of Traffic Fatalities (Fatality Analysis Reporting System [FARS]).
 - **B.** C-4 Number of Unrestrained Passenger Vehicle Occupant Fatalities, All Seat Positions (FARS).
 - C. C-5 Number of Fatalities in Crashes Involving a Driver or Motorcycle Operator with a Blood Alcohol Concentration (BAC) of .08 and above (FARS).

6. Payment.

- A. The WYDOT agrees to reimburse the Subrecipient for the activities described in Section 7 below. Total payment under this Agreement shall not exceed three hundred seventy-nine thousand, thirty-one dollars and eight cents (\$379,031.08). Payment shall be made within forty-five (45) days after submission of invoice pursuant to Wyo. Stat. § 16-6-602. Subrecipient shall submit invoices in sufficient detail to ensure that payments may be made in conformance with this Agreement.
- B. No payment shall be made for work performed before the Effective Date of this Agreement. Should the Subrecipient fail to perform in a manner consistent with the terms and conditions set forth in this Agreement, payment under this Agreement may be withheld until such time as the Subrecipient performs its duties and responsibilities to the satisfaction of the WYDOT.
- C. The Federal Award Identification Number (FAIN) and related federal award information is included in Attachment A, Federal Award Information, which is attached to and incorporated into this Agreement by this reference.
- **D.** Travel. The payment of travel expenses shall be allowed as set forth below. Subrecipient is expected to procure the most cost efficient travel arrangements.
 - (i) Air Travel. The WYDOT agrees to reimburse the Subrecipient's air travel expenses related to the performance of this Agreement. Air travel shall be reimbursed based on actual costs, supported by a copy of the original receipt with the invoice. Subrecipient must select the lowest airfare (fares available in the market at the time of booking, preferably well in advance of trip to attain the lowest possible airfare). Subrecipient shall book economy class fares for all domestic travel. First class bookings are not reimbursable.
 - (ii) <u>Personal Vehicle.</u> Mileage shall be reimbursed at the current State rate per mile based on standard map mileage.
 - (iii) <u>Car Rental.</u> The WYDOT agrees to reimburse the Subrecipient's car rental expenses related to the performance of this Agreement. Car rental expenses shall be reimbursed at actual costs, supported by a copy of the original receipt with the invoice. Subrecipient must select the lowest rental rates for an appropriate vehicle.

E. Lodging.

The WYDOT agrees to reimburse Subrecipient's lodging expenses related to the performance of this Agreement. Lodging expenses shall be reimbursed at actual costs, supported by a copy of the original receipt with the invoice. The Subrecipient shall only invoice the WYDOT for the basic room rate, taxes, and lodging fees. The

WYDOT is not responsible for incidental or miscellaneous expenses charged to the room. Incidental and miscellaneous expenses for which the WYDOT shall not be responsible include charges such as alcohol, internet, telephone charges, mini-bar, and movies.

F. Meals.

The WYDOT agrees to reimburse Subrecipient's meal expenses related to the performance of this Agreement. The Subrecipient shall be reimbursed for meals at the rate of the federal standard meal allowance per day. This reimbursement amount includes all meal, beverage, and refreshment expenses incurred during the day. Requests for reimbursement shall state the amount allowable for meals and list the actual number of travel days on the invoice.

7. Responsibilities of Subrecipient. The Subrecipient agrees to:

- A. Submit an out-of-state travel request a minimum of forty-five (45) days prior to the event. Approval must be received before incurring any costs.
- B. Submit a trip report upon completion of approved out-of-state travel. The trip report shall include the conference agenda, a list of conference sessions attended, and a description of knowledge gained from each session.
- C. Complete the identified Deliverables as outlined in Section 4 by September 30, 2026.
- **D.** The Subrecipient is authorized to purchase equipment as follows:
 - (i) DRE Kit Supplies –
 Cost not to exceed six thousand dollars (\$6,000.00).
 - (ii) Non-Major Equipment –

 Ten (10) Lifeloc PBT (Portable Breath Test) and calibration station not to exceed nine thousand dollars (\$9,000.00), including accessories.

 Non-Major Equipment Record Form is required for the WYDOT grant monitoring purposes.
 - (iii) All repairs and/or replacements required as a result of loss, damage, or malfunctions shall be at Subrecipient's expense.
- E. The Subrecipient shall provide a Reimbursement Activity Report which describes the activities that have been performed during the reporting period toward the overall objectives of the project. The report must include all time reporting events participated in, earned and paid media produced, meeting agendas (to include a list of all attendees), meeting minutes, training report for any attended training, and any

other supplemental documentation that supports grant related expenditures. The Reimbursement Activity Report must be received by the WYDOT on or before the 15th of the following month, unless a written extension is approved by the WYDOT.

- F. Reimbursement requests shall be submitted by the 15th of every month. Reimbursement requests for expenses more than three (3) months after the expenses were incurred may not be processed for payment. The Subrecipient shall submit all final requests for reimbursement to the WYDOT no later than October 30, 2026, unless an extension has been approved in writing by the WYDOT.
- G. Any cost modification of the budget must be approved by the WYDOT.
- H. Subrecipient shall have documentation and an evaluation for all purchases.
- I. Subrecipient shall notify the WYDOT immediately if, for any reason, they are unable to spend the budgeted amount to discuss alternate plans.
- J. The Subrecipient shall provide an Annual Report, which is a comprehensive summarized final reporting of all project activities occurring during the project period, by October 30, 2026. The Annual Report must include project successes and/or challenges, appropriate strategies used and results, and how to improve the project for the next fiscal year. If a report is not provided, final payment will be delayed until documentation is received by the WYDOT.
- K. Notify the WYDOT immediately if for any reason Subrecipient is unable to fulfill stated activities to discuss alternate plans.
- **8.** Responsibilities of the WYDOT. The WYDOT agrees to:
 - A. Pay Subrecipient in accordance with Section 6 above.
- 9. <u>Seat Belt Policy.</u> Subrecipient shall adopt and enforce on-the-job seat belt use policies and programs for its employees when operating company-owned, rented, or personally-owned vehicles. For information and resources on traffic safety programs and policies for employers, please contact the Network of Employers for Traffic Safety (NETS), a public-private partnership dedicated to improving the traffic safety practices of employers and employees. Information on seat belt programs, costs of motor vehicle crashes to employers, and other traffic safety initiatives is available for download at www.trafficsafety.org.

10. Special Provisions.

A. Assumption of Risk. Subrecipient shall assume the risk of any loss of state or federal funding, either administrative or program dollars, due to Subrecipient's

- failure to comply with state or federal requirements. The WYDOT shall notify Subrecipient of any state or federal determination of noncompliance.
- B. Environmental Policy Acts. Subrecipient agrees all activities under this Agreement will comply with the Clean Air Act, the Clean Water Act, the National Environmental Policy Act, and other related provisions of federal environmental protection laws, rules or regulations.
- C. Human Trafficking. As required by 22 U.S.C. § 7104(g) and 2 CFR Part 175, this Agreement may be terminated without penalty if a private entity that receives funds under this Agreement:
 - (i) Engages in severe forms of trafficking in persons during the period of time that the award is in effect:
 - (ii) Procures a commercial sex act during the period of time that the award is in effect; or
 - (iii) Uses forced labor in the performance of the award or sub-awards under the
- D. Kickbacks. Subrecipient certifies and warrants that no gratuities, kickbacks, or contingency fees were paid in connection with this Agreement, nor were any fees, commissions, gifts, or other considerations made contingent upon the award of this Agreement. If Subrecipient breaches or violates this warranty, the WYDOT may, at its discretion, terminate this Agreement without liability to the WYDOT, or deduct from the agreed upon price or consideration, or otherwise recover, the full amount of any commission, percentage, brokerage, or contingency fee.
- E. Limitations on Lobbying Activities. By signing this Agreement, Subrecipient certifies and agrees that, in accordance with P.L. 101-121, payments made from a federal grant shall not be utilized by Subrecipient or its subcontractors in connection with lobbying member(s) of Congress, or any federal agency in connection with the award of a federal grant, contract, cooperative agreement, or loan.
- F. Monitoring Activities. The WYDOT shall have the right to monitor all activities related to this Agreement that are performed by Subrecipient or its subcontractors. This shall include, but not be limited to, the right to make site inspections at any time and with reasonable notice; to bring experts and consultants on site to examine or evaluate completed work or work in progress; to examine the books, ledgers, documents, papers, and records pertinent to this Agreement; and to observe personnel in every phase of performance of Agreement related work.
- G. Nondiscrimination. Subrecipient shall comply with the Civil Rights Act of 1964, the Wyoming Fair Employment Practices Act (Wyo. Stat. § 27-9-105, et seq.), the

Americans with Disabilities Act (ADA), 42 U.S.C. § 12101, et seq., and the Age Discrimination Act of 1975 and any properly promulgated rules and regulations thereto and shall not discriminate against any individual on the grounds of age, sex, color, race, religion, national origin, or disability in connection with the performance under this Agreement.

- H. No Finder's Fees. No finder's fee, employment agency fee, or other such fee related to the procurement of this Agreement, shall be paid by either party.
- I. Publicity. Any publicity given to the projects, programs, or services provided herein, including, but not limited to, notices, information, pamphlets, press releases, research, reports, signs, and similar public notices in whatever form, prepared by or for Subrecipient and related to the services and work to be performed under this Agreement, shall identify the WYDOT as the sponsoring agency and shall not be released without prior written approval of the WYDOT.
- J. Suspension and Debarment. By signing this Agreement, Subrecipient certifies that neither it nor its principals/agents are presently debarred, suspended, proposed for debarment, declared ineligible, or voluntarily excluded from participation in this transaction or from receiving federal financial or nonfinancial assistance, nor are any of the participants involved in the execution of this Agreement suspended, debarred, or voluntarily excluded by any federal department or agency in accordance with Executive Order 12549 (Debarment and Suspension), or 2 CFR Part 180, or are on the debarred, or otherwise ineligible, vendors lists maintained by the federal government. Further, Subrecipient agrees to notify the WYDOT by certified mail should it or any of its principals/agents become ineligible for payment, debarred, suspended, or voluntarily excluded from receiving federal funds during the term of this Agreement.
- K. Administration of Federal Funds. Subrecipient agrees its use of the funds awarded herein is subject to the Uniform Administrative Requirements of 2 CFR Part 200, et seq.; requirements in Attachment B, Federal Certifications and Assurances, which is attached to and incorporated into this Agreement by this reference; and any additional requirements set forth by the federal funding agency; all applicable regulations published in the Code of Federal Regulations; and other program guidance as provided to it by the WYDOT.
- L. Copyright License and Patent Rights. Subrecipient acknowledges that federal grantor, the State of Wyoming, and the WYDOT reserve a royalty-free, nonexclusive, unlimited, and irrevocable license to reproduce, publish, or otherwise use, and to authorize others to use, for federal and state government purposes: (1) the copyright in any work developed under this Agreement; and (2) any rights of copyright to which Subrecipient purchases ownership using funds awarded under this Agreement. Subrecipient must consult with the WYDOT regarding any patent rights that arise from, or are purchased with, funds awarded under this Agreement.

- M. Federal Audit Requirements. Subrecipient agrees that if it expends an aggregate amount in excess of the amount set forth in 2 CFR Part 200, Subpart F in federal awards during its fiscal year, it must undergo an organization-wide financial and compliance single audit. Subrecipient agrees to comply with the audit requirements of the U.S. General Accounting Office Government Auditing Standards and Audit Requirements of 2 CFR Part 200, Subpart F. If findings are made which cover any part of this Agreement, Subrecipient shall provide one (1) copy of the audit report to the WYDOT and require the release of the audit report by its auditor be held until adjusting entries are disclosed and made to the WYDOT's records.
- N. Non-Supplanting Certification. Subrecipient hereby affirms that federal grant funds shall be used to supplement existing funds, and shall not replace (supplant) funds that have been appropriated for the same purpose. Subrecipient should be able to document that any reduction in non-federal resources occurred for reasons other than the receipt or expected receipt of federal funds under this Agreement.
- O. Program Income. Subrecipient shall not deposit grant funds in an interest bearing account without prior approval of the WYDOT. Any income attributable to the grant funds distributed under this Agreement must be used to increase the scope of the program or returned to the WYDOT.
- P. Applicability of Appendix II to 2 CFR Part 200. This Agreement has been funded, in whole or in part, with an Award of Federal funds and is bound by the federal contract provisions required by the Uniform Guidance Appendix II of 2 CFR Part 200 (the Federal Contract Provisions), incorporated herein by this reference. In the event of a conflict between the Special Provisions section of this Agreement, or any attachments or exhibits incorporated herein, and the Federal Contract Provisions, the Federal Contract Provisions shall control. Failure to comply with the Federal Contract Provisions shall constitute an event of default under this Agreement. If such a default remains uncured five (5) calendar days following the termination of a thirty (30) day prior written notice period, the WYDOT may terminate this Agreement. This remedy will be in addition to any other remedy available to the State of Wyoming and the WYDOT under this Agreement, at law, or in equity.

11. General Provisions.

- A. Amendments. Any changes, modifications, revisions, or amendments to this Agreement which are mutually agreed upon by the parties to this Agreement shall be incorporated by written instrument, executed by all parties to this Agreement.
- B. Applicable Law, Rules of Construction, and Venue. The construction, interpretation, and enforcement of this Agreement shall be governed by the laws of the State of Wyoming, without regard to conflicts of law principles. The terms "hereof," "hereunder," "herein," and words of similar import, are intended to refer to this Agreement as a whole and not to any particular provision or part. The Courts

- of the State of Wyoming shall have jurisdiction over this Agreement and the parties. The venue shall be the First Judicial District, Laramie County, Wyoming.
- C. Assignment Prohibited and Agreement Shall Not be Used as Collateral. Neither party shall assign or otherwise transfer any of the rights or delegate any of the duties set out in this Agreement without the prior written consent of the other party. Subrecipient shall not use this Agreement, or any portion thereof, for collateral for any financial obligation without the prior written permission of the WYDOT.
- D. Audit and Access to Records. The WYDOT and its representatives shall have access to any books, documents, papers, electronic data, and records of Subrecipient which are pertinent to this Agreement. Subrecipient shall immediately, upon receiving written instruction from the WYDOT, provide to any independent auditor or accountant all books, documents, papers, electronic data, and records of Subrecipient which are pertinent to this Agreement. Subrecipient shall cooperate fully with any such independent auditor or accountant during the entire course of any audit authorized by the WYDOT.
- E. Availability of Funds. Each payment obligation of the WYDOT is conditioned upon the availability of government funds which are appropriated or allocated for the payment of this obligation and which may be limited for any reason including, but not limited to, congressional, legislative, gubernatorial, or administrative action. If funds are not allocated and available for continued performance of the Agreement, the Agreement may be terminated by the WYDOT at the end of the period for which the funds are available. The WYDOT shall notify Subrecipient at the earliest possible time of the services which will or may be affected by a shortage of funds. No penalty shall accrue to the WYDOT in the event this provision is exercised, and the WYDOT shall not be obligated or liable for any future payments due or for any damages as a result of termination under this section.
- F. Award of Related Agreements. The WYDOT may award supplemental or successor agreements for work related to this Agreement or may award agreements to other subrecipients for work related to this Agreement. Subrecipient shall cooperate fully with other subrecipients and the WYDOT in all such cases.
- G. Compliance with Laws. Subrecipient shall keep informed of and comply with all applicable federal, state, and local laws, and regulations, and all federal grant requirements and executive orders in the performance of this Agreement.
- H. Confidentiality of Information. Except when disclosure is required by the Wyoming Public Records Act or court order, all documents, data compilations, reports, computer programs, photographs, data, and other work provided to or produced by Subrecipient in the performance of this Agreement shall be kept

confidential by Subrecipient unless written permission is granted by the WYDOT for its release. If and when Subrecipient receives a request for information subject to this Agreement, Subrecipient shall notify the WYDOT within ten (10) days of such request and shall not release such information to a third party unless directed to do so by the WYDOT.

- I. Entirety of Agreement. This Agreement, consisting of thirteen (13) pages; Attachment A, Federal Award Information, consisting of one (1) page; Attachment B, Federal Certifications and Assurances, consisting of seven (7) pages, Attachment C, Deliverables, consisting of two (2) pages; and the Federal Contract Provisions, represent the entire and integrated Agreement between the parties and supersede all prior negotiations, representations, and agreements, whether written or oral. In the event of a conflict or inconsistency between the language of this Agreement and the language of any attachment or document incorporated by reference, the language of this Agreement shall control.
- J. Ethics. Subrecipient shall keep informed of and comply with the Wyoming Ethics and Disclosure Act (Wyo. Stat. § 9-13-101, et seq.) and any and all ethical standards governing Subrecipient's profession.
- K. Extensions. Nothing in this Agreement shall be interpreted or deemed to create an expectation that this Agreement will be extended beyond the term described herein. Any extension of this Agreement shall be initiated by the WYDOT and shall be accomplished through a written amendment between the parties entered into before the expiration of the original Agreement or any valid amendment thereto, and shall be effective only after it is reduced to writing and executed by all parties to the Agreement.
- L. Force Majeure. Neither party shall be liable for failure to perform under this Agreement if such failure to perform arises out of causes beyond the control and without the fault or negligence of the nonperforming party. Such causes may include, but are not limited to, acts of God or the public enemy, fires, floods, epidemics, quarantine restrictions, freight embargoes, and unusually severe weather. This provision shall become effective only if the party failing to perform immediately notifies the other party of the extent and nature of the problem, limits delay in performance to that required by the event, and takes all reasonable steps to minimize delays.
- M. Indemnification. Each party to this Agreement shall assume the risk of any liability arising from its own conduct. Neither party agrees to insure, defend, or indemnify the other.
- N. Independent Contractor. Subrecipient shall function as an independent contractor for the purposes of this Agreement and shall not be considered an employee of the State of Wyoming for any purpose. Consistent with the express terms of this

Agreement, Subrecipient shall be free from control or direction over the details of the performance of services under this Agreement. Subrecipient shall assume sole responsibility for any debts or liabilities that may be incurred by Subrecipient in fulfilling the terms of this Agreement and shall be solely responsible for the payment of all federal, state, and local taxes which may accrue because of this Agreement. Nothing in this Agreement shall be interpreted as authorizing Subrecipient or its agents or employees to act as an agent or representative for or on behalf of the State of Wyoming or the WYDOT or to incur any obligation of any kind on behalf of the State of Wyoming or the WYDOT. Subrecipient agrees that no health or hospitalization benefits, workers' compensation, unemployment insurance, or similar benefits available to State of Wyoming employees will inure to the benefit of Subrecipient or Subrecipient's agents or employees as a result of this Agreement.

- O. Notices. All notices arising out of, or from, the provisions of this Agreement shall be in writing either by regular mail or delivery in person at the addresses provided under this Agreement.
- P. Ownership and Return of Documents and Information. The WYDOT is the official custodian and owns all documents, data compilations, reports, computer programs, photographs, data, and other work provided to or produced by Subrecipient in the performance of this Agreement. Upon termination of services, for any reason, Subrecipient agrees to return all such original and derivative information and documents to the WYDOT in a useable format. In the case of electronic transmission, such transmission shall be secured. The return of information by any other means shall be by a parcel service that utilizes tracking numbers.
- Q. Patent or Copyright Protection. Subrecipient recognizes that certain proprietary matters or techniques may be subject to patent, trademark, copyright, license, or other similar restrictions, and warrants that no work performed by Subrecipient or its subcontractors will violate any such restriction. Subrecipient shall defend and indemnify the WYDOT for any infringement or alleged infringement of such patent, trademark, copyright, license, or other restrictions.
- R. Prior Approval. This Agreement shall not be binding upon either party, no services shall be performed, and the Wyoming State Auditor shall not draw warrants for payment, until this Agreement has been fully executed, approved as to form by the Office of the Attorney General, filed with and approved by A&I Procurement, and approved by the Governor of the State of Wyoming, or his designee, if required by Wyo. Stat. § 9-2-3204 (b)(iv).
- S. Severability. Should any portion of this Agreement be judicially determined to be illegal or unenforceable, the remainder of the Agreement shall continue in full force and effect, and the parties may renegotiate the terms affected by the severance.

- T. Sovereign Immunity and Limitations. Pursuant to Wyo. Stat. § 1-39-104(a), the State of Wyoming and the WYDOT expressly reserve sovereign immunity by entering into this Agreement and Subrecipient expressly reserves governmental immunity. Each of them specifically retains all immunities and defenses available to them as sovereigns or governmental entities pursuant to Wyo. Stat. § 1-39-101. et seq., and all other applicable law. The parties acknowledge that the State of Wyoming has sovereign immunity and only the Wyoming Legislature has the power to waive sovereign immunity. The parties further acknowledge that there are constitutional and statutory limitations on the authority of the State of Wyoming and its agencies or instrumentalities to agree to certain terms and conditions supplied by Subrecipient, including, but not limited to, the following: liability for damages: choice of law; conflicts of law; venue and forum-selection clauses; defense or control of litigation or settlement; liability for acts or omissions of third parties; payment of attorneys' fees or costs; additional insured provisions; dispute resolution, including, but not limited to, arbitration; indemnification of another party: and confidentiality. Any such provisions in the Agreement, or in any attachments or documents incorporated by reference, will not be binding on the State of Wyoming, Designations of venue, choice of law, enforcement actions, and similar provisions shall not be construed as a waiver of sovereign immunity. The parties agree that any ambiguity in this Agreement shall not be strictly construed, either against or for either party, except that any ambiguity as to immunity shall be construed in favor of immunity.
- U. Taxes. Subrecipient shall pay all taxes and other such amounts required by federal, state, and local law, including, but not limited to, federal and social security taxes, workers' compensation, unemployment insurance, and sales taxes.
- V. Termination of Agreement. This Agreement may be terminated, without cause, by the WYDOT upon thirty (30) days written notice. This Agreement may be terminated by the WYDOT immediately for cause if Subrecipient fails to perform in accordance with the terms of this Agreement.
- W. Third-Party Beneficiary Rights. The parties do not intend to create in any other individual or entity the status of third-party beneficiary, and this Agreement shall not be construed so as to create such status. The rights, duties, and obligations contained in this Agreement shall operate only between the parties to this Agreement and shall inure solely to the benefit of the parties to this Agreement. The provisions of this Agreement are intended only to assist the parties in determining and performing their obligations under this Agreement.
- X. Time is of the Essence. Time is of the essence in all provisions of this Agreement.

- Y. Titles Not Controlling. Titles of sections and subsections are for reference only and shall not be used to construe the language in this Agreement.
- Z. Waiver. The waiver of any breach of any term or condition in this Agreement shall not be deemed a waiver of any prior or subsequent breach. Failure to object to a breach shall not constitute a waiver.

Such a financial or personal interest would arise when the employee, officer, or agent, any member of his or her immediate family, his or her partner, or an organization which employs or is about to employ any of the parties indicated herein, has a financial or personal interest in or a tangible personal benefit from an entity considered for a sub-award. Based on this policy:
 - (i) Subrecipient shall maintain a written code or standards of conduct that provide for disciplinary actions to be applied for violations of such standards by officers, employees, or agents.
 - (a) The code or standards shall provide that Subrecipient's officers, employees, or agents may neither solicit nor accept gratuities, favors, or anything of monetary value from present or potential subawardees, including contractors or parties to subcontracts.
 - (b) The code or standards shall establish penalties, sanctions or other disciplinary actions for violations, as permitted by State or local law or regulations.
 - (ii) Subrecipient shall maintain responsibility to enforce the requirements of the written code or standards of conduct.
- 9. <u>Disclosure Requirements.</u> The WYDOT nor its Subrecipient, including its officers, employees, or agents, shall not perform or continue to perform under a grant or cooperative agreement, whose objectivity may be impaired because of any related past, present, or currently planned interest, financial or otherwise, in organizations regulated by NHTSA or in organizations whose interests may be substantially affected by NHTSA activities. Based on this policy:
 - A. Subrecipient shall disclose any conflict of interest identified as soon as reasonably possible, making an immediate and full disclosure in writing to NHTSA. The disclosure shall include a description of the action which Subrecipient has taken or proposes to take to avoid or mitigate such conflict.

- **B.** NHTSA will review the disclosure and may require additional relevant information from Subrecipient. If a conflict of interest is found to exist, NHTSA may:

ATTACHMENT C, DELIVERABLES

General services to be provided by the Laramie County Sheriff's Office shall include, but not be limited to, the following:

- 1) Perform duties needed to maintain and expand the Impaired Driving Program within the state of Wyoming.
- 2) Provide reimbursement for required continuing education for the Drug Recognition Expert (DRE) Coordinator that meets certified law enforcement proficiency standards.
- 3) DRE Coordinator may complete additional training and/or enforcement activities to maintain DRE Instructor certification that is in good standing with the International Association of Chiefs of Police (IACP) and remain current on evolving drug trends and traffic safety issues.
- 4) Strive to maintain a minimum of fifty-five (55) Drug Recognition Experts (DREs) across the State of Wyoming.
- 5) Provide in-state/out-of-state travel expenses associated with duties required of the Impaired Driving Program.
- 6) Provide agency overtime salary for sworn personnel (Vendors) teaching Standardized Field Sobriety Testing (SFST) Refresher, SFST Instructor Development Course, Advanced Roadside Impaired Driving Enforcement (ARIDE), DRE School and Field Certifications, DRE Instructor Development Course, Drug Impairment Training for Educational Professionals (DITEP), Employer Drug Impairment Training (EDIT), and additional impaired driving trainings approved by the Highway Safety Office (HSO). All Vendors shall be certified instructors.
- 7) Conduct on-site visits with local law enforcement agency administrators, supervisors, and officers of each county throughout the state of Wyoming on available impaired driving training.
- 8) Purchase supplies and tools necessary for presentations and the administration of impaired driving testing and training of law enforcement personnel. This includes passive alcohol sensors and supplies needed for DRE evaluations.
- 9) Promote the expansion and use of DRE(s) in the investigation(s) of fatal and/or serious bodily injury collisions; to include commercial motor vehicle (CMV) enforcement activities.

- 10) Administer community trainings utilizing DITEP and/or EDIT curriculum (must include Behavioral Highway Safety training).
- 11) Develop and/or update impaired driving curriculum and programs in Wyoming.
- Administer regional DRE Coordinators managing DRE officers in their region to ensure proper evaluations and documentation per IACP standards.
- 13) Plan and administer up to two (2) trainings for Regional DRE Coordinators to include DRE tracking website.
- 14) Ensure DRE evaluation data is entered into the national database by federal due date.
- 15) Plan and administer one (1) DRE basic course and field certifications.
- 16) Plan and administer DRE in-service training as necessary for certification renewals.
- 17) Plan and administer one (1) DRE Instructor Development Course.
- 18) Plan and administer a minimum of five (5) ARIDE courses statewide.
- 19) Plan and provide support for SFST Refresher courses statewide using certified instructors and training materials.
- 20) Provide reimbursement of overtime cost for DRE callouts for state and local law enforcement personnel.
- 21) Provide reimbursement of expenditures related to work managing regional DREs and DRE Instructors, ensuring proper evaluations and documentation per IACP standards.
- 22) Provide reimbursement of expenditures for Impaired Driving Instructors, ensuring compliance with the Laramie County's procurement guidelines in compliance with uniform guidelines.
- 23) Provide an Instructor Fee Schedule to HSO through the HSO Project Site.
- Costs associated with travel and training, both in-state and out-of-state, are for one (1) Impaired Driving Program Coordinator, five (5) Regional Coordinators/ARIDE/DRE Instructors, and one (1) DRE who have been identified as top performers during the current year's DRE Class. With just cause, four (4) additional DRE may be identified. Any out-of-state travel requires prior written approval from the HSO. Those DREs selected to travel out-of-state will be required to complete the trip report as required under Section 7 (B) of the base Contract, entitled Responsibilities of Subrecipient.
