Bryce Hamilton, Planning, said on Dec 5, 2023, staff presented applications for two zone changes, a vacation, administrative plat approval, and approval of use for an RV storage unit for Toybox Storage. Mr. Hamilton pointed out staff had made an error in the proposed language for the zone change motion which was approved by the board at the Dec 5 meeting. He noted the error in the board's previously approved motion could result in Tract 1 of Larimore Subdivision not receiving one of the two intended zone changes. He said staff wanted to ensure the record of proceedings included the correct language approving the required zone change.

Bryce Hamilton, Planning, said Recreational Investment Group, LLP, on behalf of Oh Hail No, LLC, submitted a zone change application for property located at the intersection of Richard Rd and Robert Ave in the Cathcart Planned Unit Development. He said the application asks to rezone the property from PUD to a new PUD designation which would allow the parcel to contain a campground.

Mr. Hamilton said based on evidence provided, staff recommends approval of the zone change with the adoption of findings of fact a and b with no conditions.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Hearing no PUBLIC COMMENT, Chairman Thompson closed the hearing.

12. PUBLIC HEARING regarding a subdivision permit and plat for Open View Ranch, situated at the N1/2 of Sect 7, T14N, R63W, of the 6th PM, Laramie County, WY.

Bryce Hamilton, Planning, said Steil Surveying Services, LLC, on behalf of Whiskey Hill, LLC, submitted a subdivision permit and plat application for property located on the east side of County Rd 142, between County Rds 212 and 213, about one mile south of Hillsdale. He said the submitted application is to subdivide the 397.73-acre property into 22 residential lots of roughly 14.22 acres each. The southeast portion of the property on the S1/2 of Sect 7 would remain unplatted.

Mr. Hamilton said based on evidence provided, staff recommends approval of the subdivision permit and plat with the adoption of findings of fact a and b, and the condition that a non-adverse Chapter 23 recommendation is provided by DEQ prior to recordation.

Chairman Lovett opened the hearing for PUBLIC COMMENT. Melissa Anderson, Laurie Jackson and Wyatt Jackson residents, raised questions and concerns about school capacities, EMT services, postal service, water issues, the board's long-range plan, road maintenance, additional traffic, snow removal, and need for more study of wildlife in the area.

Commissioner Health explained how outside entities, such as school and fire districts, are given the opportunity to comment on the application. If there is no comment, then it is assumed there are no issues. Commissioner Health said EMT services would be through AMR and postal service is not under the board's control. Commissioner Holmes addressed the water issue, stating the AMEC memo recommendation is five acres for the recharge rate of normal household usage. The proposed tracts exceed the recommendation. He noted the state engineer monitors the water table level.

Hearing no further PUBLIC COMMENT, Chairman Thompson closed the hearing. A motion was made by Commissioner Holmes, seconded by Commissioner Heath, to adopt findings of fact a and b of the staff report and to approve the subdivision permit and plat for Open View Ranch with the one condition as outlined in the staff report. The motion carried by the following vote:
